Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of the Wolf, Greenfield & Sacks, P.C. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

Notes to Financial Statements

Note 1 - Description of the Plan

The following description of the Wolf, Greenfield & Sacks, P.C. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution profit sharing plan with a cash deferral arrangement established by Wolf, Greenfield & Sacks, P.C. (“Employer”). In accordance with the trust agreement, the Employer administers the Plan. John Hancock Trust Company LLC (“John Hancock”) is the Plan’s custodian and trustee.

The Plan covers all employees who have completed thirty days of service and have attained age twenty (“Participants”) except “of counsel” attorneys, leased employees, union employees, summer associates and temporary employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Substantially all investments are participant directed.

Participant Contributions

Participants may elect to defer up to 80% of their compensation, as defined by the Plan, subject to dollar limits set by Federal law. The Plan allows participants to make Roth 401(k) deferrals into the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (“Participant Rollovers”).

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan at 6% of compensation in a designated balance fund (until changed by the participant) unless they affirmatively elect not to participate in the Plan.

Employer Contributions

Each year, the Employer, at its sole discretion, determines the amount of matching contributions and/or profit sharing contributions it will contribute to the Plan, subject to certain limitations. Profit sharing contributions are allocated to participants based upon a percentage of their compensation for the contribution period. This percentage varies and is based on the eligible participant’s status as a shareholder, an associate, law clerk, technology specialist, patent agent or other employee of the Employer. Eligibility to participate in profit sharing contributions requires that a participant have one year of service (measured on elapsed time) and be actively employed on the last day of the Plan year.

For the year ended December 31, 2024, the Employer matched fifty percent of a participant’s contributions up to six percent of eligible compensation, as defined in the Plan.

Note 1 - Description of the Plan (Continued)

Participant Accounts

Each participant's account is credited with the Participant's contribution and allocations of the Employer's contributions and Plan earnings, and reduced by direct loan fees, benefit disbursement processing fees or administrative expenses associated with certain investment options. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the Participant's vested account balance.

Vesting

Participants are immediately vested in their deferral contributions plus earnings thereon. Participants vest in Employer contributions based on years of service with the Employer. A participant begins vesting after two years of service and is fully vested after four years of service, upon reaching age sixty-five, or if employment is terminated due to death or disability.

Forfeitures

A participant who leaves the employ of the Employer forfeits any non-vested balance. The Plan uses such forfeitures to first restore contributions of returning Participants, next to make any positive adjustment of contributions and earnings thereon and finally to reduce future Employer contributions. There were \$62,869 and \$140,648 in forfeitures available for future use as of December 31, 2024 and 2023, respectively. During the year ended December 31, 2024, forfeitures of \$166,798 were used to reduce Employer contributions.

Payment of Benefits

Participants are entitled to their total vested account balance upon their death, retirement, termination of employment or upon reaching 59½ years of age. A participant may elect to receive either a lump-sum payment equal to the vested balance of his or her account or installment payments of such amounts, frequency and duration as the participant or beneficiary may elect. Hardship withdrawals are allowed as defined in the Plan. In addition, upon termination, if a participant's vested account is less than \$5,000, the Plan administrator, after notification and without consent, may distribute the benefit to the participant. Individuals who had a deemed severance from employment, during any period that the individual is performing uniformed services, may elect to receive a distribution of his or her account balance as provided under the Plan as if the Participant terminated employment on account of death. A Participant's elective contributions are suspended for six months following the receipt of distribution during a period of deemed severance.

Notes Receivable from Participants

Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their elective deferral account balance. Loan terms range up to five years (or longer for the purchase of a primary residence). A loan is secured by the vested balance in the Participant's account. The Plan allows for only two loans per participant at any one time. Loans bear interest at a fixed or variable rate commensurate with prevailing rates charged for similar loans, as determined by the Plan's trustee. Principal and interest are paid ratably through payroll deductions or through direct payment to John Hancock in the case of terminated participants.

Plan Expenses

Individual participant accounts are charged directly for loan recordkeeping, participant fees for certain investment options, and administrative fees, if applicable. Substantially all operating expenses incurred in the administration of the Plan are paid out of the Plan unless paid directly by the Employer.

Note 2 - Summary of Significant Accounting Policies

Basis of Presentation

The financial statements of the Plan are prepared under the accrual method of accounting in conformity with accounting principles generally accepted in the United States of America.

Investments, Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by John Hancock. See Note 4 for discussions of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Contributions

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the contributions are withheld from compensation.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Benefits Paid

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Subsequent Events

Subsequent to the plan year ended December 31, 2024, the Plan Sponsor approved a change in plan custodians. Effective August, 1 2025, the Plan's assets will be transitioned from John Hancock to Fidelity Management Trust Company. The Plan Sponsor has taken necessary steps to ensure a smooth transition of plan assets and participant accounts. This change is not expected to have a material effect on the Plan's net assets available for benefits or its operations.

The Employer has evaluated subsequent events through August 15, 2025, the date that the financial statements were available to be issued.

Note 3 - Information Certified by the Trustee and Custodian

Plan investments at December 31, 2024 and 2023 are held by John Hancock, the trustee and custodian. John Hancock has certified to the fair value of investments as of December 31, 2024 and 2023, and investment transactions for the year ended December 31, 2024. Investment transactions include interest and dividend income and net appreciation in fair value of investments. Information included in the supplemental schedule and notes receivable from participants has also been derived from information certified by John Hancock.

The Plan offers investment choices to allow participants to create a diversified portfolio of assets based on the Participant's risk tolerance. Participants may invest among a combination of various options sponsored by John Hancock and may manage their own assets in self-directed accounts.

Note 4 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level I) and the lowest priority to unobservable inputs (Level III). The three levels of the fair value hierarchy are described below:

Level I – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level II – Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level II input must be observable for substantially the full term of the asset or liability.

Level III – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Note 4 - Fair Value Measurements (Continued)

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common Stocks, Mutual Funds and Cash Funds (Self-directed assets)

Valued at closing price reported on the active market on which the individual securities are traded.

Pooled Separate Account

Valued at the NAV of units of the separate account. The NAV as provided by the trustee and custodian, is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the separate account, the issuer reserves the right to temporarily delay withdrawal from the account in order to ensure that securities liquidations will be carried out in an orderly business manner.

Note 6 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Market risks include global events such as international conflict which could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

Note 7 - Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts. Any unallocated assets of the Plan shall be allocated to participant accounts in such a manner as the Employer may determine.

Note 8 - Tax Status

The IRS has determined and informed the Plan by a letter dated June 30, 2020, that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9 - Related Parties and Party-in-Interest Transactions

Certain investment accounts are managed by John Hancock. John Hancock is the trustee and custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest. Notes receivable from participants also qualify as party-in-interest transactions. For the Plan year ended December 31, 2024, administrative fees of \$246,858 were paid to John Hancock and other service providers.

During the Plan year ended December 31, 2024, the Plan received revenue credits of \$78,481 from John Hancock and used them to pay Plan expenses. The revenue credits are reported as other income on the Statement of Changes in Net Assets Available for Benefits.
