### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audit of the accompanying financial statements of Northstar Financial Group Employees' 401 (k) Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

## Notes to Financial Statements

At December 31, 2024 and 2023 and For the Year Ended December 31, 2024

### (1) Description of Plan

The following description of the Northstar Financial Group Employees' 401 (k) Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. The Plan Sponsor is Northstar Financial Group, Inc. (the "Company").

**General.** The Plan is a defined contribution plan covering all employees of the Sponsor, employees are immediately eligible upon the first entry date following date of employment, as defined in the Plan. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan's designated custodian and record-keeper is Great-West Life & Annuity Insurance Company and Subsidiaries (DBA Empower Retirement) ("Great-West").

**Contributions.** Each year, participants may contribute up to 100% of pretax annual compensation subject to certain limits, as defined in the Plan. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. The Participants may also contribute amounts representing distributions from other qualified plans or from an individual retirement account (rollover). The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 5 percent of eligible compensation for the first year and their contributions invested in a designated balanced fund until changed by the Participant. Under the Plan the auto-escalation provision increases 1 percent per year after the first year, not to exceed 11 percent.

The Plan allows for Roth elective deferrals. The Roth deferrals are included in a participant's ordinary taxable income and are maintained in a separate account from pre-tax deferrals. Earnings on a participant's Roth account accumulate on a tax free basis. Plan participants may elect all pre-tax, all Roth, or a combination of elective deferrals each pay period. In addition, the Plan accepts direct rollovers from other Roth 401 (k) accounts.

The Sponsor may contribute a matching contribution at the discretion of its Board of Directors.

**Participant Accounts.** Each participant's account is credited with the participant's contribution and Sponsor's matching contributions, as well as allocation of plan earnings. Participants accounts are charged with a flat rate per quarter for administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Upon enrollment, a participant may direct employee and employer contributions to any of the Plan's fund options.

**Vesting.** Participants are immediately vested in their contributions plus actual earnings thereon and in the Sponsor's discretionary contribution portion of their accounts plus actual earnings thereon.

### (1) Description of Plan, Continued

**Notes Receivable from Participants.** Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. The loans are secured by the balance in the participant's account. The loan interest rate, determined quarterly, is set at 1.0 percent above the prime rate, as defined. Principal and interest is paid ratably through payroll deductions.

**Payment of Benefits.** Upon retirement, death, disability, termination of employment, or termination of the Plan, participants or their beneficiaries will receive the total vested balance on their account. If at the time an employee is separated from service and their combined vested account balance is not greater than \$1,000, the entire benefit would be paid in lump sum form within one year of termination. If the vested account balance is greater than \$1,000, but not more than \$5,000, the employee can elect to be paid in lump sum form or have the distribution rolled over to either qualified retirement plan or an individual retirement account (IRA). If no election is made within thirty days of notice, the vested account balance is automatically rolled into an IRA.

**Plan Termination.** Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

### (2) Summary of Significant Accounting Policies

**Basis of Accounting.** The financial statements of the Plan are prepared using the accrual method of accounting.

**Subsequent Events.** Management has evaluated all significant events occurring subsequent to the financial statements date through August 12, 2025, which is the date the financial statements were available to be issued, determining no events require additional disclosure in the financial statements except as noted in Note 9.

**Use of Estimates.** The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes, therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**Investment Valuation and Income Recognition.** The Plan has investments that are stated at fair value, except for its fixed annuity, a benefit-responsive investment contract, which is valued at contract value. The fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The shares of mutual funds are valued at fair value at year-end based upon the quoted market prices on an active market.

### (2) Summary of Significant Accounting Policies, Continued

***Investment Valuation and Income Recognition, Continued.*** Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Notes Receivable from Participants.*** Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and are expensed when they are incurred. If a participant ceased to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

***Contributions.*** Contributions from participants were accrued and credited to participants' accounts as of each pay period.

***Payment of Benefits.*** Benefits are recorded when paid.

***Forfeited Accounts.*** At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$7,605 and \$6,392, respectively. Forfeited non-vested accounts are used to reduce future employer contributions or pay administrative expenses. During 2024 and 2023, no forfeited non-vested accounts were used to reduce employer contributions.

***Administrative Expenses.*** Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

### (3) Investment Contract with Insurance Company

The Plan has entered into an investment contract with Great-West Life & Annuity Insurance Company ("Great-West") in which participants may invest in a fixed annuity. The fixed annuity option is a guaranteed fund with offering a guaranteed minimum rate of return at a rate set by Great-West. Great-West maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and asset charges. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and asset charges. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value unless withdrawals are due to plan or contract termination or preretirement distributions at age 59 1/2 or after.

### (3) Investment Contract with Insurance Company, Continued

The methodology for calculating the interest crediting rate for the fixed annuity is based on the earnings of the underlying assets in the annuity and prevailing market conditions. The interest crediting rate is reset quarterly. The average yield earned by the Plan for the fixed annuity was 3.00% for the year ended December 31, 2024.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. The Company does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

### (4) Party-in-Interest Transactions

Certain plan investments are in shares of mutual funds and common trust funds managed by Empower Retirement, custodian of the Plan and the Plan has participant notes receivable. The Company is the Trustee as defined by the Plan, and, therefore, these transactions qualify as party-in-interest, however, investments in these funds and participant notes receivable are permitted under the provisions of the Plan and would be exempt from the prohibition of party-in-interest transactions under ERISA.

### (5) Information Certified by Trustee

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Great-West held the Plan's investment assets and executed investment transactions from January 1, 2023 to December 31, 2024. Accordingly, Great-West, the custodian of the Plan, have certified that the information regarding the value of investments, notes receivable from participants, the related investment income, interest income on notes receivable from participants, and appreciation in fair value of investments as of December 31, 2024 and 2023 and for the year ended December 31, 2024 is complete and accurate.

### (6) Income Tax Status

The Plan obtained its latest determination letter effective on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The plan administrator and the plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and therefore, believe that the Plan is qualified, and the related trust is tax-exempt

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### (7) Fair Value Measurements

GAAP defines fair value, establishes a framework for measuring fair value and enhances disclosures about fair value measurements.

GAAP defines fair value as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. GAAP also establishes a fair value hierarchy which requires an entity to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. GAAP describes three levels of inputs that may be used to measure fair value:

Level 1: Observable inputs such as quoted prices (unadjusted) in active markets for identical assets or liabilities.

Level 2: Inputs other than quoted prices that are observable for the asset or liability, either directly or indirectly. These include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities that are not active; and model-driven valuations whose inputs are observable or whose significant value drivers are observable. Valuations may be obtained from, or corroborated by, third-party pricing services.

Level 3: Unobservable inputs to measure fair value of assets and liabilities for which there is little, if any market activity at the measurement date, using reasonable inputs and assumptions based upon the best information at the time, to the extent that inputs are available without undue cost and effort.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

### (7) Fair Value Measurements, Continued

Following is a description of the valuation methodologies used for assets measured at fair value.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### (8) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
