### Note 1: Description of Plan

The following description of the ResinTech, Inc. Profit Sharing 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### General

The Plan is sponsored by ResinTech, Inc (the "Company") and its affiliates: Aries Filterworks, Inc., ACM Technologies, Inc., VMX Technologies, LLC., Aqua Water Technologies, LLC., Action Pak, Inc and Action Pak of Baltimore. The Plan is a defined contribution plan covering all employees, excluding leased employees and residents of Puerto Rico, who have completed six months of service and are age twenty-one or older. An employee is eligible to participate in the Plan on the first day of the following month the requirements are met. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### Contributions

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan document, up to the maximum dollar amount permissible under the Internal Revenue Code ("IRC") Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. Participants may direct the investment of their contributions into various investment options offered by the Plan. The Company makes a safe harbor matching contribution in the amount equal to 100% of the first three percent of the participant's eligible compensation, and 50% of the next two percent of the employee's eligible compensation, contributed to the Plan as deferral contributions. Employer discretionary matching and nonelective contributions are also permitted under the plan agreement.

#### Participant Accounts

Each participant's account is credited with the participant's contribution, the Company contribution, earnings or losses thereon, and an allocation of expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are immediately vested in their voluntary contributions, Company safe harbor matching contributions, and any rollover contributions and earnings thereon. Vesting in discretionary matching and non-elective Company contributions, plus actual earnings thereon is based on a six-year (20% each year) graded scale which begins after two years of vested service.

Participants are immediately vested in all contributions if the participant is an employee of the Company at the time the participant attains the later of age 65 or the fifth anniversary of their hire date.

### Note 1: Description of Plan (Continued)

#### Investment Options

Upon enrollment in the Plan, participants direct employee and related Company contributions into a range of mutual funds and a common collective trust fund. All investments are participant directed. Investment options can be changed daily.

#### Forfeitures

Under the Plan, forfeited nonvested contributions may be used to reduce future employer contributions or pay plan administrative expenses. The Plan had \$5,439 and \$5,674 of forfeited nonvested contributions available as of December 31, 2024 and 2023, respectively. During the year ended December 31, 2024, forfeitures amounting to \$35 were utilized for Company contributions and \$530 for administrative expenses.

#### Notes Receivable From Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms shall not exceed five years except for the purchase of a primary residence. The notes are secured by the balance in the participant's account and bear interest at rates ranging from 4.25% to 9.50%. Principal and interest are paid ratably through payroll deductions. Participants may only have one loan outstanding at any given time.

#### Payment of Benefits

On termination of service due to death, disability, or retirement or attainment of age 59-1/2, a participant (or a participant's beneficiary in the event of death) may receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum payment or a direct rollover to another qualified retirement plan.

### Note 2: Summary of Significant Accounting Policies

#### Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States (GAAP).

#### Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

### **Note 2: Summary of Significant Accounting Policies (Continued)**

#### **Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Notes Receivable From Participants**

Loans to participants are reported at their unpaid principal balance plus any accrued interest. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Company and are excluded from these financial statements. Fees related to investment advisory services and the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are allocated proportionately to plan participants based on their respective account balances and are included in investment income.

#### **Subsequent Events**

The Plan has evaluated subsequent events through September 4, 2025, which is the date the financial statements were available to be issued.

### Note 3: Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs that are unobservable inputs for the asset or liability.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common collective trust fund:* Valued at the net asset value (NAV) of units of Great Gray Trust Company Large Cap Growth Fund, an investment fund offered by Fidelity (the Trustee). The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less liabilities. This practical expedient is not used when it is determined to be probable that the investment will be sold for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. The Plan has no commitments for future investments in the fund. Were the Plan to initiate full redemption of the common trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company contributions.

### **Note 6: Tax Status**

The Company adopted a nonstandard prototype document with an IRS notification letter which states the prototype plan document is in compliance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter; however, the plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

### **Note 7: Risks and Uncertainties and Concentration of Investments**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **Note 8: Related Party and Party-in-Interest Transactions**

Direct fees are paid by the Plan to Fidelity Management Trust Company ("Fidelity"), the Plan's Trustee, as defined by the Plan, for management of the Plan's investment; therefore, these transactions qualify as party-in-interest transactions. Fidelity also provides recordkeeping services to the Plan. Direct fees incurred and paid by the Plan for these services were \$38,663 for the year ended December 31, 2024. Levy Wealth Management provides outside investment advisory services to the Plan. Direct fees incurred and paid by the Plan for these services were \$20,000 for the year ended December 31, 2024.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transactions rules of ERISA.
