Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and, therefore, is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1. Description of Plan

The following description of So Others Might Eat 401(k) Retirement Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering substantially all eligible employees of SOME, Inc. (the “Employer”). Employees are eligible to start making elective deferrals to the Plan after attainment of age 21 and have completion of 1 month of service. Employees are eligible to receive the Employer discretionary matching contributions and employer safe harbor contributions upon attainment of age 21 and completion of 1 year of service. Employees who are employed as of the last day of the plan year are eligible to receive a nonelective discretionary contribution in accordance with the following classification allocations: Group A – Participants classified by the Employer as Executive Level employees, Group B – Participants classified by the Employer as Senior Director Level employees, Group C – participants classified by the Employer as Staff Level employees, and Group D – All other participants. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions

Each year, participants may contribute up to 100% of their eligible annual compensation on a pre-tax or Roth basis, subject to the limitations established by the Internal Revenue Code (“IRC”). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans. Participants direct the investment of their contributions into the various investment options offered by the Plan.

The Plan includes an automatic enrollment feature whereby eligible participants are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default rate set at 3% of their eligible compensation with an automatic increase of 1% per year up to a maximum of 10%. Effective January 1, 2025, the default rate was increased to 4% of their eligible compensation with an automatic increase of 1% per year up to a maximum of 10%. The amount deducted will be deducted on a pre-tax basis.

For the year ended December 31, 2024, the Plan made a safe harbor match equal to 100% of a participant’s first 6% of eligible compensation contributed to the Plan. From January 1, 2024 through March 31, 2024, the Plan made an additional matching contribution equal to 100% of a participants eligible compensation contributed to the Plan in excess of 6%, but no more than 10% of eligible compensation. Effective April 1, 2024, the Plan was amended to remove the additional matching contribution. The Employer did not make a nonelective contribution for the 2024 plan year.

Effective January 1, 2025, the Plan was amended to change the safe harbor match to equal 100% of a participant’s first 4% of eligible compensation contributed to the Plan and to change the additional matching contribution to a discretionary matching contribution on behalf of eligible Plan participants not to apply to elective deferrals exceeding 6% of the participants’ compensation.

Vesting

A participant is 100% vested in their contributions and safe harbor contributions including allocated earnings thereon at all times. Participants vest in discretionary matching contributions based on the following table:

Forfeitures

At December 31, 2024 and 2023, forfeited account balances were \$13,574 and \$12,922. These accounts may be used to reduce future Employer contributions or Plan expenses. During 2024, \$16,770 was used to reduce Employer contributions. During 2024, no forfeitures were allocated to participants or used to reduce Plan expenses.

Plan Expense Account

The Plan and Empower Trust Company, LLC entered into a service-based pricing arrangement whereby a portion of the revenue earned by certain Plan investments is passed through to the Plan for payment of permitted Plan expense. The Plan Expense Account is a nonparticipant directed account within the Plan. At December 31, 2024 and 2023, the Plan Expense Account balance was \$0. During 2024, \$57,771 of revenue was received by the Plan and used to reduce Plan expenses.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Employer's contributions and (b) Plan earnings (losses) thereon. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. All investments are participant directed.

Payment of Benefits

Participants are eligible to receive benefit payments when they terminate service or reach age 59 ½. On termination of service, a participant may elect to receive a distribution in the amount equal to the participant's vested interest in their account. Benefit payments are also permitted for death, disability, and hardship.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum amount of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. The loans bear interest at prime rate plus one percentage point and are secured by the participant's account. Principal and interest are repaid through payroll deductions in equal payments over the term of the loan (up to five years). The Plan permits longer repayment terms for loans made for the purchase of a principal residence. A participant may have no more than one outstanding loan from the Plan at any time.

Expenses

Certain expenses related to maintaining the Plan are paid by the Employer and are excluded from these financial statements. Any expenses not paid by the Employer are paid by the Plan. Investment related expenses are included in net appreciation in value of investments.

2. Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Fair Value Measurements

The Plan follows U.S. GAAP guidance on Fair Value Measurements which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

At December 31, 2024 and 2023, all of the Plan's investments, which were valued at fair value, were valued using level 1 inputs.

Investment Valuation and Income Recognition

All of the Plan's investments are stated at fair value except for the group annuity contract, which is valued at contract value. Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price.

The group annuity contract is valued at contract value, which represents contributions plus credited interest less participant withdrawals and fees.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the Plan year.

Notes Receivable from Participants

Participants loans are measured at their unpaid principal balance plus any accrued unpaid interest and are classified as notes receivable from participants. If a participant ceases to make loan repayments and the Plan administrator deems the loan to be in default, the participant loan balance is reduced and a benefit payment is recorded as a deemed distribution once a distributable event has occurred.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events Evaluation by Management

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is September 3, 2025.

3. Information Certified (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year), including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in value of investments, interest and dividends, and interest on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC and Empower Annuity Insurance Company of America, qualified institutions.

4. Group Annuity Contract

The Key Guaranteed Portfolio Fund (the “Fund”) is a general account product offered through a group annuity contract and is fully-benefit responsive. Participant principal and interest are fully guaranteed by the entire general account assets of Empower Annuity Insurance Company of America, the issuer of the Fund. Each quarter an interest rate is established for all money, regardless of when it was deposited. The credited interest rate may stay the same or change each quarter.

Participants may transfer their account balances to any other investment option offered under the Plan with no restrictions or penalties. No events are probable of occurring that might limit the ability of the Plan to transact with participants at contract value.

The credit risk of the issuer was evaluated by nationally recognized statistical rating agencies as follows: A.M. Best (A+), Moody’s (Aa3), Standard and Poor’s (AA), and Fitch (AA-). These ratings were as of September 2024.

5. Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (“IRS”) are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2023 excess contributions to the participants prior to March 15, 2024.

6. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Employer contributions.

7. Tax Status

The IRS has issued an opinion letter to the plan document preparer dated November 14, 2022, which states that the Plan is designed in accordance with the applicable regulations of the IRC. The Plan administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan is qualified and tax-exempt as of the financial statement date.

U.S. GAAP require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

8. Party-in-Interest Transactions

The group annuity contract was issued by Empower Annuity Insurance Company of America, trustee of the Plan. Therefore, these transactions qualify as exempt part-in-interest transactions under ERISA.

8. Party-in-Interest Transactions *(continued)*

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statement of net assets available for benefits.

Certain employees of the Employer, who may be participants in the Plan, perform administrative services for the Plan at no cost to the Plan.

9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investments securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Global and domestic economic uncertainty has resulted in significant volatility in financial markets. This volatility has affected, and may continue to affect, the value of the Plan's net assets available for benefits. The effects of economic and market conditions subsequent to December 31, 2024 are not reflected in these financial statements and future effects on the Plan's net assets available for benefits cannot be predicted.
