Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of The Automaster 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for plan benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for plan benefits for the years then ended, and the related notes to the financial statements.

(1) DESCRIPTION OF THE PLAN

The following description of the The Automaster 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

- (a) General – The Plan is a defined contribution plan formed on January 1, 1999 and most recently amended and restated effective January 1, 2020. The Plan covers all eligible employees of Automaster Motor Co., Inc., dba The Automaster (the “Company” or the “Plan Sponsor”), excluding nonresident aliens, employees acquired in an Internal Revenue Code Section 410(b)(6)(C) transaction, certain employees covered by a collective bargaining agreement, and drivers. Employees must attain the age of 21 and complete at least 250 hours within three months of service to contribute to the Plan. In accordance with the SECURE Act and SECURE 2.0, certain long-term, part-time employees may also be eligible to participate if they have completed at least 500 hours of service in three consecutive years (for plan years beginning before January 1, 2025) or two consecutive years (for plan years beginning on or after January 1, 2025), subject to the Plan’s provisions and applicable law. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).
- (b) Employee Contributions – Participants may contribute up to 100% of their compensation, as defined by the Plan, limited to a maximum amount as set by the Internal Revenue Service (IRS). These contributions may be pre-tax or after-tax Roth contributions. Participants who have reached age 50 before the end of the year are eligible to make catch-up amounts set by the IRS. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).
- (c) Employer Contributions – The Company may make discretionary matching and other discretionary contributions, as defined by the Plan. Contributions are subject to certain limitations under the Internal Revenue Code. Participants must be making salary deferrals, be employed on the last day of the Plan year and have worked a minimum of 1,000 hours during the Plan year to be eligible for the discretionary contributions.

The Company made a safe harbor match of 100% up to 3% and 50% up to 5% for the years ended December 31, 2024 and 2023. The Company made no other discretionary contributions in 2024 or 2023.

- (d) Participant Accounts – Each participant's account is credited with the participant's contributions, the Company's matching contributions, and allocations of the Company's other discretionary contributions and Plan earnings, and charged with an allocation of administrative fees. Allocations of the Company's other discretionary contributions are based on a participant's eligible compensation relative to total eligible compensation or as defined by the Plan. Allocations of Plan earnings and administrative fees are based on a participant's account balance relative to the total account balances of all participants in the same investment. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant determines the investment strategy of their entire account, as provided in the Plan.
- (e) Vesting – Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of service. A participant is 20% vested after two years of service, increasing 20% per year, with 100% vesting after six years of credited service. Participants automatically become fully vested upon death or disability while under the employment of the Company.

- (f) Payments of Benefits – Benefits are distributed under the Plan based on the normal retirement date (age 65), disability, death, hardship or the termination of employment of the participant. A participant may elect to receive a lump-sum distribution equal to the value of their account. Participants may also receive in-service distributions after age 59½, as defined, or if they meet certain criteria. Hardship distributions are permitted under the Plan. The amount may not exceed the pre-tax and Roth deferrals.
- (g) Forfeited Accounts – Under the Plan, forfeitures of terminated participants' nonvested accounts are used to reduce employer contributions, as defined, or pay administrative fees. Available forfeitures totaled \$1,001 and \$0 as of December 31, 2024 and 2023, respectively. Forfeitures used to reduce employer contributions were \$0 for the years ended December 31, 2024 and 2023. Forfeitures used to pay administrative fees were \$349 and \$13,424 for the years ended December 31, 2024 and 2023, respectively.
- (h) Notes Receivable – Participants may borrow from a minimum of \$1,000 up to 50% of their vested account balance, provided the loan does not exceed \$50,000. Participants are permitted one outstanding loan at a time. Loans are secured by the balance in the participant's account and bear interest at a reasonable rate, as defined by the Plan. Principal and interest are paid ratably through biweekly payroll deductions.

(2) SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

- (a) Basis of Accounting – The accompanying financial statements are prepared on the accrual basis of accounting.
- (b) Investment Valuation and Income Recognition – The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Quoted market prices are used to value investments. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gain and losses on investments bought and sold, as well as held during the year.
- (c) Notes Receivable – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent loans are treated as distributions based upon the terms of the Plan document.
- (d) Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.
- (e) Administrative Expenses – Generally, the Plan Sponsor pays the administrative expenses of the Plan, except expenses of the third-party administrator. Participants pay the distribution and loan processing fees, and certain investment fees.

(f) Benefit Payments – Benefits are recorded when paid.

(g) Subsequent Events – The Plan has evaluated subsequent events through October 15, 2025, which is the date that the financial statements were available to be issued.

(3) PLAN AMENDMENT AND TERMINATION

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue contributions or terminate the Plan at any time, subject to provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts. Additionally, the Company may amend the Plan at any time without the consent of any participant or any beneficiary, provided that no amendment deprives any participant of the participant's non-forfeitable accrued benefit.

(4) TAX STATUS

The Plan was formed based on a prototype plan that has received a determination letter dated November 23, 2020. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the section 401(a) of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress. The Plan administrator believes it is no longer subject to income tax examinations for the years prior to 2021.

(5) INFORMATION PREPARED AND CERTIFIED BY TRUSTEE

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. Accordingly, Ascensus LLC, the trustee of the Plan, has certified to the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for plan benefits as of December 31, 2024 and 2023, the schedule of assets held for investment purposes as of December 31, 2024 and the related investment activity reflected in the statements of changes in net assets available for plan benefits for the years ended December 31, 2024 and 2023.

(6) RELATED PARTY TRANSACTIONS

The Plan has a number of service providers. Such parties are considered parties-in-interest under ERISA.

(7) WITHDRAWING PARTICIPANTS

All participants who have withdrawn from the Plan and requested their benefits have been paid as of December 31, 2024.

(8) FAIR VALUE MEASUREMENTS

Accounting principles generally accepted in the United States of America establish a framework for measuring fair value. That framework provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds – Valued at the closing price reported on the active market on which the securities are traded.

Money market – The Plan is able to obtain actively traded quoted prices for these funds.
