INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator
Blue Shield of California Tax-Deferred Salary Investment Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of Blue Shield of California Tax-Deferred Salary Investment Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Blue Shield of California Tax-Deferred Salary Investment Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audits of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of Blue Shield of California Tax-Deferred Salary Investment Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Blue Shield of California Tax-Deferred Salary Investment Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audits of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audits section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. - Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Blue Shield of California Tax-Deferred Salary Investment Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control related matters that we identified during the audits.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental schedule of assets (held at end of year) as of December 31, 2024, ("supplemental schedule"), is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

NOTES TO FINANCIAL STATEMENTS YEARS ENDED DECEMBER 31, 2024 AND 2023

1. PLAN DESCRIPTION

General — Blue Shield of California Tax-Deferred Salary Investment Plan (the "Plan") is a defined contribution savings plan sponsored by California Physicians' Service dba Blue Shield of California (the "Company" or the "Employer"), pursuant to Section 401(a) and related provisions of the Internal Revenue Code ("IRC"). The Plan was established on October 1, 1983. The following description of the Plan is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan's provisions.

The Plan's assets are maintained in an individual trust under the terms of the Master Trust Agreement dated June 17, 2000, among the Blue Cross Blue Shield Association (the "Association"), the National Employee Benefits Committee ("NEBC"), and Fidelity Management Trust Company ("Fidelity" or the "Trustee"). The NEBC, a committee of the Association, acting through the Association's National Employee Benefits Administration ("NEBA"), administers the Plan.

The Plan is designed to provide participants with a means to defer a portion of their compensation for retirement and to provide benefits in the event of disability, death, termination or financial hardship. The Plan covers any employee whose compensation and conditions of employment are not established by a collective bargaining agreement (unless the agreement expressly provides for participation) and who is not classified as a leased employee, temporary employee, or student intern. Non-student interns whose date of termination is known upon hire, are eligible for plan participation. The Plan is subject to the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 ("ERISA").

Plan amendments — Effective April 3, 2023, the Plan document Selection of Investment Funds exhibit was amended. Effective June 15, 2023, the Recordkeeping Agreement was amended to include a non-solicitation clause. Effective April 1, 2024 and September 30, 2024, the Plan document Selection of Investment Funds exhibits were amended.

Vesting — Participants are immediately 100% vested in the value of all contributions, plus actual earnings thereon.

Plan administration — The Company is the sponsor of the Plan and the NEBC is the plan administrator. Fidelity and Fidelity Workplace Services, LLC, (the "recordkeeper") provide trustee and recordkeeping services, respectively. The Trustee manages the Plan's investments and makes investment transactions while the recordkeeper manages participant account and participant related transactions.

1. PLAN DESCRIPTION (continued)

Contributions — Participants may elect to contribute through payroll deduction amounts up to 50% of their annual compensation as defined by the Plan, on a pre-tax and Roth after-tax basis, up to the maximum amount allowed by the IRC. The Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled at a 4% pre-tax deferral rate unless they affirmatively elect not to participate in the Plan or elect a contrary deferral rate. Participants who do not opt-out of automatic enrollment by the specified time may request a return of automatic contributions, adjusted for gains and losses, within 90 days of the automatic enrollment effective date. This withdrawal will result in the forfeiture of any related Employer matching contributions, if applicable. On March 1 of each year, participants with a contribution election (pre-tax, Roth after-tax or both) between 1% and 14% will be automatically increased by 1%, until a maximum deferral rate of 15% is reached. Participants may opt out of this automatic increase within a specified period of time. The maximum allowed deferral amount was \$23,000 for the calendar year 2024. Employees over the age of 50 were allowed to make an additional \$7,500 catch-up contribution for calendar year 2024. Participants are also allowed to rollover contributions from other qualified plans. Participants direct the investment of their contribution into various investment options offered by the Plan.

The Employer will match one dollar of each dollar participants contribute up to 4% of pay each pay period (participants must contribute a minimum of 1%). The maximum Employer match applies to the first 4% of the participants' pre-tax and Roth contributions only. Contributions in excess of 4% are not eligible for the Employer match. At the end of the year, the Employer will review the percentage of the participants' deferral over the year and make any necessary "true-up" contribution to ensure matching is equal to one dollar for each dollar on up to 4% of the participants' pay. The Company made Employer matching contributions of \$33,824,850 for the year ended December 31, 2024.

The Employer will make an enhanced discretionary Employer contribution in the amount of 2% of eligible compensation ("2% Contribution") to participants who meet certain eligibility requirements (i.e. not actively participating in another Employer sponsored plan). The Employer can elect to make a discretionary, Company performance-based, contribution in the amount of 1% ("1% Contribution") of a participant's eligible compensation. Both the 2% Contribution and 1% Contribution (collectively "discretionary contributions") are paid out to eligible employees employed on the last business day of the year. Total discretionary contributions amounted to \$13,898,717 for the year ended December 31, 2024. Eligible compensation does not include severance pay or employee contributions to deferred compensation plans, compensation in excess of \$345,000 for 2024, or amounts contributed when the participant is not considered an employee. Contributions made in excess of \$345,000 for the discretionary contributions will be applied to the employee's non-qualified deferred compensation plan.

1. PLAN DESCRIPTION (continued)

Participant's accounts — Each participant's account is credited with the participant's contributions (including rollovers from the participant's previous plan), allocations of the Company's contributions if any, and the Plan's earnings and charged with an allocation of administrative expenses and Plan losses. Allocations of investment earnings are based strictly on the participant's selection of investments and time of purchase. Other allocations are based on participant earnings or account balances, as defined in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Payment of benefits — Distributions and withdrawals are payable upon retirement, termination, financial hardship, attainment of age 59½, or death. If a participant's account balance is less than \$1,000 following termination of employment, the balance is distributed within a designated period in the form of a lump-sum cash payment unless a direct rollover into another qualified benefit plan is requested. For balances equal to \$1,000 and equal to or less than \$7,000, following termination of employment, the balances will be distributed within a designated period to a default individual retirement account unless a lump sum payment or direct rollover to another qualified benefit plan is requested. Balances that exceed \$7,000 following termination of employment may be deferred, but no later than age 73 (or 72 if reached that age on or before December 2022, or age 70½ if attained before December 31, 2019).

Additionally, distributions can be requested at any time in the form of a lump sum payment or as an installment payment or partial withdrawal. Installment payments can be established over a period of time, in fixed dollar amount, based on an annualized fixed percent or life expectancy provided vested balance is more than \$7,000. Terminated participants receiving installment payments can elect at any time to change or cease that distribution, to accelerate the remaining amount to be distributed in the form of a lump-sum payment or to recommence installment payments that were previously stopped. Distributions over \$1,000 from the Employer's pension plan may be rolled over into the Plan following termination of employment.

Notes receivable from participants — Under the terms of the Plan, participants may borrow from their accounts, in the form of a note, a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 reduced by the participant's highest outstanding loan balance in the last twelve months or 50% of the participant's total vested account balance in the Plan, less the participant's current outstanding loan balance. Only one note may be outstanding at any given time and participants may not take out more than one note in any 12-month period. Notes are secured by the balance in the participant's account. New loans initiated during the month bear interest at the prime rate as published by Reuters on the last business day of the previous month. Interest rates on participant notes receivable ranged from 3.25% to 8.5% during the year ended December 31, 2024, and have maturity dates through November 2044.

The repayment of principal plus interest is required by the Plan to be made through payroll deductions over five years. If the note is for the purchase of a primary residence, it may be paid over twenty years. A note origination fee is deducted from a participant's account balance when a new note is taken; the fee is \$50 for each loan originated.

1. PLAN DESCRIPTION (continued)

Administrative expenses — Certain administrative expenses of the Plan, including recordkeeping and audit fees, were paid by the Company for the year ended December 31, 2024. Investment fees, which may vary according to the individual funds selected, are paid at the fund level, which affects Plan earnings.

Participants may be charged for some or all of the costs and expenses of operating the Plan. Such expenses include but are not limited to costs to process distributions, participant loans and domestic relations orders. The Company generally pays for any administrative expenses of the Plan. The Plan is not required to reimburse the Company for expenses paid on its behalf.

2. SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting — The financial statements are prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of estimates — The preparation of financial statements in conformity with U.S. GAAP requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Contributions and contributions receivable — Contributions from participants are recorded based on the date the contributions are separated from the participants' pay, which is the pay date. Contributions from the Company are recorded in the year earned to coincide with the year the Company records the contributions to its general ledger. The Plan records receivables for contributions based upon contributions recorded in the Plan year but received by the Plan subsequent to year end. Rollover contributions from participants are recorded based on the date the rollover contributions have been received by the Trustee.

Investment valuation and revenue recognition — The Plan's investments are stated at fair value. The Trustee certifies the fair value of all investments. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are reflected on a trade date basis. The daily value is used to determine the cost of investments sold. Dividend income is recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) in the fair value of investments represents realized gains and losses on investments bought and sold as well as held during the year.

2. SIGNIFICANT ACCOUNTING POLICIES (continued)

Risks and uncertainties — The Plan's investments are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities could occur in the near term, and such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and changes therein. Financial markets continue to experience significant volatility with the Federal Reserve's pursuit of contractionary policies in an attempt to control inflation.

Notes receivable from participants — Notes receivable are carried and presented at their unpaid balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. If a participant ceases to make repayments and the plan administrator deems the participant note to be a distribution, the note receivable balance is reduced, and a benefit payment is recorded. No allowance for credit losses has been recorded as of December 31, 2024.

Payment of benefits — Benefits are recorded when paid.

Administrative expenses — Expenses are recorded when incurred.

Subsequent events — The Plan has evaluated subsequent events through August 25, 2025 the date that the financial statements were available to be issued. No subsequent events have occurred that would have a material impact on the presentation of the Plan's financial statements.

3. FAIR VALUE MEASUREMENTS

Accounting standards established a framework for measuring fair value. The measurement framework provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to the unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

The three levels of fair value hierarchy are as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

3. FAIR VALUE MEASUREMENTS (continued)

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; or,
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/collective trusts: Valued using the NAV per share as a practical expedient to estimate fair value provided by the managers of the fund. The NAV practical expedient is based on the value of the underlying net assets owned by the applicable fund divided by the number of shares outstanding. These investments are not available in an exchange and active market; however, the fair values are determined based on the underlying investments as traded in an exchange and active market. There are no unfunded commitments and participants may redeem their investments daily.

4. TAX STATUS

The Plan received an Internal Revenue Service determination letter dated January 19, 2016, stating that the Plan met the requirements of Section 401(a) of the IRC regarding qualified plans. The Plan has been amended since the receipt of the opinion letter. However, the Company believes that the Plan is currently designed and operated in compliance with the applicable requirement of the IRC, and the Plan and Plan management believe the related trust will continue to be tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

5. INFORMATION CERTIFIED BY THE TRUSTEE (UNAUDITED)

The plan administrator, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of ERISA. Accordingly, the Trustee, determined to be a qualified institution by the plan administrator, has certified the completeness and accuracy of:

- Investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023;
- Net appreciation in fair value of investments, dividends and interest, and other income (including interest income from notes receivable from participants) reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024; and,

- Investments and notes receivable from participants reflected on the schedule of assets (held at end of year) as of December 31, 2024.

Accordingly, as requested by the plan administrator, the Plan's auditor performed no procedures on the certified information other than to agree the certified information to the related information included in the financial statements and supplemental schedule of assets (held at end of year).

6. PLAN TERMINATION

While the Company has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of a Plan termination, participants would become 100% vested in their accounts.

7. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

ERISA defines parties-in-interest similarly to the definition of related parties under U.S. GAAP, except that ERISA's definition is broader and includes all entities and individuals that provide services to the Plan; however, these entities may not necessarily be related parties. Management did not identify related parties to the Plan that were not also considered to be parties-in-interest.

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, and a person who owns 50% or more of such an employer or employee association or relatives of such persons.

Certain funds in the Plan's investment fund options are managed by the Trustee. The Trustee is a party-in-interest to the Plan. Therefore, transactions conducted by the Trustee and its affiliates, including fee offset agreements, qualify as party-in-interest transactions. Also, the Company pays certain fees and expenses on behalf of the Plan. These transactions qualify as exempt party-in-interest transactions.

Certain fund level fees incurred by the funds in which the Plan invests for such services as investment management, shareholder services, and sub-transfer agency fees are paid through fund level revenue-sharing arrangements. These fees reduce fund earnings, thereby impacting Plan revenue applied to participant's accounts.

The Trustee retains as compensation for services provided to the Plan, any interest on amounts earned while certain transactions are pending. This applies to both contributions and distributions. Earnings are at institutional money market rates.
