## Notes to Financial Statements

### NOTE 1 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### ***Basis of Presentation***

The accompanying financial statements of Indiana Rail Road Company 401(k) Plan (the "Plan") have been prepared on the accrual basis.

#### ***Investment Valuation and Income Recognition***

Investments are reported at fair value except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Investment securities, in general, are exposed to various risks such as interest rate, credit and overall market volatility risks. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect the amounts reported in the statements of net assets available for benefits.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### ***Notes Receivable from Participants***

For reporting purposes, participant loans are classified as notes receivable from participants. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

#### ***Benefit Payments***

Benefit payments are recorded when paid.

#### ***Related Party Transactions***

Indiana Rail Road Company (the "Company") provides the Plan with certain accounting and administrative services for which no fees are charged.

#### ***Expenses***

Fees related to the administration of notes receivable from participants, payment of benefits, investment advisory and processing of other transactions are charged directly to the participant's account and are included in administrative expenses. All other expenses of maintaining the Plan are paid by the Plan. Investment related expenses are included in the net appreciation of fair value of investments.

#### ***Use of Estimates***

The preparation of financial statements in conformity with generally accepted accounting principles ("GAAP") requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

#### ***Subsequent Event Evaluation***

Subsequent events were evaluated through August 26, 2025, which is the date the financial statements were available to be issued.

#### NOTE 2 DESCRIPTION OF PLAN

The following description of the Indiana Rail Road Company 401(k) Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

##### ***General***

The Plan is a defined contribution plan covering all employees of Company, with the exception of those residing in Puerto Rico. Eligible employees enter the Plan the first day of the month following 60 days of employment. In order to participate in the discretionary employer matching provision and profit sharing provision, participants must have attained the age of 20 ½. In September 2023, the Plan was amended to remove the age requirement for participation in matching and profit sharing provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan was established by the Company effective April 1, 1993, and subsequently amended and restated in its entirety effective September 1, 2015. Effective on January 1, 2022, the Plan was restated in its entirety and amended to implement the hardship provisions of the Bipartisan Budget Act of 2018.

##### ***Contributions***

Each year, participants may elect to contribute a percentage of their pretax or post-tax (as of July 1, 2018, see below) annual compensation, as defined in the Plan. These contributions are not to exceed limitations established under Section 402(g) of the Internal Revenue Code of 1986, as amended (\$23,000 at December 31, 2024). The Plan permits catch-up elective deferrals for participants over 50 years of age subject to Internal Revenue Code limitations. Effective July 1, 2018, eligible participants are able to contribute post-tax annual compensation.

Effective January 1, 2013, the Plan is known as a "qualified automatic contribution arrangement" 401(k) plan ("QACA"). Effective June 10, 2020, the Plan's automatic enrollment provision was changed from a QACA to a traditional automatic contribution arrangement ("ACA"). Effective January 1, 2021, the automatic enrollment provisions were changed back to a QACA. Under these arrangements, newly eligible participants are automatically enrolled in the Plan with contributions of three percent of compensation. Participants must notify the Plan if they do not want to participate or if they want to change their contribution amount. In addition, their contribution will automatically increase 1% every year starting in the third plan year after automatic enrollment until it reaches 6% unless the participant elects not to increase their deferral percentage.

The Company makes matching contributions under a safe harbor match to the Plan each year. The safe harbor match is 100% of the first 3% of compensation and 50% of the next 3% to 5% of compensation. The Company made safe harbor matching contributions of \$408,825 for 2024.

Each year at the discretion of the Company, an additional matching contribution may be made at a discretionary percentage. Employee deferral contributions are not matched by the Sponsor until the employee has satisfied the eligibility requirements. No discretionary match contributions were made in 2024.

Each year at the discretion of the Company, a profit sharing contribution may be made in any amount, limited to statutory amounts. Eligible participants are allocated contributions in proportion of their compensation to total compensation of all eligible participants. No profit sharing contributions were made in 2024.

### Notes to Financial Statements (Continued)

#### NOTE 2 DESCRIPTION OF PLAN (CONTINUED)

##### ***Rollover Contributions***

Participants may roll over their taxable portion of funds previously held for their account in another qualified retirement plan to the Plan on a tax-free basis.

##### ***Participant Accounts***

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and, (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### ***Vesting***

Participants are 100% vested in individual accounts derived from their employer safe harbor matching contributions upon entry date. Vesting in discretionary profit sharing or employer match is based on a six-year scale. Participants become fully vested in these accounts after six years of service.

##### ***Notes Receivable from Participants***

Participants may borrow from their respective accounts up to a maximum amount equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates. Loan terms range from one to five years or beyond five years, as agreed upon by the participant and the loan administrator, for the purchase of a primary residence. Principal and interest is paid ratably through semimonthly payroll deductions.

##### ***Payment of Benefits***

Upon termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or annual installments. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

In-service distributions are permissible from the Plan for participants that have attained the age of 59 1/2. Participants electing in-service distributions may elect to receive all or a portion of their vested benefits in a lump sum payment or annual installments.

In conditions of "financial hardship", a participant may apply to the Plan administrator for approval to withdraw that portion of his or her 401(k) retirement account balance necessary to meet the financial hardship, subject to the limitations of the Plan and the Internal Revenue Code.

##### ***Forfeitures***

Forfeited accounts, if any, can be used to reduce future employer contributions. At December 31, 2024 and 2023, there were \$4,992 and \$4,740 of forfeited, nonvested funds, respectively.

#### NOTE 3 FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

In 2018, the Plan entered into a benefit responsive contract with Standard Insurance Company. Standard Insurance Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specific interest rate that is guaranteed by the Plan.

Due to the fact that the guaranteed investment contract is fully-benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Standard Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but may not be less than zero percent. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include Plan termination and contract termination prior to Standard Insurance Company recovering all start-up costs. The Plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

Either party may terminate the contract with at least 60 days advance written notice to the other party.

#### NOTE 4 FAIR VALUE MEASUREMENTS

Under applicable GAAP for fair value measurements and disclosures, a three-level hierarchy is established for fair value measurements based on transparency of valuation inputs as of the measurement date. The hierarchy is based on the lowest level of input that is significant to the fair value measurement.

The three levels are defined as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs to the valuation methodology includes:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

### Notes to Financial Statements (Continued)

#### NOTE 4 FAIR VALUE MEASUREMENTS (CONTINUED)

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation approaches used for assets measured at fair value.

*Mutual funds:* Value at the net asset value (“NAV”) of shares held by the plan at year end.

*Common/collective trusts:* Valued based on the NAV of units of a collective trust published by the trustee. The NAV is valued daily and is the basis for current transactions.

Certain events limit the ability of the Plan to transact with participants at fair value of the common collective trusts. Such events include the following: (a) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (e.g., divestitures or spin-offs of a subsidiary) which cause a significant withdrawal from the Plan, or (d) the failure of the Plan to qualify for exemption from federal income taxes or any other prohibited transaction exception under ERISA. The Plan Administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact with the participants, is probable.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Gains and losses (realized and unrealized) included in changes in net assets available for benefits for the year ended December 31, 2024 are reported in net appreciation of fair value of investments.

#### NOTE 5 PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan termination, all amounts credited to participants' accounts will become fully vested and non-forfeitable.

#### NOTE 6 TAX STATUS

The Internal Revenue Service has determined and informed the Company by a letter dated June 30, 2020, that the proto-type Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provisions for income taxes have been included in the Plan's financial statements.

#### NOTE 7 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
