Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Circle of Life Retirement Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Circle of Life Retirement Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTES TO FINANCIAL STATEMENTS
DECEMBER 31, 2024 AND 2023

Note 1) Description of plan:

A general description of the Circle of Life Retirement Plan (Plan), is provided in the following paragraphs. Participants should refer to the plan agreement and summary plan description for a more complete description of the Plan's provisions.

General -

The Plan is a defined contribution plan covering substantially all employees of Circle of Life (Employer) with the exception of collectively bargained employees and nonresident aliens who receive no compensation from the Employer which constitutes income from sources within the United States. All eligible employees may make salary deferrals into the Plan. Employees who are age twenty-one or older and have been credited with one year of service, as defined in the plan document, are eligible to receive employer matching and discretionary contributions. Employees satisfying the eligibility requirements are eligible to enter the Plan, for purposes of receiving an employer matching and discretionary contribution at the beginning of each month. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and subsequent amendments.

Contributions -

Participants may contribute through payroll deductions and eligible rollover contributions. Participants may elect for contributions to be made pre-tax to a traditional, tax-deferred instrument or after-tax in the form of Roth contributions. Not including rollovers, participants may contribute not in excess of the individual elective deferral limit set forth in the Internal Revenue Code (IRC). Participants who have reached the age of 50 before the end of the plan year are eligible to make catch-up contributions.

For 2024, the Employer contributed 100 percent of the first three percent of base compensation that a participant contributed to the Plan as an Employer discretionary matching contribution. In addition, the Employer's Board of Directors may also determine to make an additional discretionary contribution to the Plan each year. No such additional discretionary contribution was made during 2024.

Participants direct the investment of their contributions and those of the Employer into various investment options offered under the Plan. The Plan currently offers several mutual funds as investment options for participants. Participants may change their elected investment options and salary deferral contributions at any time.

Participant accounts -

Each participant's account is credited with the participant's contribution plus an allocation of (a) the Employer's matching contribution and discretionary contribution, and (b) plan earnings less administrative expenses. Allocations of plan earnings are based on each participant's account balance. Allocation of Employer contributions are based on each participant's compensation. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting -

Participants are immediately vested in their salary deferral contributions and rollover contributions, plus actual earnings thereon. With respect to the Employer's matching and discretionary contributions, the benefits attributable to a participant shall be fully vested and non-forfeitable upon death, becoming totally disabled or normal retirement age. Vesting in the Employer's contributions, plus earnings thereon, for participants who terminate employment for reasons other than death, disability or retirement, is based on years of credited service. A participant is 100 percent vested after three years of credited service.

Note 1) Description of plan: (continued)

Payment of benefits -

Upon termination of service due to death, disability, retirement or other reasons, a participant may elect to receive an amount equal to the value of the participant's vested interest in the participant's account in a lump sum payment, or a partial lump sum payment. If a terminated participant's account balance is equal to or less than \$5,000, the account will be automatically distributed in a lump sum payment. As defined in the plan document, in-service withdrawals are available to participants who have met certain hardship requirements, consistent with the provisions of the IRC. Benefits shall be paid as soon as administratively feasible following the date on which a distribution is requested or is otherwise payable.

Forfeited accounts -

Forfeitures can be used to reduce either the Employer's matching or discretionary contributions or pay administrative expenses of the Plan. During the year ended December 31, 2024, there were no forfeitures available to be used to reduce the Employer's discretionary matching contribution. There were no forfeited non-vested accounts available for future use as of December 31, 2024 and 2023.

Plan termination -

Although it has not expressed any intent to do so, the Employer has the right under the provisions of the plan document to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their accounts.

Administrative expenses -

Certain expenses of maintaining the Plan are paid directly by the Employer and are excluded from these financial statements. Indirect investment related expenses are included in net appreciation (depreciation) in fair value of investments. Administrative expenses consist primarily of fees charged by the third-party service providers.

Note 2) Summary of significant accounting policies:

Basis of accounting -

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States.

Valuation of investments and income recognition -

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 6 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes gains and losses on investments bought and sold, as well as held, during the year.

Note 2) Summary of significant accounting policies: (continued)

Estimates and assumptions -

The preparation of financial statements in accordance with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Payment of benefits -

Benefit payments to participants are recorded upon distribution.

Risks and uncertainties -

The Plan invests in various mutual funds. Such investments, in general, are exposed to various risks such as interest rate, market volatility, and credit risks. During 2024, net appreciation in fair value of investments occurred due, in part, to investment performance. Due to the level of risk associated with these investments, it is at least reasonably possible that changes in value will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Note 3) Investments:

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the investment information certified by Ascensus Trust Company (Ascensus), except for comparing such information to information included in the Plan's financial statements and the applicable supplemental schedule.

All investment information disclosed in the accompanying financial statements and supplemental schedule of assets (held at end of year) was obtained or derived from investment information provided to the plan administrator and certified as complete and accurate by Ascensus.

Note 4) Tax status:

The Plan has been designed to qualify under Section 403(b) of the IRC. The terms of the Plan have been prepared to conform to the sample language provided by the Internal Revenue Service (IRS) in Revenue Procedure 2007-71 (or the draft Listing of Required Modifications issued April 4, 2009). Although it is not required, the plan administrator intends to apply for a determination letter on the Plan. The Plan is required to operate in conformity with the IRC to maintain the tax-exempt status for plan participants under Section 403(b).

Accounting principles generally accepted in the United States require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that, more-likely-than-not, would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by the IRS; however, there are currently no audits in process for any open tax periods. The plan administrator believes the Plan's annual return is no longer subject to income tax examinations for plan years prior to 2021.

Note 5) Party-in-interest transactions:

Party-in-interest transactions include relationships with fiduciaries, third-party service providers and the Employer, whose employees are covered by the Plan. Ascensus served as the custodian and provided third-party administrative services and recordkeeping to the Plan. These transactions are exempt from being prohibited transactions under ERISA.

Note 6) Fair value measurements:

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date.

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, establishes a fair value hierarchy that requires the use of observable inputs and minimizes the use of unobservable inputs when measuring fair value. The standard describes three levels of inputs that may be used to measure fair value.

- Level 1 Inputs - Valuations based on quoted prices for identical assets or liabilities.
- Level 2 Inputs - Valuations based on observable inputs other than quoted prices included in Level 1, such as quoted prices for similar assets or liabilities in active markets; quoted prices for similar assets or liabilities in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.
- Level 3 Inputs - Valuations based on unobservable inputs reflecting the plan administrator's own assumptions, consistent with reasonably available assumptions made by other market participants. The Plan did not hold any investments categorized as Level 3 as of December 31, 2024 and 2023.

Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The inputs used for valuing assets are not an indication of the risk associated with investing in those assets.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual funds -

The fair value of mutual funds, other than the money market mutual fund, is based on quoted market prices of identical assets in active markets, which is categorized within Level 1 of the fair value hierarchy.

The fair value of the money market mutual fund is based on the fair value of the underlying investments. The underlying investments are valued based on quoted market prices of the shares held by the fund at year end, which are also categorized within Level 1 of the fair value hierarchy. The money market mutual fund's objective is to achieve a \$1 per share value, based on the underlying investments fair value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan administrator believes the valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 7) Reconciliation of financial statements to IRS Form 5500:

Net assets available for benefits at December 31, 2024 and 2023, as disclosed in IRS Form 5500 were \$7,097,132 and \$6,139,419, respectively, which is identical to that reported in the statements of net assets available for benefits.

Benefits paid to participants for the year ended December 31, 2024, as disclosed in IRS Form 5500 totaled \$759,547, which is identical to that reported in the statement of changes in net assets available for benefits.

Contributions and transfers of assets for the year ended December 31, 2024, as disclosed in IRS Form 5500 totaled \$924,191, which is identical to that reported in the statement of changes in net assets available for benefits.

Net appreciation in fair value of investments for the year ended December 31, 2024, as disclosed in IRS Form 5500 totaled \$660,590, which is identical to that reported in the statement of changes in net assets available for benefits.

Note 8) Subsequent events:

The plan administrator has evaluated subsequent events through August 19, 2025, the date the financial statements were available for release. The plan administrator is not aware of any subsequent events that would require recognition or disclosure in the financial statements.
