Except as discussed in the following paragraph, in planning and performing our audit of the financial statements of Maine Savings Federal Credit Union 401(k) Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as of and for the year ended December 31, 2024, in accordance with auditing standards generally accepted in the United States of America, we considered the Plan's system of internal control over financial reporting (internal control) as a basis for designing audit procedures that are appropriate in the circumstances for the purpose of issuing our report on the financial statements, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, we do not express an opinion on the effectiveness of the Plan's internal control.

We were engaged to perform an ERISA Section 103(a)(3)(C) audit of those financial statements as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. As permitted by ERISA Section 103(a)(3)(C), our audit did not extend to any statements or information related to assets held for investment of the Plan (investment information) by Fidelity Management Trust Company that prepared and certified the statements or information regarding assets so held in accordance with 29 CFR 2520.103-5. Our audit also did not include a consideration of internal control relating to the investment information.

Our consideration of internal control was for the limited purpose described in the preceding paragraph and was not designed to identify all deficiencies in internal control that might be material weaknesses or significant deficiencies and, therefore, material weaknesses or significant deficiencies may exist that were not identified. In addition, because of inherent limitations in internal control, including the possibility of management override of controls, misstatements due to error or fraud may occur and not be detected by such controls.

A deficiency in internal control exists when the design or operation of a control does not allow management or employees, in the normal course of performing their assigned functions, to prevent, or detect and correct misstatements on a timely basis. A material weakness is a deficiency or a combination of deficiencies in internal control, such that there is a reasonable possibility that a material misstatement of the Plan's financial statements will not be prevented, or detected and corrected, on a timely basis. We did not identify any deficiencies in internal control that we consider to be material weaknesses.

A significant deficiency is a deficiency, or a combination of deficiencies, in internal control that is less severe than a material weakness, yet important enough to merit attention by those charged with governance. We consider the following deficiencies in the Plan's internal control to be significant deficiencies.

#### USE OF FORFEITURES

The Plan began the year with a forfeiture balance of approximately \$11,000 related to forfeitures from 2023. The plan document requires forfeitures to be used no later than the end of the plan year immediately following the year in which the forfeitures occurred. These forfeitures must first be used to pay the administrative expenses of the Plan, then can be used to reduce the employer contributions to the Plan. Approximately \$2,000 in forfeitures were utilized in 2024. We recommend management review their procedures to ensure timely allocation of forfeited funds. We further recommend management instruct the Plan's third-party administrator (TPA) to utilize the forfeiture balance in accordance with the plan document.

#### PLAN COMPENSATION

During our audit, we noted three participants' elected deferrals and corresponding employer contributions were not applied to regular and overtime compensation for certain pay periods. Regular and overtime compensation are eligible compensation under the Plan and should be subject to a participant's deferral election and related employer contributions. We recommend management review their procedures to ensure participant elections are properly applied to all sources of eligible plan compensation. We further recommend management consult the Plan's TPA to identify any potential corrective action needed.

#### DEFERRAL ELECTIONS

During our audit, we noted one participant with discrepancies between their deferral election and actual withholdings per the payroll system. We recommend management enhance their internal controls to ensure deferral elections are entered into the payroll system accurately and timely. We further recommend management consult with the Plan's TPA to identify any potential corrective action needed.

In planning and performing the audit we noted the following situations that are not control deficiencies but are opportunities for strengthening internal controls.

#### CONTRIBUTION REMITTANCE CONSISTENCY

The Plan sponsor is required by the Department of Labor (DOL) regulations to remit participant contributions as soon as practicable. We noted the majority of participant contributions were remitted to the Plan within two days of the payroll date. However, we also noted one deposit remitted five days after the payroll date. The DOL may issue penalties and fines for not remitting participant contributions as soon as practicable. We recommend management review and evaluate current remittance practices and implement procedures to ensure timely and consistent remittance of deferrals to minimize the risk of late contributions.

## PLAN OVERSIGHT

During our audit inquiries of Plan management, it came to our attention that there is no review or reconciliation of Plan level trust statements and activity throughout the year. Periodic review and reconciliation of Plan level trust statements and activity throughout the year allows plan management and/or plan fiduciaries to identify and correct errors in a timely manner, as well as document oversight of the Plan and assist in mitigating fiduciary risk. We recommend management establish procedural controls to ensure Plan level trust statements are periodically reviewed and reconciled with plan sponsor payroll and other relevant records. The review and reconciliation process should be documented and include employee contributions, employer contributions, distributions, fees, and other activity for any unusual or unexpected transactions.

## INCONSISTENT DEMOGRAPHIC DATA

During our audit, we noted there are insufficient controls in place to ensure employee data in the recordkeeping system agrees to the payroll system. We noted a significant discrepancy in one employee's date of hire. The accuracy of employee data in the recordkeeping system is important, as it is utilized to ensure the Plan's compliance with laws and regulations. We recommend management implement policies and procedures to ensure employee data captured in the recordkeeping system is accurate.

We have discussed these comments and suggestions with the Plan's personnel, and we will be pleased to discuss them in further detail, at your convenience, to perform any additional study of these matters, or to assist you in implementing the recommendations.

We wish to take this opportunity to express our appreciation for the courtesy and cooperation extended to us by the management and employees of the Plan throughout our examination.

INDEPENDENT AUDITORS' REPORT

To the Supervisory Committee  
Maine Savings Federal Credit Union 401(k) Plan and Trust:

**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements**

We have performed an audit of the accompanying financial statements of the Maine Savings Federal Credit Union 401(k) Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Maine Savings Federal Credit Union 401(k) Plan and Trust's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Notes 3 and 8 to the financial statements, is complete and accurate.

## Auditors' Responsibilities for the Audit of the 2024 Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Maine Savings Federal Credit Union 401(k) Plan and Trust's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Maine Savings Federal Credit Union 401(k) Plan and Trust's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

## 2024 Supplemental Schedule Required by ERISA

The supplemental Schedule H, line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## Auditors' Report on the 2023 Financial Statements

The financial statements of the Maine Savings Federal Credit Union 401(k) Plan and Trust for the year ended December 31, 2023, were audited by predecessor auditors. In accordance with ERISA section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the United States Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the prior year audit did not extend to any statements or information related to assets held for investment of the plan that were certified by a qualified institution. Their report dated October 1, 2024, indicated that in their opinion (a) the amounts and disclosures in the 2023 financial statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) and (b) the information in the 2023 financial statements related to assets held by and certified to by a qualified institution agreed to, or was derived from, in all material respects, the information prepared and certified by an institution that management determined met the requirements of ERISA Section 103(a)(3)(C).
