**Note 1: Description of Plan**

The following description of the HG 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering all employees of Hankey Group employees, except for leased employees. The Hankey Group consists of Hankey Investment Company, LP (the "Company") and its affiliates, HFC Acceptance, LLC, Midway Rent A Car, Inc., Westlake Services, LLC, Nowcom, LLC, Knight Management Insurance Services, LLC, TNK Motors, Inc., Western Funding Incorporated, Westlake Portfolio Services, Inc., US Insurance Service, LLC, Conrad Staffing Services, LLC, CULA LLC, Knight Management Company, LC, Nowpay, LLC and Covered Holdings, Inc.. The Plan is intended to satisfy all of the requirements for a qualified retirement plan under the appropriate provisions of the Internal Revenue Code ("IRC") and similar state tax laws. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan initially became effective on January 1, 1996.

Employees will become eligible to participate in the Plan if they have completed six months of service and have reached the age of 18. Participants. Participants may enroll in the Plan immediately upon satisfaction of the eligibility requirements.

**Contributions**

The Company also sponsors another defined contribution retirement plan, Westlake Services Holding Company Employee Stock Ownership Plan ("ESOP Plan"). Eligible participants may contribute between a minimum 2% and a maximum 25% of their annual compensation in pre-tax contributions, Roth contributions, a combination of these of these two types offered by the Plan or ESOP Plan. Participants may also contribute amounts representing distributions from other qualified plans ("rollovers"). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants direct the investment of their contributions into various investment options offered by the Plan or ESOP Plan. Contributions are subject to certain Internal Revenue Service ("IRS") limitations, which applies to total of both plans.

The Plan allows for the Company to make discretionary matching contributions. The Company provides an employer matching contribution based on total employee deferrals and eligibility criteria among two plans. To qualify for a match, employees must have an active employment status at the last business day of the plan year and must have worked at least 1,000 hours during the year. Employer matching contributions are subject to the IRS maximum compensation limit of \$345,000, resulting in a maximum employer match of \$13,800 for 2024. The Company's matching formula is tiered based on the employee's contribution rate as a percentage of eligible compensation as follows:

- For combined employee contributions between the plan and ESOP Plan up to 3%, the Company matches 100 % of the employee's contribution, up to 3% of compensation.
- For combined employee contributions between the plan and ESOP Plan of 3-5%, the Company matches 100% of the first 3% and 50% of the 1-2%, resulting in a total potential match of up to 4%.
- For combined employee contributions between the plan and ESOP Plan of 5% or more, the maximum employer match remains 4% of eligible compensation.

**Note 1: Description of Plan (Continued)**

Total employer match is first calculated at combined for both the Plan and the ESOP Plan. Then, it is further allocated proportionally between the Plan and ESOP Plan based on how employee contributions are funded between two plans.

**Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contributions, (b) Plan earnings or losses, and (c) administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately 100% vested in their contributions plus actual earnings thereon. The Company's matching contributions and earnings thereon will be vested in accordance with the following schedule:

Less than 2	0%
2	20%
3	40%
4	60%
5 or more	100%

A participant who is an employee on or after the date they reach normal retirement age (as defined by the Plan) will be 100% vested in employer contributions.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant account. All loans shall bear an interest rate equal to the prime rate of Wells Fargo plus 1%, which shall remain fixed throughout the duration of the loan. Principal and interest is paid ratably through payroll deductions. Each participant may have two loans outstanding at a time in a rolling 12 month period. For participant loans that become delinquent, the amount of the unpaid loan principal plus any accrued unpaid interest will be treated as a deemed distribution. Deemed distributions are reported as a taxable distribution and remain part of the participant's account balance until a distributable event occurs.

**Payment of Benefits**

On termination of service due to death, disability, retirement or other reasons, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in their account. Participants may also elect to rollover their account to another tax deferred account or remain in the Plan until they are legally required to begin taking distributions. All vested account balances not exceeding \$1,000 will be immediately distributed in a lump-sum payment. All vested account balances exceeding \$1,000, up to \$5,000, will be immediately rolled into another tax deferred account. With the Plan administrator's approval, participants may withdraw all or part of their aggregate contributions in the event of financial hardship. Active employees who attain age 59 1/2 are permitted to withdraw at any time any part of his or her vested account.

**Forfeited Accounts**

At December 31, 2024 and 2023, forfeited non-allocated accounts totaled \$351,049 and \$301,453, respectively. Forfeitures are retained in the Plan and may be used to reduce employer contributions or to pay Plan expenses. For the year ended December 31, 2024, the employer contributions were reduced by \$200,000 and plan expenses were reduced by \$42,152 from forfeited non-vested accounts.

**Note 2: Summary of Accounting Policies**

**Basis of Accounting**

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

The accompanying financial statements of the plan have been prepared on the modified cash basis of accounting. Under this basis, contributions are recorded when received, with expenses and benefit payments being recorded when paid. Although the modified cash basis of accounting represents a departure from accounting principles generally accepted in the United States of America, it is an allowable method of accounting for employee benefit plans under the reporting requirements of ERISA.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and custodian. See note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income and dividend income are recorded on a cash basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowances for credit losses have been recorded as of December 31, 2024 or 2023. Delinquent notes receivable that are deemed by the plan administrator to be in default are treated as distributions based on the terms of the Plan document.

**Payment of Benefits**

Benefits are recorded when paid.

**Plan Fees and Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

**Date of Management's Review**

Events occurring after December 31, 2024 have been evaluated for possible adjustments to the financial statements or disclosures as of August 8, 2025, which is the date the financial statements were available to be issued.

**Note 3: Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common Collective Trusts ("CCTs"):

Principal/BlackRock S&P 500 Index CIT N Fund: This fund invests in equity securities that comprise the S&P 500 Index. These securities are valued at their quoted market prices (Level 1 inputs) on the primary exchange where the security is principally traded, as of the close of business on the valuation date. The Fund's net asset value, representing its fair value, is calculated daily by aggregating the market value of its underlying securities, less any liabilities, divided by the number of units outstanding.

Principal Stable Value Z Fund: This is a stable value collective investment trust ("CIT") for which the fair value is based on contract value. The contract value is the amount which participants would receive if they were to initiate permitted transactions under the terms of the underlying defined-contribution plans. The NAV, which is valued similarly to mutual funds valuation methods described above, is the basis for current transactions and the CIT can be redeemed at NAV as of the measurement date. The NAV of the CIT is not publicly quoted but is available to current investors through the Employer's website or by accessing their account information. Therefore, the investment is considered having a "readily determinable fair value".

Pooled separate accounts ("PSAs"): The Plan's PSA invests in a single mutual fund. The fair value of this underlying mutual fund is determined using a third-party vendors' pricing and observable market data, consistent with mutual funds valuation methods described above. Although the PSA itself is not publicly traded, its NAV, which is calculated using publicly quoted inputs, is available to current investors through the Employer's website or by accessing their account information. The NAV serves as the basis for current transactions, and the investment can be redeemed at NAV as of the measurement date. Therefore, the investment is considered having a "readily determinable fair value".

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

In accordance with Subtopic 820-10, certain investments that were measured at net asset value per share (or its equivalent) have not been classified in the fair value hierarchy. The fair value amounts presented in the following tables are intended to permit reconciliation of the fair value hierarchy to the line items presented in the statement of net assets available for benefits.

#### Note 4: Certified Investment Information

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal Trust Company, a qualified institution, has certified that the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net investment income and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investment information, except for notes receivable from participants, included in the schedule of assets (held at end of year) as of December 31, 2024, as shown on the supplemental schedule.

**Note 4: Certified Investment Information (Continued)**

At the request of the Plan Administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

**Note 5: Party-In-Interest Transactions**

The Plan allows for transactions with certain parties who may perform investment or recordkeeping services for the Plan. The Plan also issues loans to participants, which are secured by the balances in the participant's accounts. These transactions qualify as party-in-interest transactions for which a statutory exemption exists.

**Note 6: Transfers from ESOP Plan**

Effective January 1, 2023, the Plan permits in-service transfers from ESOP Plan for participants who have completed at least five years of service. Transfers are limited to one per Plan year, with a minimum amount of \$10,000 and a maximum of \$50,000. During 2024, participants transferred total of \$2,467,325 was transferred by participants during 2024. The funds were credited to participant Rollover accounts within the Plan.

**Note 7: Plan Termination**

Although it has not expressed any intent to do so, the sponsoring Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in any employer contributions.

**Note 8: Tax Status**

The Plan uses a pre-approved plan document, which received an advisory letter from the IRS, dated June 30, 2020, stating that the pre-approved plan document satisfies the applicable provisions of the IRC. Subsequent to this determination, the Plan was amended and restated. The Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions and there are currently no audits for any tax periods in progress.

**Note 9: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the statements of net assets available for benefits.

#### Note 10: Delinquent Participant Contributions

During the 2021 to 2023, the Company had failed to remit employee deferrals in the time described in 29 CFR 2510.3-102. As a result of these late remittances, the Plan is considered to have engaged in a prohibited transaction. The plan administrator has identified the procedural errors that allowed the late deferrals to occur and has taken steps to ensure that this does not happen again in the future. The Company is in the process of self-correcting the late remittances and will remit lost warnings to the Plan. These earnings are expected to be immaterial to the financial statements.
