Note 1 - Plan Description

The following description of Dearborn Holding Company, LLC 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees who meet the hours requirement stated in the plan document and are not covered by collective bargaining agreements or employees who are classified as interns of Dearborn Holding Company, LLC (the "Company") and are age 18 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Eligible employees are permitted to begin participating in the Plan on the first day of the subsequent month.

Contributions

A participant may elect to contribute up to 100 percent of the participant's eligible compensation, as defined in the Plan, subject to the maximum Internal Revenue Service (IRS) limits in accordance with Internal Revenue Code (IRC) Section 402(g). Roth 401(k) contributions may also be made from up to 100 percent of a participant's eligible compensation. Participants age 50 or older by the end of the calendar year who make deferral contributions to the Plan may also make a catch-up contribution of up to \$7,500. Rollover contributions are permitted by the Plan except for after-tax rollovers.

The Company may make a discretionary matching contribution based on a percentage of participants' eligible contributions. The contribution period for matching contributions is determined each plan year. In 2024, the discretionary match is based on 25 percent of the lesser of 6 percent of eligible compensation deferred or the employee contributions. Total discretionary matching contributions were \$444,583 for 2024.

The Company is required to make safe harbor contributions of 3 percent of the participant's eligible compensation. Participants are eligible to receive safe harbor contributions if they have completed one year of service and 1,000 hours. Total safe harbor contributions were \$981,878 for 2024.

The Company makes annual discretionary profit-sharing contributions to the Plan, as approved by the Company's board of directors. In 2024, the profit-sharing contribution was 2.50 percent of eligible compensation. Participants are eligible to receive profit-sharing contributions if they have completed one year of service and 1,000 hours. Total profit-sharing contributions were \$767,612 for 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

Vesting

Participants are immediately 100 percent vested in employee salary, rollover, and employer safe harbor contributions and any income or loss thereon.

Vesting in the Company's matching contributions is based on years of service. Participants vest in contributions made by the Company 100 percent after one year of service.

Vesting in the Company's profit-sharing contributions is based on six years of continuous service, beginning at 20 percent after two years of service and increasing 20 percent for each year of continuous service thereafter. A participant is 100 percent vested after six years of service with the Company.

Note 1 - Plan Description (Continued)

Forfeitures

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future company contributions or to pay administrative expenses of the Plan. At December 31, 2024 and 2023, forfeited account balances are not significant to the Plan.

Participant Notes Receivable

Participants may borrow from their accounts subject to certain maximum and minimum amounts prescribed in the plan document and in the Internal Revenue Code. Notes receivable bear interest at a market rate.

Benefit Payments

Distributions are payable upon retirement, death, disability, or termination of employment in the form of a lump-sum amount equal to the vested balance of a participant's account.

Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan document. The trustee must approve any such hardship withdrawals based on criteria defined in the plan document and directed by the Company.

Party-in-interest Transactions

Certain plan assets are in investment funds managed by Fidelity Management Trust Company or its affiliates. Fidelity Management Trust Company is the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

Termination

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

Note 2 - Summary of Significant Accounting Policies

Investment Valuation

The Plan's investments are stated at fair value.

The common/collective trust fund is valued at net asset value per share (NAV) (or its equivalent) of the fund, which is based on the fair value of the fund's underlying assets. There are no redemption restrictions or unfunded commitments on the investment.

The money market fund is valued at fair value based on its outstanding balance.

All other investments are valued based on quoted market prices reported in active markets. See Note 5 for additional information.

Participant Notes Receivable

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

Benefit Payments

Benefits are recorded when paid.

Note 2 - Summary of Significant Accounting Policies (Continued)

Administrative Expenses

Administrative expenses were incurred directly by the Plan and included expenses related to the Plan's custody of assets, various transaction processing fees, and record keeping of participant accounts. Additionally, various administrative costs are paid by the Company on behalf of the Plan.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including September 5, 2025, which is the date the financial statements were available to be issued.

Note 3 - Certified Information

Fidelity Management Trust Company (the "Trustee") holds the Plan's investments and participant notes receivable and executes all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Trustee.

Note 4 - Tax Status

The Plan, as adopted, is a preapproved plan, which does not require an application for a determination letter from the IRS. The preapproved plan has received a favorable notification letter from the IRS dated June 30, 2020. The Plan has not individually sought its own determination letter.

Note 5 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Note 5 - Fair Value Measurements (Continued)

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.
