Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements the Metal Flow Corporation Profit Sharing and Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Opinion

- The certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meet the requirements of ERISA Section 103(a)(3)(C).



Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). 1. Plan Description

The following description of the Metal Flow Corporation Profit Sharing and Savings Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Metal Flow Corporation (the Company or Employer) who have completed 90 days of service and are age 18 or older. Effective June 1, 2024, the days of service required for entry into the plan changed to 30 days. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

The trustee of the Plan is Principal Trust Company (the Trustee). The Trustee and its affiliate Principal Life Insurance Company hold all assets of the Plan in accordance with the service provider contracts with the Company.

Contributions

Participants can contribute a portion of their compensation as a pre-tax contribution to the Plan, up to the maximum allowed under the Plan and the Internal Revenue Code (IRC). Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are enrolled automatically in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The automatic deferral contribution will be increased automatically as soon as administratively feasible on or after each September 1 by 1% up to a maximum automatic deferral contribution of 10%.

The Company may also make a discretionary profit-sharing or discretionary matching contribution, to be determined annually. Participants with at least 1,000 hours of service must be employed on the last day of the year, except for those who retired, are determined to be disabled, or who are deceased during the year, to be eligible for the employer discretionary contribution. The discretionary profit-sharing contributions made during 2024 and 2023 were \$670,741 and \$732,650, respectively, excluding forfeitures. There were no discretionary matching contributions made during 2024 and 2023.

Vesting

Participants are immediately 100% vested in employee salary and rollover contributions and income or loss thereon. Effective June 1, 2024, employer matching contributions are also immediately 100% vested. Vesting in the Company's discretionary contribution portion of their accounts, plus actual earnings thereon, continues to be based on years of service. Participants vest in discretionary contributions 20% after two years of service, and an additional 20% per year thereafter, until they become fully vested after six years of service.

Participant Accounts

Each participant's account is credited with the participant's contributions, allocations of the Company's matching and discretionary non-elective contributions, and Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investment of their account balances into various investment options offered by the Plan.

Payment of Benefits

Upon termination of service due to death, disability, retirement, or separation, participants may elect to receive their benefits as a lump-sum amount equal to the value of the interest in their accounts, unless the participant elects to receive his or her benefits in the form of installment annuities. Additionally, under certain circumstances of financial hardship or age, participants are allowed to withdraw funds from the Plan.

Forfeitures

The Plan provides that forfeitures of terminated participants' non-vested balances may be used to pay administrative expenses or reduce employer contributions. Unused forfeitures are allocated to eligible participants. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$67,101 and \$28,141, respectively. During 2024 and 2023, the Plan used forfeitures to pay administrative expenses in the amount of \$21,890 and \$12,604, respectively. Forfeitures in the amount of \$26,052 and \$21,264 were used to offset employer contributions for the years ended December 31, 2024 and 2023, respectively.

Notes Receivable from Participants

Participants may borrow up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants may have only one loan outstanding at any time. The minimum note amount is \$1,000. The notes are secured by the balance in the participant's account and bear interest at a reasonable rate, which is the prevailing rate charged by other lenders for similar loans. Interest rates on notes receivable outstanding at December 31, 2024 range from 4.25% to 9.50%. The notes are repaid ratably through payroll deductions over a period of five years or less, unless for the purchase of a principal residence, which may be repaid over the lesser of a reasonable period of time or ten years.

Administrative Expenses

Certain administrative expenses of the Plan are paid by the Company. Fees related to administration of notes receivable from participants and benefit payments are charged directly to participant accounts. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments.

The Plan has an ERISA Budget Agreement with the Trustee. Administrative expenses are presented net of revenue credits in the statement of changes in net assets available for benefits.

2. Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared under the accrual method of accounting.

Subsequent Events

Subsequent events have been evaluated by management through July 29, 2025, the date these financial statements were available to be issued.

Use of Estimates

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value, except for the guaranteed investment contract which is valued at contract value. Fair value is the price that would be received to sell an asset (an exit price) in the principal or most advantageous market for the asset in an orderly transaction between market participants on the measurement date. See Note 3 for discussion of fair value measurements. See Note 5 for discussion of guaranteed investment contract.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year. Interest income is recorded on the accrual basis; dividends are recorded on the ex-dividend date.

Notes Receivable from Participants

Participant loans are classified as notes receivable from participants and are measured at the unpaid principal balance plus unpaid accrued interest. Defaulted loans, if any, are reclassified as deemed distributions based upon the terms of the Plan Agreement.

Contribution Receivable

Participant contributions and any related employer matching contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's

compensation. Non-elective/Profit sharing contributions are recorded in the relevant period in accordance with the terms in the Plan document.

Payment of Benefits

Benefits are recorded when paid.

3. Investments

In accordance with Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, the Plan utilizes a fair value hierarchy for valuation inputs that gives the highest priority to quoted prices in active markets for identical assets (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in inactive markets, and other inputs that are observable or can be corroborated by observable market data.

Level 3 - Inputs to the valuation methodology are both significant to the fair value measurement and unobservable.

The following valuation methodologies were used to measure the fair value of the Plan's investments:

Collective Investment Trusts (CITs) - Units held in CITs are valued at the net asset value (NAV) as reported by the Trustee. The CITs held by the Plan provide for daily redemptions by the Plan at reported NAV with no advance notice requirement. The Plan is permitted to redeem investment units at NAV on the measurement date. NAV is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. There are no unfunded commitments related to the CIT investments. These investments are direct filing entities.

Pooled Separate Accounts (PSAs) - Units held in PSAs are valued based on the underlying investments (i.e., common stock, mutual funds, short-term securities). While the majority of the underlying asset values are based on quoted prices, the NAV of the PSAs are not publicly quoted. The NAV is reported by the fund managers as of the financial statement date based on recent transaction prices and is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. The PSAs held by the Plan provide for daily redemptions by the Plan at reported NAV with no advance notice requirement. The Plan is permitted to redeem investment units at NAV on the measurement date. There are no unfunded commitments related to the PSA investments. These investments are direct filing entities.

Mutual Funds - These assets are valued at daily closing price as reported by the fund. These funds are required to publish their NAV and to transact at that price. The funds held by the Plan are deemed to be actively traded.

The Plan's valuation methods may result in a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Although Plan management believes the valuation methods are appropriate and consistent with the market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in methodologies used at December 31, 2024 or 2023.

The tables below set forth the Plan's investments by level within the fair value hierarchy. There have been no transfers into or out of Levels 1, 2, or 3.

4. Information Certified by Principal Trust Company

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Trust Company, a qualified institution.

5. Guaranteed Investment Contract

The Plan invests in the Principal Fixed Income Guaranteed Option (PFIGO), a guaranteed investment contract. The PFIGO is a benefit-responsive contract entered into with Principal Life Insurance Company, who maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The PFIGO guarantees the principal and a rate of interest for a period of time.

The PFIGO is valued at contract value for presentation in the Plan's net assets available for benefits. Contract value is the relevant measurement attribute for that portion of the net assets available

for benefits attributable to fully benefit-responsive investment contracts, because contract value is that amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The contract has a 5% surrender fee should the Plan discontinue without proper notification as prescribed in the contract. Currently, Plan management believes that the occurrence of an event that would cause the Plan to transact at less than contract value is not probable.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is a blended rate determined using a dollar-weighted average of all the guaranteed interest rates of the guaranteed interest funds under this contract. Under the terms of the existing contract, the guaranteed minimum crediting interest rate was 1.55% as of December 31, 2024 and 2023, respectively, and can be re-set on a semi-annual basis. The PFIGO is a single group annuity contract with a fixed rate of interest.

6. Related Party Transactions

Investments in certain PSAs, CITs, and a guaranteed investment contract are managed by Principal Life Insurance Company, on behalf of Principal Global Investors Trust Company and Principal Life Insurance Company, the Trustee and contract holder as defined by the Plan. Therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for recordkeeping fees were \$101,630 and \$82,785 in 2024 and 2023, respectively.

7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

8. Income Tax Status

The Company adopted the Principal Financial Group non-standardized pre-approved profit sharing plan document. Principal Financial Group obtained an opinion letter dated June 30, 2020 in which the Internal Revenue Service (IRS) stated that the pre-approved plan document is qualified, and the trust established under the Plan is tax-exempt under the appropriate sections of the IRC. The Plan has been amended subsequent to the IRS ruling. The Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there currently are no audits for any tax periods in progress.
