Opinion

We have audited the financial statements of The Ford Foundation Retiree Welfare Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and of benefit obligations as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits and of changes in benefit obligations for the year ended December 31, 2024, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits and of benefit obligations of the Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits and changes in benefit obligations for the year ended December 31, 2024, in accordance with accounting principles generally accepted in the United States of America.

Basis for opinion

We conducted our audits of the financial statements in accordance with auditing standards generally accepted in the United States of America (US GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of management for the financial statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

NOTE 1 - DESCRIPTION OF PLAN

General

The following description of the plan is for informational purposes. Participants should refer to the plan document for more complete information.

The Ford Foundation (the "Foundation" or "Sponsor") established The Ford Foundation Retiree Welfare Plan (the "Plan") effective January 1, 2009 to provide medical, dental and life benefits covering all eligible retirees of the Foundation. It is a single, written welfare benefit plan subject to the Employee Retirement Income Security Act ("ERISA") of 1974, as amended. The Plan complies with the applicable provisions of the Internal Revenue Code of 1986, as amended ("Code") and with the applicable provisions of ERISA.

Benefits

The Plan provides medical and dental insurance to retirees of the Foundation and their eligible dependents. The Plan also provides life insurance for retirees and pays those benefits to beneficiaries named by the retiree. Current health claims of retired participants and their dependents are provided under group insurance contracts with Aetna. Death benefits are covered by a group-term policy with Standard Life Insurance. For these contracts, the Foundation pays monthly premiums to the service providers.

Eligibility

An eligible participant is a retiree who commenced work on or before May 31, 2009, and (i) who at the time of separation from the Foundation is age 55 or older and has completed a minimum of five years of service, or (ii) who is offered and signs a separation agreement which provides for participation in the Plan. In addition, an eligible participant includes a retiree, for the purposes of medical and dental benefits only, who commenced work after May 31, 2009 and on or before December 31, 2012, and (i) who at the time of separation from the Foundation is age 65 or older and has completed a minimum of 10 years of service, or (ii) who is offered and signs a separation agreement which provides for participation in the Plan. No employee hired on or after January 1, 2013 shall be considered a retiree under the Plan. Service is defined as a continuous period of full time employment, as determined by the Foundation.

Funding

The Plan is funded by the Foundation through a VEBA Trust, which is a Voluntary Employees' Beneficiary Association, established by the Foundation exclusively for the Plan. The trustee and custodian of the VEBA Trust was Vanguard Fiduciary Trust Co. On December 11, 2024, the Plan changed its trustee and custodian of the VEBA Trust to U.S. Bank National Association ("Trustee").

Funding is determined by the Foundation at its sole discretion. All Foundation contributions under the Plan are paid to the insurance companies and are used exclusively for the purchase of insurance to provide benefits under the Plan.

Termination of the Plan

The Foundation has established this Plan with the intention and expectation that it will be continued for an indefinite period of time. Notwithstanding, the Foundation reserves the right to amend, modify, revoke or terminate the Plan, in whole or in part, at any time. The authority to make any such changes rests with the Foundation's President or their designee, although the Plan Administrator may also change the Plan as required by law or in a manner which will not result in a material cost.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan's financial statements are prepared on the accrual basis of accounting, which is in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosures of contingent assets benefit obligations and liabilities. These estimates primarily include fair value of investments and the benefit obligation. Actual results could differ from those estimates.

Valuation of Investments

The Plan's investments in the VEBA Trust are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The investments in the VEBA Trust consist of both equity and fixed income mutual funds.

Investment income consists of dividends and net appreciation (net depreciation) in the fair value of investments. Dividends are recorded on the ex-dividend date. Net depreciation includes gains and losses on investments bought and sold as well as held during the year.

Postretirement Benefits

The postretirement benefit obligation represents the actuarial present value of those estimated future benefits that are attributed to employee service rendered to December 31. Postretirement benefits include future insurance premiums to be paid to or for (1) currently retired employees and dependents and (2) active employees and their dependents after retirement from service with the Sponsor. Prior to an active employee's full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributed to that employee's service rendered to the valuation date.

The actuarial present value of the expected postretirement benefit obligation is determined by an actuary and is the amount that results from applying actuarial assumptions to historical claims-cost data to estimate future annual insurance premiums per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

For measurement purposes at December 31, 2024, the medical cost trend rate was assumed to be 6.60% for 2025, decreasing gradually over the next 51 years to an ultimate rate of 4.04% for 2076 and thereafter. As of December 31, 2023, the medical cost trend rate was assumed to be 6.75% for 2024, decreasing gradually over the next 52 years to an ultimate rate of 4.04% for 2076 and thereafter. As of December 31, 2024 and 2023, the dental cost trend rate was assumed to increase by 3% per year.

The foregoing assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the postretirement benefit obligation.

Administrative Expenses

Expenses incurred are paid by the Plan. The Foundation has the option, but not the obligation, to pay any such expenses, in whole or in part, and by so doing, to relieve the Plan from the obligation of bearing such expenses.

Premium Payments

Premiums paid by either the Foundation or the VEBA trust are recorded as insurance premiums in the accompanying statement of changes in net assets available for benefits.

Experience-Rated Contracts

The Plan has an experience-rated contract which is subject to experience-rating adjustments. Experience ratings (calculated as the difference between premiums paid and the total of claims paid and fees charged by the insurance company) are determined by the insurance company in the following year and may result in a premium surplus or deficit. The Foundation uses premium surpluses to reduce premiums paid in the statement of changes in net asset available for benefits.

NOTE 3 - BENEFIT OBLIGATIONS

Health costs incurred by participants and dependents are covered by insurance contracts maintained by the Plan. It is the present intention of the Sponsor and the Plan to continue obtaining insurance coverage for benefits.

The health care cost-trend rate assumption has a significant effect on the amounts reported. If the assumed rates increased by 1%, that would increase the obligation as of December 31, 2024 and 2023 by \$10,933,469 and \$12,377,845, respectively. The Plan's deficiency of net assets over benefit obligations at December 31, 2024 and 2023 relates primarily to the postretirement benefit obligation, the funding of which is not covered by the contribution rate. It is expected that the deficiency will be funded through future increases in the contribution rate.

The Medicare Prescription Drug Improvement and Modernization Act of 2003 provides federal subsidies for certain prescription drug programs. The accumulated post-retirement benefit obligation ("APBO") does not reflect any amount associated with the Medicare Part D subsidy as the Plan is not directly entitled to such benefit. The Plan has estimated this amount to be \$1,874,437 and \$2,785,123 at December 31, 2024 and 2023, respectively. The statements of benefit obligations and the statement of changes in benefit obligations have been presented excluding the effects of the Medicare Part D Subsidy in accordance with

NOTE 4 - INCOME TAXES

The VEBA Trust, established under the Plan to hold the Plan's assets, is intended to qualify pursuant to Section 501(c)(9) of the Code and, accordingly, the Trust's net investment income is exempt from income taxes. The Trust has obtained a favorable tax determination letter from the Internal Revenue Service ("IRS") dated January 25, 2011.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 5 - PARTY-IN-INTEREST TRANSACTIONS

The Plan investments are held in a VEBA Trust. Prior to December 12, 2024 the Plan investments were managed by Vanguard Fiduciary Trust Co. and its investment agent, VIAS. The Plan investments are managed by U.S. Bank National Association. These transactions qualify as party-in-interest transactions.

NOTE 6 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible

that changes in these estimates and assumptions in the near term would be material to the financial statements.

NOTE 7 - FAIR VALUE MEASUREMENTS OF INVESTMENTS

U.S. GAAP established a fair value hierarchy for inputs used in measuring fair value that requires that the most observable inputs be used when available. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The fair value hierarchy is categorized into three levels based on the inputs as follows:

- Level 1 - Quoted prices in active markets for identical assets that the Plan has the ability to access at the measurement date;
- Level 2 - Inputs (other than quoted prices included within Level 1) that are observable for the asset, either directly or indirectly; and
- Level 3 - The unobservable inputs for the asset. Unobservable inputs are those that reflect the Plan's own assumptions about the assumptions that the market participants would use in pricing the asset developed based on the best information available in the circumstances.

Market participant assumptions include assumptions about risk and/or the risk inherent in the inputs to the valuation technique. The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level at any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The categorization of an investment within the fair value hierarchy is based upon the pricing transparency of the investment and does not necessarily correspond to the Plan Administrator's perceived risk of that investment.

Following is a description of the valuation methodology used for assets measured at fair value. There has been no changes in the methodology at December 31, 2024 and 2023.

Mutual Funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the report date.
