**NOTE 1 - DESCRIPTION OF THE PLAN**

The following brief description of the Lowenstein Sandler Profit Sharing Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

**General**

The Lowenstein Sandler Profit Sharing Plan, a defined contribution plan sponsored by Lowenstein Sandler LLP (the “Sponsor”), was established effective January 1, 1996. The Plan covers partners, certain of counsel/senior counsel, department leaders (CXOs), and all eligible Roseland (NJ) Business Service Group employees, Law Clerks and Legal Assistants. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan's recordkeeper and trustee is Vanguard Fiduciary Trust Company (“Vanguard”).

Effective November 15, 2023, the Plan was amended to accept surplus assets from one or more of the Sponsor's terminated defined benefit plans in order to provide for disposition of such transferred surplus assets in accordance with section 4980(d) of the Internal Revenue Code of 1986. The amounts transferred are held in a suspension account and used to offset any profit sharing contributions. The Lowenstein Sandler Retirement Shares Plan and the Lowenstein Sandler 2016 Retirement Shares Plan were terminated in 2024 and the surplus assets of \$452,546 were transferred to the Plan's suspension account. The surplus assets transferred plus earnings of \$7,543 were used to reduce employer contributions recorded in the statement of changes in net assets available for benefits.

**Eligibility and Vesting**

Eligible employees who are partners or CXOs shall enter the Plan as of the January 1<sup>st</sup> coinciding with or next following the date that he or she becomes a partner or CXO. All other eligible employees shall enter the Plan as of the later of January 1, 2016, or the date on which they are first credited with an hour of service. Eligible employees shall not receive a contribution for a given Plan year unless they work at least 1,000 hours in that Plan year and are employed as an eligible employee or on a recognized absence on the last day of the Plan year, except as defined. In addition, the Plan contains a requirement that participants must attain the age of 18 to be eligible. A participant's vested interest in the profit sharing account is based on the participant's vesting years. A vesting year is a calendar year in which the participant is credited with at least 1,000 hours of service.

Participants become fully vested on their normal retirement date, provided they are employed on or after that date, or in the event that their employment is terminated by death or total and permanent disability, as defined.

**Contributions**

Contributions for partners, of counsel/senior counsel, and CXOs are limited to 50% of the difference between the maximum amount allowed under the Internal Revenue Code, and the amounts that may be contributed by them to other defined contribution plans of the Sponsor. Partners who become participants on or after January 1, 2013 are deemed to have waived 50% of any Profit Sharing contributions to which they would otherwise be entitled for a Plan Year if they have not attained age 40 on or before the last day of that Plan Year. Prior to January 1, 2013 partners, of counsel/senior counsel and CXOs were permitted to make a one-time irrevocable election to waive their participation in the Plan either partially or fully. No such election is permitted to be made on or after January 1, 2013. Contributions to the Plan for all others will be equal to 5% or 7.5% of the employee's covered compensation, depending upon the number of vesting years the employee has been credited with since date of hire, as defined. Employee contributions to the Plan are not permitted.

**Participant Accounts**

A separate account is established and maintained under the Plan for each participant, and participants direct contributions to the investment options offered by the Plan. A participant's account may be credited with an allocation of the Sponsor's contribution and the proportionate share of dividends, interest and investment gains. A participant's account may be reduced by distributions, forfeitures, and an allocation of investment losses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Payment of Benefits**

Upon termination of service, a participant may receive a lump sum distribution or rollover into a qualified plan, or combination thereof, in the amount of the participant's vested account balance. If the participant's vested account balance is less than \$1,000 and the participant does not request a distribution, then the participant's account will be distributed automatically in the form of a lump sum payment as soon as practical. During 2022, additional distribution options (i.e., partial withdrawals and installment payments) were added for terminated participants. In addition, Vanguard's Auto Rollover feature was adopted, which allows for the vested account balances of terminated participants which are greater than \$1,000, but less than \$5,000, to be automatically rolled over to a Vanguard IRA if no other election is made by the participant within 90 days of termination. The limit was increased to \$7,000 effective January 1, 2024 as permitted by the SECURE 2.0 Act. Participants who reach the age of 72 (age 73 if the account owner was born in 1951 or later) and are no longer active employees are subject to the Internal Revenue Service ("IRS") minimum distribution rules.

**Forfeitures**

Forfeited nonvested accounts may be used to reduce future Sponsor contributions. Forfeitures of \$36,884 were used to reduce the Sponsor's contribution receivable to \$3,407,402, as shown on the statements of net assets available for benefits as of December 31, 2024. Forfeitures available as of December 31, 2024 and 2023 were \$116,660 and \$148, respectively.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

The following are the significant accounting policies followed by the Plan:

**Basis of Accounting**

The accompanying financial statements are prepared on the accrual basis of accounting.

**Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Committee determines the Plan's valuation policies utilizing information provided by the Plan custodian and Plan management. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's realized gains and losses on investments bought and sold as well as unrealized gains and losses on assets held during the year. In addition, certain investment related expenses have been offset by investment income.

**Payment of Benefits**

Benefit payments to participants are recorded when paid.

**Administrative Expenses**

The Plan permits the payment of administrative expenses to be made from the Plan's assets. However, substantially all of the administrative expenses of the Plan are paid by the Sponsor without charge to the Plan and are excluded from these financial statements. Certain expenses relating to specific participant transactions are charged directly against the appropriate participant's account and are included in Administrative Expenses on the statement of changes in net assets available for benefits. Certain administrative functions are performed by employees of the Sponsor. No such employee receives compensation from the Plan.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets, liabilities and changes therein and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

**NOTE 3 - INFORMATION CERTIFIED BY THE TRUSTEE**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, Vanguard Fiduciary Trust Company, the trustee of the Plan has certified to the completeness and accuracy of all investments and related investment activity and notes receivable from participants and related activity in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024 and the accompanying supplemental schedule of assets (held at end of year) as of December 31, 2024.

**NOTE 4 - FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1    Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2    Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability

Level 3    Unobservable inputs that are supported by little or no market activity and that are financial instruments whose values are determined using pricing models, discounted cash flow methodologies, or similar techniques, as well as instruments for which the determination of fair value requires significant judgment or estimation.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Mutual funds:** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Collective Trusts:**

- **Columbia Trust Dividend Income Fund:** The Plan's investment in the Columbia Trust Dividend Income Fund Collective Investment Trust is stated at fair value, in accordance with FASB Accounting Standards Codification 820, Fair Value Measurement. The fair value is determined based on the underlying investments held within the CIT, which primarily consist of dividend-paying equity securities. The plan's interest in the CIT is represented by investment units, and the valuation is based on the Net Asset Value (NAV) per share provided by the administrator of the collective trust. The NAV represents the fair value of the underlying investments held by the fund, less its liabilities, divided by the number of shares outstanding. Valuation adjustments may be made to reflect changes in the operating results, financial condition, or prospects of the underlying portfolio companies. The investment in the Columbia Trust Dividend Income Fund is measured at fair value using the NAV per share as a practical expedient and, as such, has not been categorized within the fair value hierarchy. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer requires at least 3 business days notice, in order to ensure that securities liquidations will be carried out in an orderly business manner. For cases other than full redemption, units can be redeemed on any business day.
- **Harbor Capital Appreciation Collective Investment Trust:** Valued at the NAV of units of a collective investment trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the Plan will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a withdrawal in excess of 20% of investment in Fund, the Trustee requires at least 15 days written notice, in order to ensure that securities liquidations will be carried out in an orderly business manner.
- **MFS Mid Cap Value Fund:** The Plan's investment in the MFS Mid Cap Value Fund Collective Investment Trust is stated at fair value, in accordance with FASB Accounting Standards Codification 820, Fair Value Measurement. The fair value is determined based on the underlying investments held within the CIT, which primarily consist of equity securities of companies with medium market capitalizations that the fund manager believes are undervalued. The plan's interest in the CIT is represented by investment units, and the valuation is based on the Net Asset Value (NAV) per share provided by the administrator of the collective trust. The NAV represents the fair value of the

underlying investments held by the fund, less its liabilities, divided by the number of shares outstanding. Valuation adjustments may be made to reflect changes in the operating results, financial condition, or prospects of the underlying portfolio companies. The investment in the MFS Mid Cap Value Fund is measured at fair value using the NAV per share as a practical expedient and, as such, has not been categorized within the fair value hierarchy. Participant transactions (purchases and sales) may occur daily. If the plan initiates a redemption exceeding \$1,000,000, the issuer requires at least 5 business days written notice, in order to ensure that securities liquidations will be carried out in an orderly business manner.

- ***Putnam Stable Value Fund:*** A stable value fund that is composed primarily of fully benefit-responsive investment contracts and that is valued at the net asset value of units of the bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer requires at least 60 days written notice and reserves the right to delay payment for 12 months, in order to ensure that securities liquidations will be carried out in an orderly business manner.
- ***Vanguard Target date collective trust funds:*** Target date trust funds that invest in other Vanguard mutual funds and trusts according to an asset allocation strategy designed for participants planning to retire and leave the workforce in or within a few years of the stated target year. The trust's asset allocation will become more conservative over time; and, within seven years after the target year, the trust's asset allocation should resemble that of the Vanguard Target Retirement Income Trust II. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust funds, the Trustee will use its best efforts to distribute proceeds as soon as practicable.

***Self-directed brokerage accounts:*** Accounts consist of mutual funds, exchange traded funds and money market funds that are valued on the basis of readily determinable market prices.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Changes in Fair Value Levels**

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another.

**NOTE 5 - RELATED PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS**

Certain plan investments are shares of mutual funds and collective trust funds managed by an affiliate of Vanguard. Vanguard is the trustee of the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to Vanguard for administrative services amounted to \$500 for the year ended December 31, 2024. Expense ratios paid by the Plan for the operating expenses and investment management services of the funds are included in net appreciation in fair value of investments. The Plan Sponsor pays directly any other fees related to the Plan's operations.

**NOTE 6 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Sponsor has the right to terminate the Plan subject to the provisions of ERISA and the terms of the Plan. In the event of Plan termination, participants would become 100% vested in their employer contributions. The Sponsor determines the date and manner in which participants' accounts will be distributed in accordance with ERISA.

**NOTE 7 - TAX STATUS**

The plan was restated effective January 1, 2022, and the IRS informed Vanguard by an opinion letter dated June 30, 2020, that the form of the non-standardized pre-approved profit sharing plan with CODA adopted by the Sponsor, is acceptable under the applicable sections of the IRC. The Plan has been amended since the restatement date, however, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and therefore believes that the Plan is qualified and the related trust is tax exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a government authority. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require adjustment to or disclosure in the financial statements. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

**NOTE 8 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Volatility in the financial markets may significantly impact the subsequent valuation of the Plan's investments. Accordingly, the valuation of investments at December 31, 2024 may not necessarily be indicative of amounts that could be realized in a current market exchange.

**NOTE 9 - MUTUAL FUND FEES**

Certain investments in mutual funds are subject to sales charges in the form of front-end loads, back-end loads or 12b-1 fees. 12b-1 fees are ongoing fees allowable under Section 12b-1 of the Investment Company Act of 1940. These annual fees are used to pay for marketing and distribution costs of the funds. These fees are deducted prior to the allocation of the Plan's investment earnings activity, and thus not separately identifiable as an expense.

**NOTE 10 - SUBSEQUENT EVENTS**

Subsequent events have been evaluated through September 4, 2025, which is the date the financial statements were available to be issued.
