Opinion

We have audited the financial statements of The Ford Foundation Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of the Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for opinion

We conducted our audits of the financial statements in accordance with auditing standards generally accepted in the United States of America (US GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of management for the financial statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in

conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's responsibilities for the audit of the financial statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with US GAAS will always detect a material misstatement when it exists. NOTE 1 - DESCRIPTION OF PLAN

The following description of the plan provides only general information. Participants should refer to the plan document for more complete information of the plan's provisions.

General

As of December 31, 1992, the Ford Foundation (the "Foundation") Thrift Plan, a defined contribution plan consisting of employee contributions and employer matching contributions, was merged into The Ford Foundation Retirement Plan, a defined contribution plan consisting primarily of employer contributions. The plan resulting from the merger was amended to move the employer matching contribution feature out of the old Thrift Plan into Ford Foundation's 403(b) Savings Plan. Thereafter, the merged plan was restated in its entirety as The Ford Foundation Retirement Plan (the "Plan"), effective January 1, 1993. The Plan is a defined contribution plan covering all eligible employees. The Plan is subject to the Employee Retirement Income Security Act of 1974, as amended. Effective November 2, 2011, any newly hired employee will not be eligible to become a participant of the Plan.

The Plan is comprised of two components: (i) the Thrift Component, representing assets from the old Thrift Plan; and (ii) the Basic Benefit Component, representing the Retirement Plan. Eligible employees age 25 or older were able to participate in the Retirement Plan beginning the first of the month following hire by the Foundation. Eligible employees younger than age 25 when hired by the Foundation became eligible to participate in the Retirement Plan after they completed two years of service, as defined in the Plan, or attained age 25. Eligible employees who did not attain age 25 by December 31, 2011 automatically became participants on January 1, 2012.

The Plan assets in the Thrift Component of the Plan are invested at Fidelity Management Trust Company ("Fidelity") at the direction of the participant among different investment options available in the Plan.

The Basic Benefit Component of the Plan consists entirely of individual annuity contracts purchased by the Plan on the participant's behalf from Teacher's Insurance and Annuity Association ("TIAA") and the College Retirement Equities Fund ("CREF") (together, "TIAA" and "CREF") for each participant. TIAA and CREF, a regulated insurance company, is obligated to make payments to participants and/or beneficiaries in accordance with the terms of the Plan and annuity contracts. Participants have the option to direct contributions and the balances accumulated in their accounts in TIAA and CREF investments and may elect to choose between a guaranteed annuity contract or a pooled separate account, or among several variable annuities offered by CREF, which are registered investment company funds, or a pooled separate account.

Administration

The Plan is administered by a committee of The Ford Foundation appointed by the President of the Foundation. The Plan uses a fee leveling approach where all participants in the plan pay the exact same asset-based fee for recordkeeping. Fidelity Management Research and Trust Companies are the investment manager and Trustee of the assets of the Thrift Component of the Plan. TIAA and CREF is the custodian for the Basic Benefit Component of the Plan. The administrative expenses of the Basic Benefit Component are included as an expense within the individual annuity contracts and are a component of the individual fund performance calculations.

Contributions

For active employees hired before November 2, 2011, the Foundation makes monthly contributions to the Basic Benefit Component of the Plan based upon the following formula:

<u>Age</u>	<u>Percentage of Compensation</u>
Under 32	4%
32 through 34	7%
35 through 39	10%
40 through 44	14%
45 or older	17%

Participants may also make voluntary after-tax plan contributions. The cumulative amount of contributions under the Basic Benefit Component of the Plan must comply with Internal Revenue Service ("IRS") regulations, as amended.

Participant Accounts

Each participant's account is credited with the participant's contributions and Foundation's contributions, as well as allocations of the Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participants in the Basic Benefit Component of the Plan are at all times 100% vested in their employer contribution accounts.

Notes Receivable from Participants

Under the Thrift Component of the Plan, participants may generally borrow up to 50% of their vested benefit, to a maximum of \$50,000. Participants may have no more than two loans outstanding at any time. Loans made to participants have a term of not more than five years. Loans are secured by the participant's account balance, and are repaid biweekly through automatic payroll deductions. Loans bear interest at the prime rate, as published in the Wall Street Journal on the first day of the month prior to the date in which the loan was issued.

Benefit Payments

The Plan provides for benefit distributions (either as an annuity for the Basic Benefit Component only, installment or lump sum) to plan participants or the beneficiaries of their accounts upon the participants' termination of employment, retirement or death.

Participants may elect to receive payment of the Basic Benefit or Thrift Benefit at any time after terminating employment with the Foundation. Effective January 1, 2020, the minimum required distribution age was increased from 70½ to 72 in accordance with Setting Every Community up for Retirement Enhancement Act ("SECURE Act"). Payment of the Basic Benefit and Thrift Benefits will commence no later than April 1st of the calendar year following the later of (i) the calendar year in which the participant reaches age 72, or (ii) the calendar year in which the participant terminates employment with the Foundation. Under certain circumstances, participants may withdraw an amount equal to all or part of their contributions from the Thrift Component no more than every six months while still employed.

All distributions from the Plan will be made in accordance with the Plan document.

Hardship Withdrawals

Hardship withdrawals are permitted under the Thrift Component of the Plan but not under the Basic Benefit Component of the Plan. Participants are able to withdraw from their vested account if they have a financial hardship. Hardship withdrawals are permitted to pay for medical expenses, college tuition, certain funeral expenses, the purchase of primary home, repair of damage to a principal residence or to stop eviction or foreclosure.

Termination of the Plan

According to the Plan document, the Board of Trustees of the Foundation reserves the right to amend or terminate the Plan at any time. However, no plan amendment or termination may return to the Foundation any part of the principal or income in the Plan or divert any part of such principal or income for purposes other than those specified in the Plan. No amendments shall adversely affect the rights of any participant with respect to contributions made by or on behalf of such participant. In the event of the termination of the Plan, the rights of participants to the net assets of the Plan become fully vested and payment of benefits to participants shall be made as specified in the Plan.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Method of Accounting

The Plan's financial statements are prepared on the accrual basis of accounting, which is in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosures of contingent assets and liabilities. These estimates primarily include fair value of investments. Actual results could differ from those estimates.

Valuation of Investments and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 7 for a discussion of fair value measurement.

Purchases and sales of securities are recorded as of the trade date. Interest income is recorded on the accrual basis and dividend income is recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investment earnings are automatically reinvested.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. As of December 31, 2024 and 2023, there were no outstanding loans.

Benefits

Benefits are recorded when paid.

Administrative Expenses (Other Income)

Expenses incurred by the Plan are currently paid by the Plan and reported as Administrative Expenses on the Financial Statements. Fees related to the administration of the Employee Loans receivables are charged directly to the Participants' accounts and included in administrative expenses. Investments related expenses are included in the net appreciation of the fair value of the investments.

NOTE 3 - FEDERAL INCOME TAX STATUS

The IRS has determined and informed the Foundation, by a letter dated March 16, 2018, that the Plan documents comply with Sections 401 and 501 of the Internal Revenue Code and, therefore, the Plan is not subject to income tax under present income tax law. Although the Plan has been amended since receiving the determination letter, the Plan administrator and management believe the Plan is currently designed and being operated in conformity with the Plan documents and is not aware of any course of action or series of events that have occurred that might adversely affect the Plan's tax status. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 4 - PARTY-IN-INTEREST TRANSACTIONS

Certain plan investments are shares of mutual funds managed by Fidelity. Fidelity is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. TIAA and CREF is the custodian and holds certain investments purchased by the Plan on the participants' behalf. Fees for TIAA and CREF are netted against the fund performance calculations; therefore, these transactions qualify as party-in-interest transactions.

NOTE 5 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 6 - TIAA TRADITIONAL ANNUITY

The TIAA Traditional Annuity is a guaranteed fixed annuity contract available as an investment option to Plan participants. Each contract is fully and unconditionally guaranteed by TIAA. The Traditional Annuity is offered through a variety of contract types, including Retirement Annuities ("RA"). The RA is not considered fully-benefit responsive; however, it is reported at contract value, which approximates fair value. The type of contract through which a participant invests in the TIAA Traditional Annuity determines the applicability of certain account features, such as the guaranteed minimum interest rate, additional interest declarations, the degree of liquidity of the participant's account, and the options for receiving income upon retirement.

When participants choose to allocate a portion of their retirement savings to the TIAA Traditional Annuity during the accumulation phase of the contract, their contributions purchase a specific amount of lifetime income based on the contractual rate schedule in effect at the time the premium is paid. The participant's principal, plus a specified minimum rate of interest, are guaranteed by TIAA's claims-paying ability. The TIAA Traditional Annuity also provides the potential for additional interest if declared by TIAA's Board of Trustees. Additional interest, when declared, remains in effect for the declaration year, which begins each March 1 for accumulating annuities, and January 1 for lifetime payout annuities. Additional interest is not guaranteed for future years. Together, the guaranteed minimum and additional amounts make up the crediting interest rate. For accumulating RA contracts, the crediting interest rates for regular annuities ranged from 4.75% and 6% for the year ended December 31, 2024 and 6.00% and 6.75% for the year ended December 31, 2023, respectively. Crediting interest rates were 5.3% and 5.5% for annuities in the accumulation phase as of December 31, 2024 and 2023, respectively.

The RA contract does not allow lump-sum cash withdrawals and transfers must be spread over 10 annual installments. All other withdrawals and transfers from RA contracts must be spread over 10 annual installments (five annual installments for withdrawals after termination of employment). When a participant's accumulation in the TIAA Traditional Annuity is converted to a lifetime payout annuity, the present value of the stream of payments is equal to the accumulated balance, and the entire amount is recorded as a distribution in the statements of changes in net assets available for benefits.

NOTE 7 - FAIR VALUE MEASUREMENTS OF INVESTMENTS

U.S. GAAP established a fair value hierarchy for inputs used in measuring fair value that requires that the most observable inputs be used when available. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The fair value hierarchy is categorized into three levels based on the inputs as follows:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 - Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Market participant assumptions include assumptions about risk and/or the risk inherent in the inputs to the valuation technique. The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level at any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The categorization of an investment within the fair value hierarchy is based upon the pricing transparency of the investment and does not necessarily correspond to the Plan administrator's perceived risk of that investment.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies at December 31, 2024 and 2023.

- Mutual Funds (registered investment companies) are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- CREF accounts (registered investment companies): The fair value of accumulation units held by the Plan in CREF accounts are valued at quoted market prices at the close of the last business day of the year, and classified as Level 1. Data for net asset values are available daily to plan administrators and client investors on NASDAQ’s website, and provide sufficient corroborative evidence to ascertain the relationship between each fund’s NAV and the values of individual underlying holdings. Underlying holdings are primarily valued using market quotations or prices obtained from independent pricing sources. There are no unfunded commitments from participants in the Plan who invest in these accounts.
- The TIAA Real Estate Account (a pooled separate account): The fair value of the Plan’s interest in the TIAA Real Estate Account is based on the fund’s daily NAV. The investment is classified within Level 2 of the fair value hierarchy. The unit value of the fund is calculated daily and available to plan administrators and client investors on NASDAQ’s website. Underlying holdings are primarily valued using independent appraisals or independent pricing sources. Although the underlying assets of the fund cannot be quickly sold and converted to liquid assets, the TIAA general account provides the fund with a liquidity guarantee whereby TIAA ensures that the fund has funds available to meet participant redemption, transfer or cash withdrawal requests. Although this interest has a readily determinable fair value, management has classified this within Level 2 as a result of the associated redemption provisions. There are no unfunded commitments from participants in the Plan who invest in this account.
- TIAA Traditional Annuity is valued at contract value as determined by the issuer, which approximates fair value. As these investments are contract-based, observable prices for identical or similar investments do not exist and, accordingly, these investments are valued using unobservable inputs (Level 3). The contract value equals the accumulated cash contributions and interest credited to the contract, less any withdrawals. See also Note 6 for discussion of the TIAA Traditional Annuity. Contract value is deemed to approximate fair value for RA contracts based on observation of recent participant investments at contract value and by comparison of historical and current yields of highly rated long-term corporate bonds to historical and current crediting interest rates of the contracts, taking into consideration the liquidity restrictions applicable to the contracts.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies on assumptions to determine the fair value of certain financial investments could result in a different fair value measurement at the reporting date.
