## Independent Auditors' Report

Bill & Melinda Gates Foundation Sharing Retirement Plan:

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Bill & Melinda Gates Foundation Sharing Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### *Opinion*

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with U.S. generally accepted accounting principles.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### *Basis for Opinion*

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.



### *Responsibilities of Management for the Financial Statements*

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. generally accepted accounting principles, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. generally accepted accounting principles.

**(1) Description of Plan**

The following description of the Bill & Melinda Gates Foundation Sharing Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**(a) General**

The Plan is a defined-contribution, profit sharing plan described in Section 401(a) of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan's participating employers (the Employer) include the Gates Foundation (the Foundation), Gates Medical Research Institute and Gates Agricultural Innovations. The Plan covers all employees of the Employer who meet the eligibility requirements. The Plan is considered a single-employer plan for reporting purposes, as the employers maintaining the Plan are members of the same controlled group.

The Retirement Plans Committee (the Committee) administers the Plan and consists of employees appointed by the Chief Executive Officer. Empower Trust Company, LLC (ETC) and Empower Annuity Insurance Company (Empower) are the trustees of the Plan. Empower is the recordkeeper for the Plan.

**(b) Eligibility**

Employees are generally eligible to participate in the Plan as of their hire date.

**(c) Contributions**

Participant contributions are not allowed under the Plan. The Foundation contributes a discretionary percentage of each participant's eligible compensation, subject to limitations under the IRC. The contribution level was 15% of eligible compensation for the years ended December 31, 2024 and 2023.

**(d) Participant Accounts**

Participant accounts are credited with the Foundation's contribution and allocated earnings or losses on investments. Participants may direct the investment of their account and transfer amounts among a variety of investment funds selected by the Committee. Participants may also opt to invest funds through a self-directed brokerage option. If a participant does not make an affirmative investment election, contributions will be invested in a default investment fund determined by the Committee. The default investment fund consists of a service that automatically allocates the account to a combination of the Plan's investment funds and rebalances the account over time. Participant accounts are valued daily based on the value of the assets of the Plan.

**(e) Vesting**

Participants are 100% vested upon entering the Plan.

**(f) Notes Receivable from Participants**

Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their account balance or \$50,000 reduced by the excess, if any, of the highest outstanding loan balance during the previous 12 months ending on the day before the date on which the loan was

made. An employee may have only one loan outstanding from the Plan at any time. The loans are secured by the balance in the participant's account. The interest rate for all new loans is based on the "bank prime rate" plus 1% reported by the U.S. Federal Reserve on the last business day of a calendar month effective for loans made on and after the first business day of the subsequent month. All loans except those to purchase a primary residence must be repaid within 5 years. Loans to purchase a primary residence must be repaid within 15 years, except for pre-existing loans transferred from the Foundation's previous 401(k) plan on January 1, 2010, which allowed for longer loan periods. Principal and interest are paid ratably through semimonthly payroll deductions. As of December 31, 2024, interest rates on outstanding loans ranged from 4.25% to 9.5%, and the loans mature through December 2039.

**(g) Employer Contributions Receivable**

Receivables from employer contributions are stated at net realizable value, and represent contributions that have not yet been remitted to the Plan.

**(h) Payment of Benefits**

Participants may elect to receive a distribution upon termination of service due to death, disability, retirement, or otherwise. The Plan provides for automatic distribution of a terminated participant's account balance of \$5,000 or less. If a terminated participant with an account balance of between \$1,000 and \$5,000 does not make a timely distribution election, his or her account balance will be paid into an Individual Retirement Account in his or her name. In the event of death of a participant, the participant's account is distributed by the Plan to the participant's surviving spouse or designated beneficiary.

Under certain conditions, participants actively employed by the Employer are permitted to withdraw a portion of their account balance due to financial hardship. These in-service distributions are permitted for the following: unreimbursed medical expenses; the purchase of, or to prevent eviction or foreclosure from, the participant's principal residence; postsecondary education tuition; or a federally declared disaster. In addition, actively employed participants who satisfy applicable conditions are permitted to withdraw a portion of their account balance in the event of a qualified disaster; domestic abuse; or a qualified birth or adoption.

**(i) Administrative Expenses**

Administrative expenses include recordkeeping, participant disbursement and loan fees, and other general services to operate the Plan. The Foundation pays recordkeeping expenses on behalf of active employees. Individual plan participants are charged loan and distribution fees, and, for terminated participants, recordkeeping expenses.

**(2) Summary of Significant Accounting Policies**

**(a) Basis of Presentation**

The accompanying financial statements have been prepared on an accrual basis. However, benefits are recorded when paid.

**(b) Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from the estimates made.

**(c) Risk and Uncertainties**

The Plan invests in various financial instruments. Investment securities are exposed to various risks such as interest rate, market, and credit. Due to the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the various risk factors, in the near term, could materially affect participants' account balances and the amounts reported in the financial statements.

**(d) Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value. Purchases and sales of securities are recorded on a trade date basis.

Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments represents the change in net unrealized appreciation from one period to the next and realized gains and losses.

**(e) Fair Value of Financial Instruments**

In accordance with ASC 820-10-55, Fair Value Measurements, fair value is defined as the price that the Plan would receive upon selling an investment in an orderly transaction to an independent buyer in the principal or most advantageous market of the investment. A three-tier hierarchy maximizes the use of observable market data and minimizes the use of unobservable inputs to establish classification of fair value measurements for disclosure purposes. Inputs refer broadly to the assumptions that market participants would use in pricing the asset or liability, including assumptions about risk. Inputs may be observable or unobservable. Observable inputs are inputs that reflect the assumptions market participants would use in pricing the asset or liability developed based on market data obtained from sources independent of the reporting entity. Unobservable inputs are inputs that reflect the reporting entity's own assumptions about the assumptions market participants would use in pricing the asset or liability developed based on the best information available. The three-tier hierarchy of inputs is summarized in the three broad levels listed below.

- Level 1 – quoted prices in active markets for identical investments
- Level 2 – other observable inputs (other than Level 1 prices) such as quoted prices for similar investments, quoted prices in markets that are not active or other inputs that are observable, either directly or indirectly
- Level 3 – inputs that are unobservable and significant to the overall fair value measurement and involve judgment (including the Plan's own assumptions in determining the fair value of investments)

Following is a description of the valuation methodology used for assets measured at fair value:

*Registered investment company funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective trust fund:* Valued at a daily calculated unit value, which is considered by Plan management as readily determinable fair value measurement as the collective trust fund has a published price that investors can obtain at any time. The asset is not traded in an active market or exchange. Galliard Managed Income Fund is composed primarily of fully benefit-responsive investment contracts that is valued at the net asset value of units of the bank collective trust.

*Pooled separate account:* Valued at a daily calculated unit value, which is considered by Plan management as readily determinable fair value measurement as the pooled separate account has a published price that investors can obtain at any time. The asset is not traded in an active market or exchange.

*Self-directed brokerage account:* Securities within the account are based on quoted market prices.

**(f) Notes Receivable from Participants**

Participant loans are classified as notes receivable from participants, which are segregated from plan investments and measured at their unpaid principal balance plus any accrued but unpaid interest.

**(5) Party-in-Interest Transactions**

ETC and Empower are the trustees and Empower is the recordkeeper as defined by the Plan, and therefore, transactions with these entities are considered party-in-interest transactions. Total fees paid by the Plan for the investment management services amounted to \$67,106 and \$51,970 for the years ended December 31, 2024 and 2023, respectively.

**(6) Plan Termination**

Although it has not expressed any intent to do so, the Foundation has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

**(7) Tax Status of the Plan**

The Internal Revenue Service issued a favorable determination letter dated March 23, 2018, which provides that the Plan, as amended and restated effective January 1, 2017, and related trust are designed in accordance with applicable sections of the Internal Revenue Code.

Although the Plan has been amended since the determination letter application was filed, the Committee believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Committee has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**(8) Subsequent Events**

Subsequent events were evaluated through July 25, 2025, the date at which the financial statements were available to be issued.
