(1) Description of Plan

The following description of the At Home Care 403(b) Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

(a) General

The Plan is a defined contribution 403(b) plan established for employees of At Home Care, Inc. (the Company or Plan Sponsor) and its subsidiary, At Home Care Partners, Inc. (AHCP). Eligible plan participants may begin contributing their earnings through traditional 403(b) elections and are eligible for the matching employer contribution when they have completed two years of service (at least 1,000 hours each year). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

During 2023, the Company and AHCP entered into an agreement whereby both are no longer affiliated and Plan assets relating to AHCP's participants were transferred to a new 401(k) plan established by AHCP.

(b) Plan Management

The Plan entered into agreements with NBT Bank (NBT) and Empower Life & Annuity Insurance Company of New York (Empower), whereby NBT and Empower have the discretion and responsibility to (i) select investment alternative categories and specific investment alternatives; (ii) monitor the performance of each such investment alternative; (iii) determine whether the nature, objectives and risk characteristics of each such investment alternative continue to conform to the category under which it is made available under the Plan; and (iv) replace or discontinue each such investment alternative whenever they determine, in their sole discretion, that it is necessary or prudent to do so. Epic Advisors, Inc. serves as record keeper for the Plan.

(c) Contributions

Each year participants may elect to contribute a percentage of their eligible compensation, subject to the maximum dollar amount limit as determined by the Internal Revenue Code (Code) and regulations thereunder. Participants over the age of 50 are eligible to make catch-up contributions. In addition, participants may rollover an eligible rollover distribution from another qualified plan. Participants direct the investment of their contributions into various investment options offered by the Plan.

Notes to Financial Statements

(1) Description of Plan, Continued

(c) Contributions, Continued

The Company provides matching contributions based on the participant's total years of service. For participants who have less than 5 years of service, the Company will match 100% of the participant's elective deferrals up to a maximum of \$1,500. For participants who have more than 5 years of service, the Company will match 100% of the participant's elective deferrals up to a maximum of \$2,000 for non-highly compensated employees and \$1,500 for highly compensated employees.

(d) Participant Accounts

Each participant's account is credited with (a) the employee's contributions, (b) the Company's matching contribution, (c) Plan earnings/losses associated with the participant's account, and (d) administrative expenses primarily related to loan initiation charges and participant activity charges which include benefit processing. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

(e) Administrative Expenses

The Plan permits the payment of Plan expenses to be made from Plan assets. Certain administrative fees associated with asset balances are paid by Plan participants as a reduction of investment income. Administrative expenses primarily related to loan initiation charges and participant activity charges which include benefit processing are paid by Plan participants. The Plan Sponsor pays for certain base fees associated with the administration of the Plan.

(f) Vesting

Participants are immediately vested in their voluntary contributions and Company matching contributions.

(g) Payment of Benefits

On termination of service, a participant may elect to receive either a lump-sum amount equal to the value of the vested balance in their account, or a partial distribution of less than their entire vested balance. If the participant's vested account balance is \$5,000 or less, the balance is distributed in a lump sum payment.

(1) Description of Plan, Continued

(h) Notes Receivable from Participants

Participants may borrow from their account up to a maximum amount that is equal to the lesser of \$50,000 or 50 percent of their account balance. Generally, loan terms range from 1-5 years. If the loan is used to purchase a primary residence, the loan may be repaid over a reasonable period of time that may be longer than 5 years. The loans are secured by the balance in the participant's account and bear interest at rates ranging from 4.25% to 9.25%. Principal and interest is paid ratably through payroll deductions.

(2) Summary of Significant Accounting Policies

(a) Basis of Accounting

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

(b) Use of Estimates

U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements. Estimates also affect the reported amounts of revenue and expenses during the reporting period. Actual results could differ from those estimates.

(c) Investment Valuation and Income Recognition

Investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the custodians and investment advisors. See note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

(d) Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

(e) Payment of Benefits

Benefits are recorded when paid.

(f) Subsequent Events

The Plan has evaluated subsequent events through September 9, 2025, the date the financial statements were available to be issued.

(3) Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

(3) Fair Value Measurements, Continued

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. Mutual funds held by the Plan are deemed to be actively traded.

Pooled separate accounts: Pooled separate accounts are valued at each account's net asset value (NAV) as determined by Empower as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by each fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investments for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily.

(4) Group Annuity Contract with Insurance Company

The Plan maintains a fully benefit-responsive group annuity contract with Talcott Resolution Life Insurance Company (Talcott). Talcott maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Talcott is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by Talcott but may not be less than 3%. The crediting rate is reviewed on a quarterly basis for resetting.

This contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Talcott, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on Talcott's ability to meet its financial obligations. Talcott's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

(4) Group Annuity Contract with Insurance Company, Continued

Certain events might limit the ability of the Plan to transact at contract value with Talcott. Such events include: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with Talcott and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow Talcott to terminate the contract with the Plan and settle at an amount different from contract value. Such events include: (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation or (4) a material amendment to the agreement without the consent of Talcott.

(5) Certified Information

Certain information disclosed in the accompanying financial statements and ERISA-required supplementary schedule, including investments and cash held at December 31, 2024 and 2023, and net appreciation in fair value of investments, and interest and dividends, for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by NBT Bank and Empower Life & Annuity Insurance Company of New York (the custodians of the Plan).

(6) Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will remain 100% vested in their accounts.

(7) Party-in-Interest Transactions

The Plan allows current employees who are participants to receive loans under specific circumstances. As such, transactions between the participants with these loans and the Plan qualify as party-in-interest transactions.

(8) Tax Status

The Plan and trust have been established using a volume submitter plan designed and maintained by the Plan's third-party administrator. The Internal Revenue Service (IRS) has determined and informed the volume submitter sponsor by a letter dated March 31, 2017, that the volume submitter plan and related trust are designed in accordance with applicable sections of the Code. The Plan has been amended since receiving the determination letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations prior to 2021.

(9) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
