**INDEPENDENT AUDITOR'S REPORT**

To the Administrators and Trustees of

**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audit of the accompanying financial statements of Relyance Bank Safe Harbor 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

**Note A – Description of Plan**

The following description of Relyance Bank, (“Company”) Safe Harbor 401(k) Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

**General**

The Plan was established in January 1994 and is a defined contribution plan sponsored by the Company for the benefit of employees of Relyance Bank and Jefferson Bancshares, Inc. covering eligible employees of the Company as of the first entry date following completion of three months of service, obtaining age twenty-one, and who elect to participate. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

**Contributions**

The Plan permits eligible employees through a salary deferral election to have the Company make annual contributions of eligible compensation, not to exceed the dollar limit which is set by law. The Plan offers both traditional and ROTH contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Employee rollover contributions are also permitted. The Company provides a safe harbor matching contribution equal to 100% up to 3% of the employee’s compensation, plus 50% of applicable contributions up to the next 2% of included employee’s compensation. Contributions are subject to certain limitations. Discretionary profit-sharing contributions may also be made from time to time as deemed appropriate and approved by the Company. The Company did not make any discretionary profit-sharing contributions during the years ended December 31, 2024 or 2023.

**Participants Accounts**

Each participant’s self-directed account is credited with the participant’s contribution and the Company’s contribution and plan earnings. Allocations are based on participant earnings or account balances as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Vesting**

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company contributions portion excluding safe harbor matching contributions of their accounts plus earnings thereon is based on six years of continuous service. The safe harbor matching contribution is 100% vested.

**Payment of Benefits**

On termination of service due to death, disability or retirement, a participant may elect to receive an amount equal to the value of the participant’s vested interest in his or her account in either a lump-sum amount, or in annual installments over the lesser of five years or his or her life expectancy. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. The Plan also has an age 59 ½ in-service distribution provision for participants that satisfy certain conditions.

Upon enrollment in the Plan, participants direct the investment of their contributions into various options offered by the Plan.

**Forfeited Accounts**

The amounts of forfeited non-vested accounts may first be used to pay any administrative expenses with any remaining forfeitures allocated to additional discretionary non-elective contributions. Forfeited nonvested accounts were zero in both December 31, 2024 and 2023, respectively.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at rates ranging from 3.25% to 8.50%, which are commensurate with local prevailing rates as determined quarterly by the Plan Administrator. Principal and interest is paid ratably through monthly payroll deductions.

**Note B – Summary of Accounting Policies**

**Basis of Accounting**

The financial statements of the Plan are prepared under the accrual method of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the Plan administrator to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**Payments of Benefits**

Benefits are recorded when paid.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024, and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

**Investment Valuation and Income Recognition**

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Investment Committee determines the Plan's valuation policies. See Note E for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the plan's gains and losses on investments bought and sold as well as held during the year.

**Date of Management's Review of Subsequent Events**

For the year ended December 31, 2024, the Company evaluated subsequent events for potential recognition and disclosure through August 29, 2025, which is the date the financial statements were available to be issued.

**Note C – Tax Status**

On November 14, 2022, the Internal Revenue Service stated that the prototype adopted by the Plan, as then designed, qualifies under Section 401(a) of the Internal Revenue Code (IRC). The Plan has not received a determination letter specific to the Plan itself. The prototype plan has been amended and restated to comply with several recent legislative actions. However, the Plan administrator believes that the Plan was designed and is being operated in compliance with applicable requirements of the IRC.

**Note D – Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments.

**Note E – Fair Value Measurements**

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuations techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs were used only when Level 1 or Level 2 inputs were not available.

*Level 1 Fair Value Measurements*

The fair value of registered investment companies (mutual funds) is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

*Level 2 Fair Value Measurements*

The fair value of the common/collective trust account is based on the beginning of year value of the Plan's interest in the common/collective trust account plus actual contributions and allocated investment income less actual distributions.

*Level 3 Fair Value Measurements*

Closely held common stock – Jefferson Bancshares, Inc. is not actively traded and significant other observable inputs are not available. Thus, the fair value of the closely held common stock – Jefferson Bancshares, Inc. is valued annually by an outside specialist.

**Note F – Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Company may determine.

**Note H – Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**Note I – Related Party Transactions**

Certain Plan investments are shares of mutual funds and a common collective trust managed by Empower Retirement. Empower Retirement is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

Additionally, a portion of the Plan's assets are investments in Jefferson Bancshares, Inc. common stock. As the Company Plan sponsor, transactions involving Jefferson Bancshares, Inc. qualify as party-in-interest transactions. Investments in the bank stock are no longer allowed as an option by the Plan. Participants can hold the stock until they choose to liquidate.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**Note J – Guaranteed Investment Contract with Insurance Company**

In 2020, the Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Great-West Life & Annuity Insurance Company, renamed Empower Annuity Insurance Company of America (“Empower Annuity Insurance”). Empower Annuity Insurance maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract meets the criteria to be considered fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statement of net assets available for benefits at contract value. Contract value, as reported to the Plan by Empower Annuity Insurance, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023, was \$1,573,041 and \$1,722,053, respectively. The crediting interest rate is based on a formula agreed upon with the issuer, but may not be less than 0%. Such interest rates are reviewed on a quarterly basis for resetting. The average yield was 1.41% and 1.23% in 2024 and 2023, respectively.

Certain events limit the Plan's ability to transact at contract value with Empower Annuity Insurance. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.
