## INDEPENDENT AUDITOR'S REPORT

To the Investment Committee of  
Pikeville Medical Center, Inc.:

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of the Retirement Plan for Employees of Pikeville Medical Center, Inc. (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. #### NOTE A--DESCRIPTION OF PLAN

The following description of the Retirement Plan for Employees of Pikeville Medical Center, Inc. (the Plan) provides general information only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

*General:* The Plan is a defined contribution plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Certain employees of Pikeville Medical Center, Inc. (the Plan Sponsor) are eligible to participate in the Plan upon date of hire. Collectively bargained employees, leased employees, student employees, and temporary employees are excluded from participating in the Plan.

*Contributions:* Participants may elect to contribute, through salary reduction, up to 100% of their eligible compensation each Plan year up to the Internal Revenue Service limit. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. For participants who have completed 12 months of eligible service and are 21 years of age, the Plan Sponsor contributes to the Plan a matching contribution equal to 50% of a participant's elected deferral amount up to 10% of the participant's eligible compensation. Participants direct the investment of all contributions into various investment options offered by the Plan.

*Participant Accounts:* Each participant's account is credited with the participant's contributions, the Plan Sponsor's matching contributions, an allocation of Plan earnings and is charged with an allocation of administrative expenses. The benefit to which a participant is entitled is the vested benefit of their account balance.

*Vesting:* Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Plan Sponsor's contribution portion of their account is based on years of continuous service as follows:

*Notes Receivable from Participants:* Participants may borrow from their investment account balances a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at rates between 4.25% and 9.50% at December 31, 2024. The term of a loan is no longer than five years unless the loan is used to purchase a principal residence.

*Payment of Benefits:* Upon termination of service due to disability or retirement, a participant may elect to receive either an annuity, a lump sum amount equal to the value of the participant's vested interest in their account, or annual installments over a period elected by the participant (not exceeding their life expectancy). For termination of service for other reasons, a participant may receive the value of the vested interest in their account as a lump sum distribution.

*Forfeited Accounts:* At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$82,879 and \$47,366, respectively. Forfeitures will be used to reduce future employer contributions or pay Plan expenses. Forfeitures used to reduce employer contributions were \$250,705 during the year ended December 31, 2024.

#### NOTE B--SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

*Basis of Accounting:* The accompanying financial statements are prepared on the accrual basis of accounting.

*Use of Estimates:* The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

*Investment Valuation and Income Recognition:* Shares of registered investment companies are valued at the quoted market values of the shares held by the Plan.

The group annuity contract held by the Plan is reported at contract value. Contract value represents contributions made under the contract plus credited interest, less participant withdrawals and fees.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

*Notes Receivable from Participants:* Notes receivable from participants are stated at their unpaid principal balance plus any accrued interest. Delinquent participant loans are recognized as benefits paid to participants based upon the terms of the Plan agreement.

*Payment of Benefits:* Benefits are recorded when paid. There were no significant amounts allocated to accounts of participants who have elected to withdraw from the Plan but have not been paid as of December 31, 2024.

*Administrative Expenses:* All significant expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from the accompanying financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participants' accounts and are included in administrative expenses. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments.

#### NOTE C--INFORMATION CERTIFIED BY THE CUSTODIAN AND INSURANCE COMPANY

Plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted under such election, the following information was certified by Prudential Bank & Trust, FSB (Prudential Trust), formerly Prudential Trust Company, and Empower Annuity Insurance Company (Empower Insurance), formerly Prudential Insurance Company of America, and was not subjected to any auditing procedures performed by the Plan's independent public accountants:

- The investments and notes receivable from participants as shown in the accompanying Statements of Net Assets Available for Benefits of \$170,937,426 and \$2,749,992, respectively, as of December 31, 2024, and \$148,401,787 and \$3,159,919, respectively, as of December 31, 2023.
- Net appreciation in fair value of investments of \$10,929,932 and interest and dividends of \$9,073,457 as shown in the accompanying Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.
- All investment-related information in the accompanying supplemental Schedule H, Line 4i – Schedule of Assets Held at Year End as of December 31, 2024.

#### NOTE D--GROUP ANNUITY CONTRACT

The Plan has entered into a fully benefit-responsive group annuity contract with Empower Insurance. Empower Insurance maintains the contributions in a general account. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

The Guaranteed Income Fund is a group annuity contract that provides for a fixed interest rate for all deposits regardless of the initial deposit date. The crediting interest rate is based on a specified

index reduced by 1.25%. The minimum guaranteed interest rate will not be less than 1.00% nor greater than 3.00%. Such interest rates are reviewed on a semi-annual basis for resetting. There are not any events that could limit the ability of the Plan to transact at contract value paid within 90 days or contract value paid over time. There are not any events that allow the issuer to terminate the contract, and which require the Plan sponsor to settle at an amount different than contract value paid whether within 90 days or over time.

#### NOTE E--FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy based on valuation inputs. The three levels of the fair value hierarchy are described as follows:

- *Level 1:* Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- *Level 2:* Inputs to the valuation methodology include:
  - Quoted prices for similar assets and liabilities in active markets;
  - Quoted prices for identical or similar assets and liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability; and
  - Inputs that are derived principally from or are corroborated by observable market data by correlation or other means.
- *Level 3:* Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the valuation hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The investment valuation methods described in Note B may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan administrator believes the Plan's valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used at December 31, 2024 and 2023.

#### NOTE F--RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are units of interest in an annuity contract secured by the general assets of Empower Insurance, who is a custodian as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to Empower Insurance totaled \$277,408 for the year ended December 31, 2024.

#### NOTE G--PLAN TERMINATION

Although it has not expressed any intention to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their account balances.

#### NOTE H--INCOME TAX STATUS

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code (IRC). The Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and intends to apply for a determination letter once such a program becomes available. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Generally accepted accounting principles require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### NOTE I--RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate market and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
