1. Description of Plan

The following brief description of the Farrell Distributing Corporation 401(k) Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Summary Plan Description or the current Plan document for a complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of Farrell Distributing Corporation (the "Company" or "Employer,). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Eligibility

All employees, as defined in the Plan, who are at least 21 years of age and have been credited with one year of service are eligible to participate in the Plan on the first day of the quarter immediately following the completion of the eligibility requirements.

Effective January 1, 2024 the Plan was amended to change the minimum age requirement from 21 to 18.

Contributions

Each year, eligible employees may contribute up to 75% of their eligible compensation on a pre-tax or Roth basis, as defined in the Plan, subject to certain Internal Revenue Code ("IRC") limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions (rollovers) from another qualified plan.

The Employer makes a safe harbor non-elective contribution for eligible participants equal to 3% of the participant's eligible compensation. Employer safe harbor contributions made to the Plan amounted to \$571,072 for the year ended December 31, 2024.

In addition to the salary deferrals and safe harbor contributions, the Company may make a discretionary matching contribution (either annually or on a more frequent basis) for each eligible participant resulting in an employer match of 100% of the first 1% of deferred compensation and then 50% of the next 5% for a total maximum match of 3.5% of eligible compensation. The Company may also make a profit sharing contribution that is also at the discretion of management. For the year ended December 31, 2024 there were no Company match or profit sharing contributions.

Participants' Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Employer's contribution and (b) Plan earnings (losses) thereon.

Participants' Accounts (continued)

Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions and Employer safe harbor contributions and actual earnings thereon. Vesting in the Company's contributions is based on years of credited service. Participants vest in the Company's discretionary contributions, if any, based on the schedule below:

A participant becomes 100% vested upon retirement at normal retirement age, death, disability, and termination of the Plan.

Participant Loans

Participant loans are not permitted under the provisions of the Plan.

Forfeitures

When certain terminations of participation in the Plan occur, the non-vested portion of the participant's account as defined by the Plan, represents a forfeiture. The plan document permits the use of forfeitures to either reduce future Employer contributions or Plan administrative expenses for the Plan year. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$604 and \$547. During 2024, no forfeitures were used to reduce Plan administrative expenses or to reduce Employer contributions.

Payment of Benefits

Upon termination of service due to death, disability, retirement or separation from service, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. Withdrawals from the Plan may also be granted based upon circumstances of financial hardship or after attaining age 65, in accordance with provisions specified in the Plan. If the value of a participant's vested interest in their account is \$7,000 or less, the account will be cashed out by distributing the vested interest in a single-sum payment or by direct rollover to an IRA or other eligible retirement plan as soon as reasonably practicable following the date the participant's employment terminates.

Payment of Benefits (continued)

The account will be cashed out even if the participant does not consent to the distribution. If the value of a participant's vested interest in their account is more than \$7,000, distribution of the account cannot be made before the participant's normal retirement date without written consent.

Expenses

Certain expenses of maintaining the Plan are paid by the Company and are excluded from these financial statements. Investment related expenses are paid by the Plan and are included in net appreciation in value of investments.

2. Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Fair Value Measurements

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist. At December 31, 2024 and 2023 all of the Plan's investments that were valued at fair value, were valued using level 1 inputs.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value except for the guaranteed investment contract, which is stated at contract value. The guaranteed investment contract is valued at contract value, which represents contributions, plus earnings, less participant withdrawals and administrative expenses. Mutual funds held by the Plan are valued at fair value based on the daily closing price as reported by the funds. All of the mutual funds are open-ended and are registered with the Securities and Exchange Commission. These mutual funds are required to publish their daily Net Asset Value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Investment Valuation and Income Recognition (continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recognized on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events Evaluation by Management

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is September 3, 2025.

3. Information Certified (Unaudited)

Certain information related to the investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, Schedule H, Part IV, Line 4i-Schedule of Assets (Held at End of Year), including investments held at December 31, 2024 and 2023, and net appreciation in value of investments, and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by T. Rowe Price Trust Company, a qualified institution.

4. Guaranteed Investment Contract

The Plan invests in the Standard Stable Asset Fund II (the "Fund"), a group annuity contract issued and fully guaranteed by Standard Insurance Company (the "Issuer"). The Fund is a stable value investment option that seeks to preserve principal while providing a stable rate of return.

Under the terms of the contract, participant contributions to the Fund are directed into the Issuer's general account, and the Issuer guarantees both principal and accrued interest, regardless of the performance of the underlying investments. The crediting interest rate is set periodically by the Issuer and is based on the performance of the underlying portfolio as well as market conditions. The contract provides for liquidity to meet participant-initiated withdrawals, including transfers, loans, or benefit payments, at contract value.

The Fund is designed to pay all participant-initiated transactions at contract value. However, the Fund imposes certain restrictions on the Plan and reserves the right to defer withdrawal requests initiated by the Plan sponsor (such as plan termination, mergers, or changes in investment options) for up to 12 months.

4. Guaranteed Investment Contract (*continued*)

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

The Fund is recorded at contract value, as this represents the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

The underlying investments of the Fund are not reported separately, as the Issuer is responsible for investment management and guaranteeing contract value.

5. Tax Status

The Plan is based on a Volume Submitter Profit Sharing Plan with Cash or Deferred Arrangement which received an opinion letter from the Internal Revenue Service ("IRS") dated August 19, 2020 stating that the Volume Submitter Profit Sharing Plan was designed in accordance with applicable sections of the IRC.

Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

7. Party-in-Interest

Certain Plan investments are managed by T. Rowe Price Trust Company. T. Rowe Price Trust Company is the trustee of the Plan and, therefore, these transactions qualify as party-in-interest.

Certain employees of the Company, who may be participants in the Plan, perform administrative services to the Plan at no cost to the Plan.
