We have performed an audit of the financial statements of Wright-Pierce Employees Section 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

1. Description of Plan

The following description of the Wright-Pierce Employees Section 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. According to the Plan documents, individual participants direct investment options.

The Plan is a defined contribution plan sponsored by Wright-Pierce (the Company). All employees are eligible for participation in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each participant may contribute a minimum of 1% of eligible compensation as defined by the Plan. The Company may contribute, at its discretion, matching contributions. The Company may also contribute, at its discretion, profit-sharing contributions.

In 2024, the Company contributed a profit-sharing contribution of 4% of eligible compensation and a matching contribution of 50% of the first 5% of a participant's salary deferral to a maximum of 2.5% of eligible compensation.

Contributions are subject to certain limitations.

2. Summary of Significant Accounting Policies

Investments

Investments are recorded at fair value, except for the guaranteed investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Use of Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the plan administrator to make significant estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosures of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Administrative expenses paid by the Plan are primarily fees for third-party record-keeping services, financial statement audit fees, administration fees for notes receivable from participants, and investment advisor fees. The Company pays all other administrative costs.

Subsequent Events

Management has considered transactions or events occurring through August 6, 2025, which is the date the financial statements were available to be issued. Management has not evaluated subsequent events after that date for inclusion in the financial statements.

3. Guaranteed Investment Contract

The Plan is invested in the Voya Fixed Account (the Fixed Account), which maintains the contributions in a general account of Voya Retirement Insurance and Annuity Company (Voya). The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The Fixed Account is considered fully benefit-responsive; therefore, contract value is the relevant measurement to the guaranteed investment contract. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. The contract value of the Fixed Account approximates fair value within an insignificant amount.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 1%. Such interest rates are reviewed on a quarterly basis for resetting. The crediting interest rate was 2.4% percent at December 31, 2024. The average yield earned by the Plan and the weighted average crediting interest rate were approximately 2.4% for 2024.

4. Fair Value Measurement

The fair value measurement accounting literature establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements), and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for the identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Mutual funds are valued using Level 1 inputs and are based on quoted market prices of shares held by the plan at year-end.

Collective trusts are valued at net asset value (NAV) of units held by the Plan at year-end. The NAV is used as a practical expedient to estimate fair value and is excluded from the fair value hierarchy. The NAV is based on the fair value of the underlying investments in the collective trusts.

The Plan began investing in collective trusts during the year ended December 31, 2024. Accordingly, this represents a change in the types of investments held by the Plan, and the related valuation methodology. There were no other changes in valuation methodologies used at December 31, 2024 and 2023.

5. Tax Status

The Internal Revenue Service has determined and informed the plan sponsor, by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the advisory opinion, the plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their employer contributions.

7. Information Prepared and Certified by the Trustee

The investments, investment transactions, net appreciation in fair value of investments, notes receivable from participants and interest and dividends were obtained by management and agreed to or derived from the information certified by Voya, the trustee, as complete and accurate. This information is included in the following:

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

9. Party-in-Interest Transactions

Plan investments include a guaranteed investment contract managed by Voya, the trustee. Accordingly, this transaction qualifies as a party-in-interest. Administrative expenses for the year ended December 31, 2024, include the following: \$56,663 in account management fees paid to Voya; \$37,500 paid to Osaic Wealth, Inc., broker; \$13,504 paid to Ascensus, recordkeeper; and \$9,292 in investment advisor fees. Additionally, notes receivable from participants are also considered party-in-interest transactions.
