
Dear Sir/Madam:

Attached please find the 2024 Form 5500-SF (Short Form Annual Return/Report of Small Employee Benefit Plan) filed with respect to the Engineer.ai Corp U.S. 401(K) Plan (the "Plan"), for the plan year ending December 31, 2024. Engineer.ai Corp U.S., the Plan Sponsor, filed a voluntary petition for relief under Chapter 7 of the United States Bankruptcy Code (the "Bankruptcy Code") on June 2, 2025. The Office of the United States Trustee appointed me to serve as the Chapter 7 trustee in the bankruptcy case (the "Bankruptcy Trustee").

As the Bankruptcy Trustee, and pursuant to section 704(a)(11) of the Bankruptcy Code, I am continuing to perform the obligations required of the administrator of the Plan. Accordingly, I am overseeing the termination and liquidation of the Plan. I have signed the 2024 Form 5500-SF for the plan year ending December 31, 2024, solely in my capacity as the Bankruptcy Trustee. The recordkeeper for the Plan was Principal, which prepared the 2024 Form 5500-SF. As a result of the Plan Sponsor's bankruptcy, and given my limited role as Bankruptcy Trustee, I cannot confirm the accuracy of all the information contained in the 2024 Form 5500-SF (notwithstanding the fact that I have signed the form).
