**Opinion**

We have audited the accompanying financial statements of Wyoming Credit Union Insurance Trust, which comprise the statement of net assets available for benefits and statements of plan benefit obligations as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits and of changes in benefit obligations for the year then ended, and the related notes to the financial statements.

We are required to be independent of Wyoming Credit Union Insurance Trust and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

**Management's Responsibility for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America; this includes the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

**Auditor's Responsibility**

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the

aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of ABC Company Defined Benefit Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about ABC Company Defined Benefit Plan's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### **Supplemental Schedules Required by ERISA**

Our audit was conducted for the purpose of forming an opinion on the financial statements as a whole. The supplemental schedules of assets (held at end of year), referred to as "supplemental information," are presented for the purpose of additional analysis and are not a required part of the financial statements but are supplemental information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under the ERISA. Such information is the responsibility of the Plan's management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedules is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

### 1. DESCRIPTION OF PLAN

The following description of the Wyoming Credit Union Insurance Trust (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan’s provisions. The Plan is sponsored under a Multiple Employer Welfare Agreement (“MEWA”).

#### General

The Plan provides health and other benefits to all eligible employees of participating employers who are members of the Wyoming Credit Union Insurance Association (“Association”) and former employees electing coverage under the Consolidated Omnibus Budget Reconciliation Act of 1985 (“COBRA”) provisions.

Benefits are also provided to dependents of these individuals who elect coverage on their behalf. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) as amended, and the Health Insurance Portability and Accountability Act (“HIPAA”) of 1996, and may be subject to insurance regulations under Wyoming state statutes.

#### Plan Administration

The Plan Sponsor is the Association, which is governed by a Board of Trustees. The assets of the Plan are held in the Wyoming Credit Union Insurance Trust (the “Trust”). The Plan and Trust constitute a Voluntary Employees’ Benefits Association (“VEBA”) under section 501(c)(9) of the Internal Revenue Code of 1986.

Medical and pharmacy claims are processed by Allegiance Benefit Plan Management, Inc. (“Allegiance”), dental claims are processed by Delta Dental of Wyoming (“Delta Dental”) and vision claims are processed by Standard Insurance Company (“Standard”), the third-party administrators.

#### Benefits

The Plan provides health benefits (medical, hospital, surgical, major medical, prescription drug, vision, and dental) to full-time employees of subscribing credit unions with at least 30 hours of service per week and to their beneficiaries and covered dependents. An eligible participant is defined as a person who is hired by a participating employer. The participant must complete the employment waiting period of 30 days.

#### Stop Loss Coverage

The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over \$70,000, as well as its aggregate exposure for all claims).

#### Self-Insured and Fully-Insured Benefit

All health benefits, with the exception of vision benefits, are self-insured. The claims for self-insured benefits are processed by the Plan’s third-party claims processor under administrative

services only (ASO) arrangements. The claims processor pays claims directly to or on behalf of participants and are then reimbursed by the Trust. Despite the Plan's utilization of third-party claim's processors, ultimate responsibility for payments to providers is retained by the Plan. The Plan fully insures the vision benefits. The Association purchases an insurance contract for the insured benefits. Premiums are paid to the insurance company from the Trust.

#### Contribution

Participating employers contribute premiums to the Plan in amounts that are determined by the Board of Trustees and agreed to by the participating employers. Once the premiums are established the plan administrator invoices the participating employers for the employees enrolled in the Plan and the cost share of that premium that could be charged to employees is left to the employer's discretion. Participating employers shall not receive a refund of its contributions or assessed net pro rata reserves in the event the employer elects to withdraw from participation in their agreement. Upon voluntary withdrawal from participation, any incurred but unpaid claims incurred by the members who are employed by that employer will be paid from the Trust.

### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### Basis of Accounting

The accompanying financial statements have been prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

#### Use of Estimate

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations, and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of changes in net assets and benefit obligations during the reporting period. Actual results could differ from those estimates and could be material to the Plan's financial statements. The most significant estimate to the Plan is the estimate of plan benefit obligations.

#### Plan Benefit Obligation

Plan obligations at December 31, 2024 and 2023, consist of claims reported for payment and not paid by year end (claims payable) and for health claims incurred by participants but not reported at that date ("IBNR") and are estimated by the third party administrator based on an analysis of their corporate payment patterns, aggregate stop-loss limits, and the actual claims incurred January 1 through December 31. Amounts due by the Plan will be paid by the Trust. Such estimated amounts are reported in the accompanying statements of plan obligations at present value.

### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

#### Valuation of Investments and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Trustees determine the Plan's valuation policies and procedures. See Note 4 for discussion of fair value measurements. Interest income is recorded as earned on an accrual basis.

#### Rebates

Rebates due from the Plan's pharmacy benefits provider are recorded when earned. Rebates due as of the financial statement date have been reported as a receivable, if any, with the offset being netted against claims paid. Pharmacy rebates totaling \$190,818 for 2024 and \$85,187 for 2023 have been netted with claims paid in the accompanying statement of changes in net assets available for benefits for each year.

#### Third-Party Administrator Fees

Third-party administrator fees are paid by the Plan and are included in administrative expenses on the statements of changes in net assets available for benefits.

#### Payment of Benefits

Claim payments are recorded when paid by the third-party claims processor. Any refunds due to over-payments, subrogation, or adjustments are recorded in the period received.

#### Stop Loss Reimbursement

The third party administrators pay all approved claims incurred by plan participants, which is then reimbursed by the trust. Once a participant reaches the stop loss limit of \$70,000 per participant, the claims paid in excess of \$70,000 are submitted to Companion Life Insurance Company, their stop loss insurance carrier, for reimbursement of the excess claims. Amounts pending reimbursement for claims incurred during the plan are reported as a stop loss receivable in the accompanying financial statements.

#### Income Taxes

The trust established under the Plan is designed to be exempt from federal income taxes under Section 501(c)(9) of the Internal Revenue Code. Accordingly, the financial statements reflect no federal income tax expense. A favorable tax determination letter has been received from the Internal Revenue Service on January 26, 2007. The Trust has since been amended and restated. The appointed Board of Trustees are not aware of any course of action or series of events that have occurred that would adversely affect the qualified status of the Trust.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by applicable taxing authorities. The plan administrator has analyzed the tax

positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there were no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### Subsequent Events

Management has evaluated subsequent events through September 2, 2025, the date which the financial statements were available for issue. There were no events or transactions discovered during the evaluation that require recognition or disclosure in the financial statements.

#### Reclassifications

Certain reclassifications were made to conform to current year presentation.

### 3. FAIR VALUE MEASUREMENTS AND DISCLOSURES

Financial Accounting Standards Board (“FASB”) Accounting Standards Codification Topic 820, Fair Value Measurements and Disclosures, established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels. Level 1 inputs are the highest priority and consist of unadjusted quoted prices in active markets for identical assets and liabilities. Level 2 inputs are inputs for quoted prices for similar assets or liabilities in active markets; inputs for quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from or corroborated by observable market data by correlation or other means. Level 3 inputs are the lowest priority and are unobservable and significant to the fair value measurement of an asset or liability. The asset’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023, although the prior year presentation was changed to confirm to the current year presentation.

**Other Investments:** Consist of certificates of deposit valued at the carrying value as reported by the financial institution and approximates fair value because of the short-term maturity of the certificate and the highly liquid nature of the investments. The other investments are considered to be level 2 investments.

**Cash and Cash Equivalents:** Consist of interest-bearing cash and other liquid short-term investments valued at \$1 per share or unit held by the Plan at year end and are considered to be Level 1 investments.

### 3. FAIR VALUE MEASUREMENTS AND DISCLOSURES (Continued)

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Transfers, if any, are reported at the beginning of the reporting period. For the years ended December 31, 2024 and 2023, there were no transfers between levels 1, 2, or 3.

### 4. BENEFIT OBLIGATIONS

The amount of benefit obligations is reported based on certain assumptions pertaining to estimated claims. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term could be material to the Plan's financial statements.

### 5. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan has an expense cash account established with a subscribing credit union. On a monthly basis an administrative fee is contributed from the participating credit unions and deposited into the expense account to pay administrative expenses not paid on behalf of Allegiance.

The Plan also holds certificates of deposit with five subscribing credit unions. The value of the certificates of deposit at December 31, 2024 and 2023 was \$1,308,603 and \$513,235, respectively.

Certain other expenses are paid to the third-party administrators, auditors, and insurance broker.

These transactions are exempt from the prohibited transaction rules.

### 6. PRIORITIES UPON TERMINATION OF THE PLAN

Although they have not expressed any intent to do so, the plan sponsors have the right to discontinue the Plan at any time subject to the provisions of ERISA. If the Plan is discontinued, Plan assets will first be used to pay liabilities of the Plan and then remaining assets shall be paid as directed by the plan Trustees or the Wyoming Credit Unions until the assets are exhausted. However, if the Plan is discontinued and a liability remains for unpaid plan benefits to participants, such liability shall be paid by the then participating eligible employers and participating employers who terminated within 13 months of Plan termination, pro rata based on the employers' contribution in the 12 month period preceding the termination date.

### 7. CONCENTRATION OF CREDIT RISK

The Plan maintains deposits in cash accounts which may at times exceed federally insured limits of \$250,000 for each credit union. The Plan has not experienced any losses in such accounts. The Plan monitors the strength of the financial institutions with which it does business and believes it is not exposed to any significant concentration risk of its cash balances. As of December 31, 2024 and 2023, the Plan's cash balance exceeded the federally insured amounts.

### 8. DEPOSITS

The amounts included in the caption deposits are prepayment required for prescription claims.

### 9. EMPLOYER ASSESSMENTS

The Plan requires the participating employers maintain an assessment within the Plan. The assessment is adjusted annually and equal to the current year's January premium. If the Plan were to be terminated, these amounts, if not needed for benefit payments, will be returned to the participating employer.


