INDEPENDENT AUDITORS' REPORT

To the Plan Administrator, Participants and Beneficiaries of the
CSU 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 (in Liquidation) Financial Statements

We have performed audits of the financial statements of CSU 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of November 5, 2024 (in Liquidation) and December 31, 2023 (Ongoing) and the related statement of changes in net assets available for benefits for the final period January 1, 2024 through November 5, 2024 (in Liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of November 5, 2024 and December 31, 2023, and for the final period January 1, 2024 through November 5, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion on the 2024 (in Liquidation) Financial Statements

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the 2024 (in Liquidation) Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion on the 2024 (in Liquidation) Financial Statements

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the 2024 (in Liquidation) Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Plan termination and Liquidation Basis of Accounting

As further discussed in Note A to the financial statements, the governing body of the Plan approved a plan of liquidation on April 19, 2024, and management determined liquidation is imminent. As a result, the Plan has changed its basis of accounting to the liquidation basis in presenting the 2024 financial statements. As of April 19, 2024, all participants became fully vested. The Plan Sponsor distributed all Plan assets as of November 5, 2024. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the 2024 (in Liquidation) Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the 2024 (in Liquidation) Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) audit for the 2024 (in Liquidation) Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.



In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. NOTE A - DESCRIPTION OF THE PLAN

The following description of the CSU 401(k) Plan (the "Plan") that was established March 27, 2023, provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

[1] General:

Pursuant to a resolution executed on April 19, 2024, the Plan was terminated and all employee contributions ceased and Plan participants became fully vested. The Plan distributed all Plan assets by November 5, 2024.

The Plan was a defined contribution plan, which, prior to termination, covered all full-time employees of CareerStaff Unlimited, LLC (the "Company") who had completed two months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

[2] Contributions:

Participants may have contributed an amount equal to a dollar amount or percentage of annual compensations, as defined by the Plan. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. In no event could a participants' pre-tax contributions exceed any statutory limitations. Participants may also have contributed amounts representing distributions from other qualified defined benefit or contribution plans.

The Company may have made a discretionary matching contribution for which participants were required to be employed as on last day of the plan year. Additional discretionary non-elective contributions could also have been made at the option of the Company. To be eligible for discretionary non-elective contributions, a participant must have worked 1,000 hours in the given Plan year and be employed on the last day of the Plan year. The Company did not make any discretionary matching contribution or discretionary non-elective contributions in 2024 or 2023. Participants directed the participant and employer contributions into various investment options offered by the Plan.

[3] Participant accounts:

Each participant's account was credited with the participant's contribution and allocations of (a) the Company's contributions, (b) Plan earnings (losses), and could have been charged with an allocation of administrative expenses paid by the Plan. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

[4] Vesting:

Participants were immediately vested in their contributions, plus actual earnings thereon. Effective April 19, 2024, vesting in the Company's matching and discretionary non-elective contribution portion of their accounts, plus actual earnings thereon became 100% vested.

Prior to April 19, 2024, vesting in the Company's matching and discretionary non-elective contribution portion of their accounts, plus actual earnings thereon, was as follows:

[5] Notes receivable from participants:

Notes receivable from participants were measured at their unpaid principal balance, plus any accrued but unpaid interest. Participants could have borrowed from their accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms ranged from one to five years; however, terms could have exceeded five years for the purchase of a primary residence. The loans were secured by the balance in the participant's account and bore interest at a rate of prime plus 1%. Interest rates on the December 31, 2023 outstanding loan balances ranged from 3.25% to 9.5%. Principal and interest were paid ratably through payroll deductions. Delinquent notes receivable from participants were reclassified as distributions based upon the terms of the Plan document. Related fees were recorded as administrative expenses and were expensed when they were incurred.

[6] Payment of benefits:

On termination of service due to death, disability, or retirement, a participant may have elected to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or installments over a fixed reasonable period of time. In-service and hardship distributions were allowed by the Plan if the participant met certain criteria, as defined by the Plan document.

[7] Forfeitures:

Forfeited nonvested accounts may have been used to reduce future Company contributions and pay Plan expenses. During the final period from January 1, 2024 through November 5, 2024, there were no forfeitures used to reduce employer contributions and approximately \$2,000 were used to pay Plan expenses. Forfeited nonvested accounts available at November 5, 2024 and December 31, 2023 were \$0 and approximately \$2,000, respectively.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

[1] Basis of accounting:

As a result of Plan termination effective April 19, 2024, for the final period January 1, 2024 through November 5, 2024, the financial statements were prepared under the liquidation basis of accounting. Under the liquidation basis of accounting, assets were measured to reflect the estimated amount of cash expected to be collected in settling or disposing of the assets during the liquidation process and liabilities were measured using the accrual basis of accounting and would include any expected cost of disposal of the assets and other costs that were expected to be incurred during the liquidation process. The financial statements as of December 31, 2023 were prepared on the accrual method of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts, because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

[2] Subsequent events:

The Plan has evaluated subsequent events through September 9, 2025, the date the financial statements were available to be issued.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

[3] Investment valuation and income recognition:

The Plan's investments were reported at fair value (except for fully benefit-responsive investment contracts, which were reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation in the value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the final period from January 1, 2024 through November 5, 2024.

[4] Payment of benefits:

Benefits were recorded when paid.

[5] Plan expenses:

Certain expenses of maintaining the Plan were paid by the Plan, unless otherwise paid by the Company. Expenses that were paid by the Company were excluded from these financial statements. Fees related to the administration of notes receivable from participants were charged directly to the participant's account and were included in administrative expenses. Investment related expenses were included in the net appreciation in value of investments.

[6] Use of estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and when applicable, disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

NOTE C - INVESTMENT CERTIFICATION

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the U.S. Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, Empower Annuity Insurance Company of America and Empower Trust Company, LLC have certified to the completeness and accuracy of all investments and related investment activity and notes receivable from participants, and related activity in the accompanying statements of net assets available for benefits as of November 5, 2024 (in Liquidation) and December 31, 2023 (Ongoing), and the statement of changes in net assets available for benefits for the final period January 1, 2024 through November 5, 2024 (in Liquidation).

NOTE D - FAIR VALUE MEASUREMENTS

The Financial Accounting Standards Board's ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements), and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

NOTE D - FAIR VALUE MEASUREMENTS (CONTINUED)

Level 2 – Inputs to the valuation methodology include: (1) quoted prices for similar assets or liabilities in active markets; (2) quoted prices for identical or similar assets or liabilities in inactive markets; (3) inputs other than quoted prices that are observable for the asset or liability; or (4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy was based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investment assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2023.

Mutual funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that were registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan were deemed to be actively traded.

Collective trust fund – A collective trust is comprised of a diversified portfolio of fixed income instruments which may include guaranteed investment contracts, synthetic guaranteed contracts, separate account contracts, cash and cash equivalents and other commingled investment vehicles. It is valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. Participant transactions (purchases and sales) may have occurred daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. The investment advisor did not delay the fund's withdrawal at the time of liquidation during 2024.

The preceding methods described may have produced a fair value calculation that may not have been indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods were appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could have resulted in a different fair value measurement at the reporting date.

NOTE D - FAIR VALUE MEASUREMENTS (CONTINUED)

(A) Certain investments that were measured at fair value using the NAV per share (or its equivalent) practical expedient have not been classified in the fair value hierarchy. The fair value amounts presented in this table were intended to permit reconciliation of the fair value hierarchy to the amounts presented in the statement of net assets available for benefits.

Changes in Fair Value Levels

The availability of observable market data was monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques could have required the transfer of financial instruments from one fair value level to another.

NOTE E - GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY

In 2023, the Plan entered into a benefit-responsive guaranteed investment contract with Prudential Retirement Insurance and Annuity Company ("PRIAC") and Great-West Life & Annuity Insurance Company ("GWA"). PRIAC and GWA maintained the contributions in a general account. The contract was reported at contract value. The account was credited with earnings on the underlying investments and was charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer was contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract was fully benefit-responsive, contract value was the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by PRIAC and GWA, represented contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may have ordinarily directed the withdrawal or transfer of all or a portion of their investment at contract value.

The traditional investment contract held by the Plan was a guaranteed investment contract. The contract issuer was contractually obligated to repay the principal and interest at a specified interest rate that was guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1 percent. The crediting rate was reviewed on a quarterly basis for resetting.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts was dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations could have been affected by future economic and regulatory developments.

Certain events that might have limited the ability of the Plan to transact at contract value with the contract issuer. Such events included the following:

1. The Plan's failure to qualify under Section 401(a) of the Internal Revenue Code or the failure of the trust to be tax-exempt under Section 501(a) of the Internal Revenue Code;
2. Premature termination of the contracts;

3. Plan termination or merger;
4. Changes to the Plan's prohibition on competing investment options; or
5. Bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

The Plan was terminated in 2024. However, this event did not limit the ability of the Plan to transact at contract value with the contract issuers or limit the ability of the Plan to transact at contract value with the participants.

NOTE F - TAX STATUS

The Plan adopted a Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA sponsored by Empower Retirement LLC. On November 14, 2022, the Internal Revenue Service ("IRS") stated in an opinion letter that the prototype adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code ("IRC") and therefore, the related trust is exempt from taxation. The Plan was amended since receiving the letter. However, the Plan administrator believed that the Plan was designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan was qualified, and the related trust was tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a government authority. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of November 5, 2024 and December 31, 2023, there were no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

NOTE G - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain investments were managed by Empower Trust Company ("ETC"). Empower Trust Company LLC, was the Plan trustee and Empower Retirement LLC ("ERL") was the recordkeeper and, therefore, transactions related to these investments qualified as party-in-interest transactions. Fees paid by the Plan to ETC and ERL were \$76,333 for the final period January 1, 2024 through November 5, 2024.

NOTE H - RISKS AND UNCERTAINTIES

The Plan invested in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could have materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE I - MUTUAL FUND FEES

Certain investments in mutual funds are subject to sales charges in the form of front-end loads, back-end loads or 12b-1 fees, which are ongoing fees allowable under Section 12b-1 of the Investment Company Act of 1940 are annual fees used to pay for marketing and distribution costs of the funds. These fees were deducted prior to the allocation of the Plan's investment earnings activity, and thus not separately identifiable as an expense.

NOTE J - NONEXEMPT PARTY-IN-INTEREST TRANSACTION

Prohibited transaction for late remittances

For the period March 27, 2023 through December 31, 2023, it was discovered that certain amounts withheld were not timely remitted to the Plan. The Plan administrator deposited \$25,686 and \$169 into the Plan on April 1, 2024 and October 7, 2024, respectively. On April 10, 2024 and November 1, 2024, the Plan remitted earnings of \$1,749 and \$20, respectively, in order to make the affected participants whole.
