Opinion

NOTE A – DESCRIPTION OF PLAN

The following description of the LTI Technology Solutions (hereinafter referred to as the Company and Plan Administrator) Employee Stock Ownership Plan (hereinafter referred to as the Plan) provides only general information. Participants should refer to the Plan agreement for complete information.

General

The Company established the Plan effective as of January 1, 2006. The Plan was most recently amended effective November 1, 2018 and is currently operating as a non-leveraged employee stock ownership plan (ESOP) and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986, as amended (IRC), and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

On December 31, 2012, the Employee Stock Ownership Trust purchased 6,069 shares of the Company's common stock through secured nonrecourse promissory notes in the aggregate amount of \$384,455. The notes were unconditionally guaranteed by the Company. The notes were paid off by December 31, 2014 and all shares allocated to participants.

Eligibility

Employees of the Company are generally eligible to participate in the Plan after attaining age 21 and after one year of service, providing they worked at least 1,000 hours during such 12 months of service. The computation period with regards to eligibility reverts to the Plan year after the initial year of service. Participants who do not have at least 1,000 hours of service during such Plan year or are not employed on the last working day of a Plan year are generally not eligible for an allocation of Company contributions for such year.

Contributions

Prior to debt payoff, the Company was obligated to make contributions to the Plan equal to the amount necessary to enable the Plan to make its regularly scheduled payments of principal and interest due on its loan. After loan payoff, contributions to the Plan are made at the discretion of the Company. Employee contributions are not permitted. S-Corporation distributions contributed to the Plan are allocated pro-rata based on the shares in each participant's account and are recorded as dividend income in the accompanying financial statements.

Receivables

Receivables represent amounts due to the Plan either through cash or S-Corporation distributions. Amounts are considered fully collectible, therefore, there is no allowance for credit losses as of December 31, 2024 or 2023, respectively.

Payment of Benefits

Distribution on account of death, disability, or retirement are made not later than one year after the close of the Plan year in which the termination occurred, provided a distribution was affirmatively elected. Distributions for other separations from service commence not later than one year after the close of the fifth Plan year following termination, provided a distribution was affirmatively elected. If the employee's vested account is \$1,000 or less at the time of distribution, a single lump sum cash payment is made.

For vested accounts over \$1,000 at the time of distribution, payments are generally made in substantially equal periodic payments over a period not longer than five years. However, the Company may elect to pay the benefits in a lump sum distribution sooner. The amount to be distributed is based upon the immediately preceding valuation date. Distributions of a cash balance or any portion of an employee's account attributable to Company stock are paid in cash or through a direct rollover to a qualified Plan.

As of December 31, 2024, the vested balance of future distributions to be paid out related to employees who terminated or reached normal retirement age prior to December 31, 2024 but have not yet elected a distribution was \$1,325,059.

Administrative Expenses

As provided in the Plan agreement, administrative expenses may be paid either by the Plan or by the Company. Expenses paid by the Company are not included in these financial statements.

Voting Rights

Each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account with respect to certain corporate matters and is notified by the Trustee prior to the time that such rights are to be exercised.

Participant Accounts

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited as of the last day of each Plan year with an allocation of forfeitures of terminated participants' non-vested accounts. Only those participants who are eligible employees of the Company as of the last day of the Plan year and who have had 1,000 hours of service in the Plan year will receive an allocation. Allocations are based on a participant's eligible compensation, relative to total eligible compensation. The value of interest in Company stock is determined based on the value of the Company's stock. The Administrator will value the account each valuation date, which is the last day of the Plan year.

Vesting

If a participant's employment with the Company ends for any reason other than retirement, permanent disability, or death, he or she will vest in the balances in his or her account based on total years of service with the Company. After 2 years of service, participants are 20% vested in their account balance and vest 20% percent per year of service until they are 100% vested after 6 years of service.

Put Option

Under federal income tax regulations, the employer stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the fair market value of the Company stock. The Trustee may exercise the put option at any time by giving 30 days written notice to the Company. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

Diversification

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company common stock into investments that are more diversified. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a 6-year period. In each of the first 5 years, a participant may diversify up to 25 percent of the number of shares allocated to his or her account as of the immediately preceding valuation date, less any shares previously diversified. In the sixth year, the percentage changes to 50 percent. Participants who elect to diversify can elect a distribution from the Plan, can elect a transfer from the Plan to another qualified Plan of the Company that accepts such transfer, or can elect a transfer from the Plan to an Individual Retirement Account (IRA) in the participant's name.

Forfeitures

Plan forfeitures are allocated to each participant's account based upon the relation of the participant's eligible compensation to total eligible compensation for the Plan year. Forfeitures allocated to participants totaled \$19,297 and \$11,922 during the years ended December 31, 2024 and 2023, respectively. Forfeited non-vested accounts to be allocated to participant accounts in future years as of December 31, 2024 and 2023 were \$39,964 and \$45,315, respectively.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Use of Estimates

Management uses estimates and assumptions in preparing these financial statements in accordance with accounting principles generally accepted in the United States of America. Those estimates and assumptions affect the reported amounts of assets and liabilities, and the reported additions to and reductions from net assets. Actual results could vary from estimates used.

Investment Valuation and Income Recognition

The shares of Company common stock are reported at fair value. See note D for a discussion of fair value measurements. Dividend income is accrued on the ex-dividend date. Purchases and sales of securities are recorded on a trade-date basis. Realized gains and losses from security transactions are reported on the average cost method. Net depreciation and appreciation include the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

The Plan Administrator has evaluated subsequent events through August 20, 2025 which is the date the financial statements were available to be issued. In April 2025, there was a change to the Plan's trustee.

NOTE D – FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB), Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures – Overall Disclosure*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described below:

The valuation process involves the selection of an appraiser under contract for a term as determined by the employer with the right to cancel such contract at any time. Plan management accumulates the data for the appraiser from historical and projected financial information of the Company. The appraiser prepares a report of estimated per share value that a participant will receive upon distributions.

Interest Bearing Cash: Carrying amount approximates fair value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E – TAX STATUS

The Plan has most recently received a determination letter from the Internal Revenue Service (IRS) dated January 5, 2018, stating that the Plan is qualified under the Internal Revenue Code (IRC) and, therefore, the related trust is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan has been amended since receiving the determination letter. However, the Plan administrator believes that the Plan is currently designed, and being operated, in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

NOTE E – TAX STATUS (Continued)

Accounting principles generally accepted in the United States of America requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes that the Plan is no longer subject to income tax examinations for periods prior to December 31, 2021.

NOTE F – PLAN TERMINATION

The Company reserves the right to terminate the Plan at any time, subject to Plan provisions. Upon discontinuance of Plan contributions or full or partial termination of the Plan, the account of each affected participant shall become fully vested and nonforfeitable. The Company shall provide the Trustee with written notification of the full or partial termination of the Plan. In the event of full or partial termination, the Company's liability to pay Plan benefits shall be strictly limited to assets of the Plan held in trust by the Trustee.

NOTE G – RISKS AND UNCERTAINTIES

The Plan investments consist primarily of the Company's common stock, which is exposed to various risks, such as interest rate, market, and credit risks, as well as valuation assumptions based on earnings, cash flows, and other such techniques. Due to the level of risk associated with the investment in common stock and to uncertainties inherent in estimates and assumptions, it is at least reasonably possible that changes in the value of the common stock will occur in the near term and that such change could materially affect the amounts reported in the statements of net assets available for benefits.

NOTE H – RELATED PARTY TRANSACTIONS

The Plan invests in Company common stock. This is considered a related party and party in interest transaction. The Plan also has a number of service providers. Such providers are parties in interest under ERISA.
