## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator and Participants of the Gilmore & Bell, P.C. 401(k) Profit Sharing Plan and Trust  
Kansas City, Missouri

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Gilmore & Bell, P.C. 401(k) Profit Sharing Plan and Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



In our opinion:

- The form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

---

### 1. DESCRIPTION OF THE PLAN

The following description of the Gilmore & Bell, P.C. 401(k) Profit Sharing Plan and Trust (the "Plan") provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

**General** – The Plan is a defined contribution plan subject to the provision of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan is open to employees of Gilmore & Bell, P.C. (the "Company") who are 21 years old. Eligible employees may enter the Plan as soon as administratively possible.

Ascensus Trust Company is the trustee and custodian of the Plan, and the recordkeeping and administrative services are provided by The Vanguard Group, Inc. ("VGI"). VGI has entered into an agreement with Ascensus, Inc. to provide certain plan recordkeeping and administrative services on its behalf. MHM Retirement Plan Solutions LLC ("MHM") serves as the third party administrator.

**Contributions** – Participants may contribute amounts up to certain Internal Revenue Code ("IRC") limitations. Participants 50 years or older are permitted to make catch-up contributions, as defined in the Plan. The Plan has an automatic enrollment feature. New employees are automatically enrolled in the Plan, and contribute 6% of their eligible wages, unless the employee opts out of participation, or chooses a different deferral rate. Each successive year on the first day of January, the deferral will increase by 1%, to a maximum amount of 10%.

The Company contributed a discretionary matching contribution equal to 25% of the first 4% of eligible compensation that a participant contributes to the Plan. Profit-sharing contributions are discretionary as determined by the Company's board of directors. Participants are eligible for discretionary profit-sharing contributions upon completion of six months of service and must be employed on the last day of the Plan year. For the years ended December 31, 2024 and 2023, the Company elected to make profit sharing contributions of \$2,013,222 and \$1,986,386, respectively, which were paid into the Plan subsequent to year end.

**Participant Accounts** – Each participant's account is credited with the participant's voluntary contribution, the Company's contributions, plan earnings, and charged with the participant's withdrawals and distributions, and administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

**Investment Options** – Participants direct the investment of all contributions into various investment options offered by the Plan. The Plan currently offers mutual funds, money market funds, and self-directed brokerage accounts as investment options.

**Vesting** – Participants' contributions are fully vested at all times. The employer contributions vest in 33% increments, and 100% vested after the third year. In the event of permanent disability, death, reaching normal retirement age, or termination of the Plan, the Company's contributions will become fully vested.

**Forfeitures** – Forfeitures occur upon termination of employment by a participant who is not fully vested in the Plan. Forfeited balances of terminated participants' nonvested accounts are used to either pay Plan expenses or to reduce the employer contributions to the Plan. There are \$0 and \$8 in forfeitures as of December 31, 2024 and 2023, respectively. Forfeitures of \$4,649 were used to pay administrative expenses in 2024.

**Payment of Benefits** – Upon termination of employment, the participant, or in the case of death, the participant's beneficiary, receives the participant's account balance in a single lump-sum or installments for participants who must receive minimum required distributions. Participants may also rollover their account to an individual retirement account or another qualified employer plan. In the event that a participant terminates employment, and their account balance is less than \$5,000, the balance will automatically be paid out in a single lump sum payment, or be rolled over into an IRA.

**In-Service Withdrawals** – Certain participants may make withdrawals prior to termination of employment. Hardship withdrawals are available to Plan participants, as defined by the Plan Adoption Agreement and permitted by the IRC. Hardship withdrawals are limited to the participant's account balance that is 100% vested.

Participants who have obtained the age of 59 ½ may elect to receive a distribution of all or any portion of their vested account balances in a single lump sum payment.

**Notes Receivable from Participants** – Participants may borrow from their fund accounts a minimum of \$1,000, up to the lesser of \$50,000 or 50% of their vested account balance. The maximum loan term is 5 years, except if the loan is to acquire the participant's principal residence, which may have a longer repayment term. Interest rates are established by adding one percentage point to the Prime rate. The balance in the participant's account secures the loan. Principal and interest are paid ratably through payroll deductions. A participant may have no more than two loans outstanding at any one time.

**Administrative Expenses** – Administrative expenses may be paid by the Company or the Plan, at the Company's discretion. The Plan paid expenses of \$29,053 for the year ended December 31, 2024. The Company may pay other professional fees associated with the Plan.

**Termination of the Plan** – Although the Company has not expressed any intent to do so, it has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the Plan and under ERISA. In the event that the Plan should be terminated, all remaining Plan assets would become fully vested and allocated to the participants as described in the full text of the Plan.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting** – The accompanying financial statements have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

**Use of Estimates** – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of certain assets, liabilities, and disclosures. Actual results could differ from those estimates.

**Contributions** – Employer and employee contributions are reported in the year services are rendered to the Company by the Plan participants.

**Investment Valuation and Income Recognition** – The Plan’s investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis.

Management fees and operating expenses charged to the Plan for investments in the mutual funds, money market funds and pooled separate accounts are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

**Notes Receivable from Participants** – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. No allowance is considered necessary.

**Payment of Benefits** – Benefit payments are reported in the year paid.

**Date of Management’s Review** – Subsequent events have been evaluated through September 2, 2025, which is the date the financial statements were available to be issued, and there were no material events requiring recognition or disclosure.

### 3. FAIR VALUE MEASUREMENTS

FASB ASC 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The hierarchy consists of three broad levels, described as follows:

Level 1 – Inputs consist of unadjusted quoted prices for identical assets in active markets that the plan has the ability to access.

Level 2 – Inputs consist of 1) quoted prices for similar assets in active markets, 2) quoted prices for identical or similar assets in inactive markets, 3) inputs other than quoted prices that are observable, and 4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term.

Level 3 – Inputs consist of unobservable inputs where there is little or no market activity, and the reporting entity makes estimates and assumptions related to the pricing of the asset including assumptions regarding risk.

The assets fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Mutual Funds and Money Market Funds – Valued at the published net asset value (“NAV”) of shares held by the Plan at year end.

Self-Directed Brokerage Accounts – Participants can invest in these accounts which consist of mutual funds and money market funds. The mutual funds, and money market funds, are valued as described above.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. The Plan's investments are reported at fair value as follows at December 31, 2024 and 2023:

#### 4. RISKS AND UNCERTAINTIES

The Plan invests in investment securities, which hold securities including U.S. Government securities, corporate debt instruments, and corporate stocks. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

#### 5. INFORMATION CERTIFIED BY THE TRUSTEE

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosures under ERISA. Accordingly, Ascensus Trust Company, the trustee of the Plan, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate with respect to investments as December 31, 2024 and 2023, and for the year ended December 31, 2024:

- Investments, at fair value
- Notes receivable from participants and related interest
- Net appreciation in fair value of investments
- Interest and dividend income
- Schedule of assets (held at end of year)

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

**6. TAX STATUS**

The Company adopted a Non-Standardized Pre-Approved Profit Sharing Plan which received a favorable opinion letter from the IRS on June 30, 2020, which stated that the Plan and related trust are designed in accordance with applicable sections of the IRC. The Plan has been amended since the date of the opinion letter. However, the Company believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and that, therefore, the Plan qualifies under Section 401(a) and the related trust is tax-exempt as of December 31, 2024. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**7. EXEMPT PARTY-IN-INTEREST TRANSACTIONS**

Plan investments include mutual funds, and a money market fund managed by VGI. VGI is a recordkeeper as defined by the Plan, and therefore, these transactions qualify as party-in-interest. The Plan has a number of service providers, and such providers are parties-in-interest under ERISA.

The Company provides certain administrative services at no cost to the Plan.

The Plan pays certain fees to VGI and MHM to administer the Plan. These transactions qualify as party-in-interest. Notes receivable from participants are party-in-interest transactions.

**8. PROHIBITED TRANSACTIONS**

During the year ended December 31, 2023, employee deferrals of \$429 were withheld from two payrolls and not remitted to the Plan on a timely basis (as defined by the Department of Labor "DOL") by the Plan Sponsor. The Plan Sponsor subsequently remitted the deferrals to the trust, filed and paid the appropriate excise tax, and contributed lost earnings to the affected participants. These transactions were prohibited according to the provisions of the DOL.


