Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

## NOTES TO FINANCIAL STATEMENTS

### 401(k) Plan for Sotera Health

#### 1 Description of Plan

The following description of the 401(k) Plan for Sotera Health (the “Plan”) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

##### ***General:***

The Plan is a defined contribution plan covering all eligible employees of Sotera Health, LLC (the “Company”). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

##### ***Plan Administration:***

The Company is the administrator of the Plan and, as such, carries out the duties imposed by ERISA. The Company has delegated certain responsibilities for the operation and administration of the Plan. Trustee services were provided by Charles Schwab Trust Bank, a division of Charles Schwab Bank (“Schwab”).

##### ***Contributions:***

Employee Contributions – Newly hired employees are automatically enrolled in the Plan when they become eligible to participate. The amount of eligible pay that will automatically be contributed on a pre-tax basis to the Plan is initially 3% of eligible pay and then will increase annually by 1% each year on a predetermined date until the participant’s pre-tax contributions equal 6% of eligible pay. Employees have the ability to opt-out of the automatic enrollment and escalation features of the Plan at any time.

The Plan allows participants to elect to contribute up to 100% of their qualified compensation on a pre-tax basis up to the maximum percentage allowable by federal law. Maximum allowed deferral amounts were \$23,000 for 2024. Participants over the age of 50 may also contribute an additional \$7,500 to the Plan for 2024. This contribution limitation may be adjusted annually to reflect changes in the cost of living.

Federal law may further limit the contributions of certain highly compensated participants based on the level of participation of the non-highly compensated participants as a group.

Participants are also allowed to roll over contributions from other qualified employer-sponsored retirement plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

Employer Contributions - The Plan provides for the Company to make matching contributions equal to each participant's deferral to the extent that the participant's deferral does not exceed 3% of the participant's total compensation, as defined by the Plan, plus 50% of the employee deferrals up to 6% of the participant's total compensation up to the maximum amount allowable by federal law. There were no qualified non-elective contributions made during 2024. The Company may make contributions to each eligible participant's account by matching a percentage of the Participant's elective deferral for the plan year.

Contributions are subject to limitations on annual additions and other limitations imposed by the Internal Revenue Code as defined in the Plan agreement.

## NOTES TO FINANCIAL STATEMENTS

### 401(k) Plan for Sotera Health

#### 1 Description of Plan, Continued

##### *Participants' Accounts:*

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and (b) Plan earnings/ (loss) and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

##### *Administrative and Investment Management Expenses:*

Certain administrative expenses are paid by the Plan and are reflected in the financial statements as administrative expenses of the Plan. Administrative fees paid by the Plan for the years ended December 31, 2024 and 2023, totaled \$524,542 and \$484,057 respectively. Investment management fees, which may vary according to the individual funds selected, are charged to the Plan as a reduction of investment return and included in the investment income (loss) reported by the Plan. Participants should refer to the prospectus of the individual investment funds for further details on individual investment fees. All other expenses of the Plan are paid by the Company.

##### *Retirement, Death and Disability:*

A participant is entitled to 100% of his or her account balance upon retirement, death or disability.

##### *Vesting:*

All participants are 100% vested in elective deferrals, qualified non-elective contributions and rollover contributions made to the Plan. Participants are 100% vested in Company matching contributions plus actual earnings thereon.

##### *Forfeitures:*

Forfeitures due to termination from the Plan before a participant is 100% vested may be used to reduce Plan administrative fees, reduce employer contributions, or may be reallocated to the remaining participants in accordance with provisions of the Plan. Forfeitures used to offset expenses for the years ended December 31, 2024, and 2023 were \$ 24,001 and \$9,020 respectively. Forfeited non-vested accounts totaled \$20,092 and \$24,694 as of December 31, 2024 and 2023, respectively.

##### *Notes Receivable from Participants:*

Loans are permitted under certain circumstances and are subject to limitations. Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loans are repaid over a period not to exceed 5 years with exceptions for the purchase of a primary residence. Loans are valued at unpaid principal plus accrued but unpaid interest. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan agreement.

The loans are secured by the balance in the participant's account and bear interest at prevailing interest rates. Principal and interest are paid ratably through payroll deductions.

## NOTES TO FINANCIAL STATEMENTS

### 401(k) Plan for Sotera Health

#### 1 Description of Plan, Continued

##### *Other Plan Provisions:*

Normal retirement age is 65, however, a participant may elect early retirement on or after age 55. The Plan also provides for early payment of benefits after reaching age 59-1/2.

##### *Plan Merger:*

As a result of the company's acquisition of Regulatory Compliance Associates, Inc., the Regulatory Compliance Associations Plan was merged into the Plan. The merger resulted in the transfer of \$3,588,122 in plan assets to the 401(k) Plan for Sotera Health effective January 1, 2023.

##### *Payment of Benefits:*

Upon termination of service by reason of separation of service, retirement, death or total and permanent disability, a participant receives a lump sum amount equal to the value of his or her account. If a participant's account balance is equal to or less than \$5,000, the balance is distributed immediately in a lump sum cash payment unless a direct rollover into another qualified benefit plan is requested. Balances between \$1,000 and \$5,000 must be rolled over to an individual retirement plan designated by the administrator if the participant has not requested a lump-sum cash payment or a direct rollover into another qualified benefit plan. If the account balance is over \$5,000, the participant can consent to either a distribution paid in the form of a lump-sum payment, a direct rollover into another qualified plan, installment payments over a period not longer than life expectancy or postpone payment to a later date and remain in the Plan as described in the Plan documents. In-service withdrawals are also permitted for employees meeting certain criteria, including for participants employed after the normal retirement age, participants still employed before normal retirement age but who have reached age 50. Benefits are recorded when paid.

##### *Hardship Withdrawals:*

Hardship withdrawals are permitted in accordance with Internal Revenue Service guidelines.

##### *Investment Options:*

Upon enrollment in the Plan, a participant may direct any contributions to any of the investment options offered by the Plan.

#### 2 Summary of Significant Accounting Policies

##### *Basis of Accounting:*

The Plan's transactions are reported on the accrual basis of accounting.

##### *Valuation of Investments:*

The Plan's investments other than fully benefit responsive investment contracts are reported at fair value as further described in Note 4. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability.

## 2 Summary of Significant Accounting Policies, Continued

### *Valuation of Investments, Continued:*

Contract value is the relevant measure for the Plan's fully benefit-responsive investment contracts, because contract value is the amount Plan participants generally receive when executing transactions under the terms of the contract and Plan provisions.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments purchased and sold as held during the year.

### *Use of Estimates:*

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses during the reporting period. Actual results could differ from those estimates.

### *Plan Termination:*

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

### *Risks and Uncertainties:*

The Plan's investment include various investments contracts with varying degrees of risk, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the statement of net assets available for plan benefits.

### *Subsequent Events:*

Management evaluates subsequent events occurring subsequent to the date of the financial statements in determining and the accounting for and disclosure of transactions and events that affect the financial statements.

Subsequent events have been evaluated through August 26, 2025, which is the date the financial statements were available to be issued.

## 3 Tax Status

On September 21, 2020, the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue code. The Plan has been amended; however, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue code. Therefore, they believe that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

## NOTES TO FINANCIAL STATEMENTS

#### 3 Tax Status, Continued

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken uncertain tax positions that more-likely-than-not would not be sustained upon examination by applicable taxing authorities. The Plan administrator has analyzed tax positions taken by the Plan and has concluded that, as of December 31, 2024 there are no uncertain tax positions taken, or expected to be taken, that would require recognition of a liability or that would require disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions. However, currently no audits for any tax periods are in progress.

#### 4 Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Topic 820 are described as follows:

- \* Level 1: Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.
- \* Level 2: Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:
  - \* Quoted prices for similar assets or liabilities in active markets.
  - \* Quoted prices for identical or similar assets or liabilities in inactive markets.
  - \* Inputs other than quoted prices that are observable for the asset or liability.
  - \* Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- \* Level 3: Inputs that are unobservable inputs for the asset or liability.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used on December 31, 2024, and 2023.

##### ***Mutual Funds:***

The fair value of the mutual funds is based on quoted market prices.

##### ***Collective Trusts:***

The fair values of participation units held in collective trusts are based on the net asset values per unit as reported by the fund managers. The collective trusts provide for daily redemptions by the Plan at reported net asset values per share, with no advance notice requirement.

**6 Party-in-Interest Transactions**

Certain Plan investments are shares of mutual funds managed by Charles Schwab Trust Bank, the Trustee as defined by the Plan, and therefore, these transactions qualify as party-in-interest. Usual and customary fees were paid by the mutual fund for the investment management services. In addition, the Plan has arrangements with various service providers and these arrangements qualify as party in interest transactions.

#### **7 Benefit-Responsive Contract**

The Plan holds a traditional fully benefit-responsive investment contract. Fully benefit responsive investment contracts are presented at contract value in the statement of net assets, because contract value is the relevant measurement attribute for that portion of the Plan's net assets available for benefits. Contract value represents contributions made to a contract, plus earnings, less participant withdrawals, and administrative expenses. The contract value of the fully benefit-responsive investment contract is \$15,305,838 and \$10,101,367 on December 31, 2024, and 2023, respectively. Participants in fully benefit-responsive contracts may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan holds a direct interest in a fully benefit-responsive investment through its investment in the Anchor Account, which is a group annuity contract (Stable Value ("SVF") managed by New York Life Company ("NYLIC"). Contributions to the contract are deposited into a guaranteed separate account of NYLIC, which is a participating stable value separate account that is not unitized, and the assets of the separate account are accounted for at amortized cost. There are no reserves against contract value of the issuer or otherwise.

The contract for the SVF specifies certain conditions under which distributions from the SVF would be payable at amounts below contract value. Such circumstances may include a partial plan termination, mergers, spin-offs, layoffs, early retirement incentive programs, sales or closings of all or a portion of the plan sponsor's operations, bankruptcy, or receivership, if these events would lead to a request for payment of more than 10% of the Plan's value in the fund. The contract does not limit the circumstances under which the issuer may terminate the contract. Currently, management believes that the occurrence of an event that would cause the Plan to transact contract distributions at less than contract value is not probable.
