Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements

We have performed the audit of the financial statements of Auto Ranch Group 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Auto Ranch Group 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note E to the financial statements, is complete and accurate.

Opinion on the Financial Statements

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section-

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion on the Financial Statements

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. The following description of the Auto Ranch Group 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. **General** - The plan is a defined contribution plan formed on January 1, 2010, covering all eligible employees of Auto Ranch Group (the Company/Employer/Plan Sponsor) who have at least 90 days of service and are age 18 or older. On December 28, 2018, the plan changed its name to Auto Ranch Group 401(k) plan. The plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Employees may enter the plan on the first day of the month following the date on which the employee satisfies the eligibility requirements. Employees are eligible to receive discretionary profit-sharing contributions following the completion of 1,000 service hours and are age 18 or older. Service hours with affiliates (Curt & Hal Dodge, Dennis Dillon Auto Park & Truck Center, Hanigan Chrysler Jeep Dodge, Gentry Motors Subaru LLC, Gentry Motors Ford LLC and Gentry Baker City Motors LLC) will be recognized for eligibility purposes with respect to all plan components and will be treated as service with the Company for profit sharing eligibility. The Board of Trustees oversees governance of the plan. The plan's Investment Committee determines the appropriateness of the plan investments, monitors investment performance, and reports to the plan Board of Trustees. The Trustee of the Plan is Capital Bank and Trust Company ("Trustee"). The Plan was restated effective January 1, 2022, to bring the plan into compliance with the legislative and regulatory changes set forth in IRS Notice 2017-37.
2. **Contributions** – The Plan includes a pre-tax and Roth after-tax salary deferral arrangement allowed under Section 401(k) of the Internal Revenue Code ("IRC"). Eligible participants are permitted to elect to have a percentage of their compensation contributed to the Plan.

The Company may, at its discretion, elect to make qualified matching contributions to the Plan. The Company elected to match 15% of eligible employee contributions made to the Plan up to 6% of eligible compensation for the 2023 Plan year. Employer matching contributions for the years ended December 31, 2024 and 2023, were \$0 and \$56,256, respectively.

The Company may, at its discretion, elect to make a discretionary contribution to the Plan. For the years ended December 31, 2024 and 2023, there was no discretionary contributions made to the Plan by the Company, other than those listed above.

Participants may also contribute amounts representing distributions from other qualified plans provided that certain conditions are met, including the approval of the Plan administrator.

Participants direct the investment of contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service ("IRS") limitations.

3. **Participant Accounts** – Each participant's account is credited throughout the year with (a) the participant's contribution, (b) the sponsor's matching contribution, (c) sponsor's elected profit-sharing contribution, and (d) plan investment income and unrealized gains or losses. The sponsor's matching contribution is allocated based upon participant contributions. The sponsor's profit-sharing contribution is allocated to the Profit-Sharing Contribution Account of each eligible participant in pro rata shares. Earnings are allocated based upon individual accounts. The benefit to which a participant is entitled is the vested account balance of the participant.
4. **Vesting** – Participants are immediately vested in their elective deferral contributions plus actual earnings thereon. Participants become vested in Sponsor matching and profit-sharing contributions in 20% increments for each year of credited services beginning in the second year of service. A participant is fully vested in nonelective contributions after six years of credited services. Service with affiliates (Curt & Hal Dodge, Dennis Dillon Auto Park & Truck Center, Hanigan Chrysler Jeep Dodge, Gentry Motors Subaru LLC, Gentry Motors Ford LLC and Gentry Baker City Motors LLC) will be recognized for vesting purposes with respect to all plan components and will be treated as service with the Company for vesting purposes.

5. **Payment of Benefits** – Upon termination of service, death, disability, or retirement, the participant will receive the value of the vested interest in his or her account in the form of a lump sum distribution. The Plan allows for in-service distributions if a participant reaches age 59½. If a participant terminates employment and the participant’s account balance does not exceed \$5,000, the Plan administrator will authorize the benefit payment without the participant’s consent.
6. **Notes Receivable from Participants** – Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. Principal and interest is paid ratably through payroll deductions. Note terms are up to five years or longer if proceeds are used for the purchase of a primary residence. The notes are secured by the balance in the participant’s account and bear interest at a rate commensurate with local prevailing rates as determined quarterly by the Plan administrator. On December 31, 2024, interest rates ranged from 4.25 percent to 9.5 percent.
7. **Forfeited Accounts** – Forfeited nonvested accounts may be used for payment of administrative expenses and or allocated to participants as additional matching contributions. Forfeited nonvested accounts as of December 31, 2024 and 2023 totaled \$31,782 and \$24,849, respectively. In 2024, forfeited nonvested accounts of \$4,775 were used to pay administrative expenses. In 2023, Employer Contributions were reduced by \$5,692 from forfeited nonvested accounts.

B. Summary of Significant Accounting Policies:

The following are the significant accounting policies followed by the Plan:

1. **Basis of Accounting** – The financial statements of the Plan are prepared using the accrual method of accounting.
2. **Estimates** – The preparation of financial statements in conformity with generally accepted accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.
3. **Investment Valuation and Income Recognition** – Investments are reported at fair value except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note G for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.
4. **Payments of Benefits** – Benefits are recorded when paid.
5. **Contributions** – Contributions from Plan participants and the matching contributions from the Employer are recorded in the year which the employee contributions are withheld from compensation.
6. **Expenses** – The Plan’s expenses are paid either by the Plan or the Company, as provided by the Plan document. Expenses paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan, that are paid by the Plan, are recorded as deductions in the accompanying statements of changes in net assets available for benefits. In addition, certain investment-related expenses are included in net appreciation (depreciation) of the fair value of investment presented in the accompanying statement of changes in net assets available for benefits.
7. **Notes Receivable from Participants** – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

8. **Excess contributions payable** – Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 excess contributions to the applicable participants prior to March 15, 2025. The Plan distributed the 2023 excess contributions to the applicable participants prior to March 15, 2024.
9. **Reclassifications** – Certain amounts for the year ended December 31, 2023 were reclassified to conform to the current year presentation. The reclassifications did not affect the net increase for the year ended December 31, 2023
10. **Subsequent Events** – The Plan has performed an evaluation of subsequent events through August 14, 2025, which is the date the financial statements were available to be issued.

C. Plan Termination:

Although they have not expressed any intent to do so, the Companies have the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

D. Tax Status of Plan:

The Plan is placing reliance on an opinion letter dated September 13, 2021, received from the IRS on the pre-approved plan indicating that the Plan is qualified under Section 401 of the IRC and is therefore not subject to tax under current income tax law. The pre-approved plan has been amended since receiving the opinion letter. However, the Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified.

Accounting principles generally accepted in the United States of America requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax years in progress.

E. Information prepared and certified by trustee:

F. Risks and Uncertainties:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

G. Fair Value Measurements:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
Level 2	Inputs to the valuation methodology include <ul style="list-style-type: none">• quoted prices for similar assets or liabilities in active markets;• quoted prices for identical or similar assets or liabilities in inactive markets;• inputs other than quoted prices that are observable for the asset or liability;• inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

I. Related Party and Party-In-Interest Transactions:

The Plan investments are managed by Capital Bank and Trust Company and therefore, the investment transactions qualify as party-in-interest transactions. Participant loan and distribution processing fees incurred by the Plan are paid by participants. Fees for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. The Plan also issues loans to participants which are secured by the vested balance of the participant's accounts. Certain other fees in the form of an expense ratio charged to each investment option are paid by the Plan and deducted from earnings on investments. These transactions are party-in-interest transactions which are exempt from the prohibited transaction rules.

J. Concentration of Credit Risk:

Financial instruments that potentially subject the Plan to concentrations of credit risk consist of cash and short-term investments and marketable securities. The amount of exposure to any one specific investment has been limited by investing in mutual funds that use a diverse investment portfolio to limit risk.

K. SECURE 2.0:

SECURE 2.0 continue the themes and reforms that began with the 2019 SECURE Act Secure Act 2.0. Many of the provisions have different effective dates, with some changes impacting 2023, 2024, 2025 and beyond. Plan documents are required to be formally amended for mandatory and any nonmandatory provisions adopted on or before the last day of the 2025 plan year. Since the provisions include both required and optional elements, the Plan administrator will determine the optional provisions to elect.
