INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of the
CAI Software 401(k) Profit Sharing Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the CAI Software 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Basis for Opinion

1. Description of the Plan

The following description of the CAI Software 401(k) Profit Sharing Plan (the Plan) is intended to provide only general information regarding the Plan. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of CAI Software LLC, Casco Development LLC, IMS Software LLC, Multiprocess Computer LLC, OpenMFG LLC d/b/a xTuple, Robocom US, LLC, and Radley LLC (collectively, the Company or Employer) who are 18 years of age or older. The Plan is a contributory single-employer defined contribution plan under Section 401(k) of the Internal Revenue Code (IRC) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Employer is also the administrator of the Plan (Plan Administrator). As Plan Administrator, the Employer has exclusive authority and responsibility for all matters in connection with the operation and administration of the Plan. Fidelity Management Trust Company (Fidelity) is the appointed trustee of the Plan, and acts at the direction of the Plan Administrator.

Contributions

Participants may elect to contribute up to 90% of their annual pretax and after-tax eligible compensation, so long as those contributions do not exceed annual limitations set by the IRC (\$23,000 in 2024). Participants may designate some or all of their elective deferrals as Roth 401(k) deferrals.

The Company has an automatic enrollment for those hired on or after January 15, 2020 under which eligible employees will contribute 5% of compensation automatically unless they affirmatively elect otherwise. The Plan also has an automatic escalation for participants hired on or after January 15, 2020, with a deferral rate greater than zero, who are not suspended from making deferral contributions. Eligible participants' deferral rates increase annually by 1%, not to exceed 10%.

Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions (\$7,500 in 2024), subject to the restrictions as defined by the Plan. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollovers).

Employer matching contributions are discretionary. Participants are eligible to receive the Employer discretionary matching contribution immediately upon becoming eligible. The matching contribution will be computed based on a participant's eligible compensation deferred in the Plan each payroll period. In addition, the Employer may choose to make discretionary non-elective contributions to participants who were either employed on the last day of the Plan year or who have completed more than 501 hours of service in the Plan year. There were no non-elective contributions made for the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Employer matching contribution, (b) Plan earnings (losses) and (c) administrative expenses. Plan earnings (losses) and administrative expenses are allocated to participant accounts based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings on those contributions. Participants become vested in the non-elective Employer contributions and the allocated earnings on those contributions as follows: 20% after two years, 40% after three years, 60% after four years, 80% after five years and 100% after six years. Participants are immediately vested in all accounts upon death, disability, or attainment of retirement age as defined by the Plan. A year of vesting service is equal to the Plan year.

Participant Notes Receivable

Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Note terms range from one to five years, or up to 10 years for the purchase of a primary residence. The notes are secured by the vested balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

On retirement, death, disability, termination of service or at age 59½, a participant (or participant's beneficiary in the event of death) may elect to receive a lump-sum distribution, partial distribution or installment payments equal to the value of his or her account. Participants may request in-service hardship withdrawals from their elective deferral accounts.

Forfeitures

Participants in the Plan who leave the employment of the Company before completing five years of service forfeit the non-vested portion of their accounts. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$3,129 and \$27,135, respectively. For the year ended December 31, 2024, \$51,846 and \$25 of the forfeiture balance were used to reduce Employer contributions and pay administrative expenses, respectively.

Plan Termination

The Company expects to continue the Plan indefinitely. However, the Company reserves the right to amend the Plan or contributions thereto at any time and in any manner that it deems advisable, provided that no amendment shall have the effect of diverting Plan assets for purposes other than for the exclusive benefit of the Plan participants and any Plan termination would be subject to the provisions of ERISA. If the Plan is terminated, the participants would become fully vested and entitled to receive all amounts credited to their accounts.

2. Summary of Significant Accounting Policies

Basis of Accounting

The Plan's financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Valuation of Investments and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Participant Notes Receivable

Participant notes receivable are measured at their unpaid principal balances plus any accrued but unpaid interest and are secured by the balance in the respective participant's account. Interest income on participant notes receivable is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. A receivable is considered past due if payment has not been received within stated terms. Delinquent participant notes receivable are reclassified as distributions based on terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Contributions

Participant contributions and Employer matching contributions are recorded each pay period when the Company remits the payroll deductions for investment into the Plan. Employer non-elective matching contributions are discretionary and are recorded when the Company elects to remit the contributions for investment into the funds.

Payment of Benefits

Benefits are recognized when paid to participants or their designated beneficiaries.

Administrative Expenses

Certain administrative expenses of the Plan are paid by the Employer, unless the Employer directs that the expenses be paid by the Plan. Expenses that are paid by the Employer are excluded from these financial statements. Participant notes receivable set-up and maintenance fees are paid directly by the participants through a reduction in their account and are included in administrative expenses. Investment management and recordkeeping fees, if applicable, are paid by the Plan through revenue sharing as a reduction of investment income (net appreciation or depreciation) from the related investment fund.

Administrative revenue arises when investment managers return a portion of the investment fees to the recordkeeper to offset the administrative expenses. Any excess resulting from this revenue credit remains in an unallocated account from which future Plan expenses can be paid or allocated to participant accounts. The Plan held unallocated administrative revenues of \$108,188 and \$80,064 at December 31, 2024 and 2023, respectively.

Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts of assets, liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported changes in net assets. Accordingly, actual results may differ from those estimates.

Risks and Uncertainties

The Plan provides for various investment options with various investment objectives. Investment securities are exposed to various risks such as interest risk, market risk and credit risk. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Plan Benefits.

The Plan invested in three mutual funds that accounted for approximately 49% of total Plan investments as of December 31, 2024. The Plan invested in four mutual funds that accounted for approximately 59% of total Plan investments as of December 31, 2023.

Financial Instruments with a Concentration of Credit Risk

The Plan's investments are held by a single trustee. The Plan's exposure to credit risk is associated with the outside entities' non-performance of their fiduciary responsibilities relating to these amounts as specified in the agreements. Benefits provided by the Plan are not insured or guaranteed by the Pension Benefit Guaranty Corporation.

Subsequent Events

Management has evaluated subsequent events through September 9, 2025, which is the date these financial statements were available to be issued.

3. Fair Value Measurements

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives highest priority to unadjusted quoted prices in active markets for identical assets (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy and inputs to the valuation methodologies are described as follows:

Level 1 inputs are unadjusted quoted prices in active markets for identical assets the Plan has the ability to access.

Level 2 inputs are other than quoted prices in active markets that are observable either directly or indirectly for the asset. Such inputs are derived principally from or corroborated by observable market data for similar assets by correlation or other means, over substantially the full contractual term of the asset, if applicable.

Level 3 inputs are unobservable and significant to the fair value measurement. Such inputs generally rely on the Plan's own assumptions about the assumptions that market participants would use in pricing the asset.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis.

Money Market Fund: The carrying amount of the money market fund is the deposit amount plus accrued interest, as determined according to stated terms.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

As of December 31, 2024 and 2023, the Plan's investments in the money market fund and mutual funds are reported at level 1 within the fair value hierarchy.

4. Summary of Financial Data Certified by the Trustee

The following is a summary of financial information and data certified by the trustee, Fidelity:

Statements of Net Assets Available for Plan Benefits at December 31, 2024 and 2023, except for contribution receivables, if any;

Investment income and interest income from participant notes receivable on the Statement of Changes in Net Assets Available for Plan Benefits for the year ended December 31, 2024, and;

Investment information provided on the supplemental schedule, Schedule of Assets (Held at End of Year) at December 31, 2024.

5. Income Tax Status

The Plan adopted a volume submitter plan document created by Fidelity Management and Research Co., who received an opinion letter dated June 30, 2020, in which the Internal Revenue Service stated that the Plan document, as then designed, was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Differences from Form 5500

Differences between the Annual Return/Report of Employee Benefit Plan, Form 5500, and these financial statements are a result of different classifications between line items. Total Plan assets are in agreement.

7. Related Party Transactions and Party-in-Interest Transactions

Plan investments are held and managed by Fidelity, the trustee of the Plan. Therefore, these transactions qualify as party-in-interest transactions. The Plan receives revenue credits from Fidelity, as discussed in Note 2. Amounts credited to the revenue credit account plus earned interest are used to pay third-party administrative expenses or allocated to participant accounts. During 2024, \$23,713 was credited to the administrative revenue account and used to offset third-party administrative expenses of \$1,488. The Plan also made direct payments to its independent advisor of \$67,581 for the year ended December 31, 2024. Participant notes receivable also qualify as party-in-interest transactions.
