Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the E&E 401(k) & Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Basis for Opinion on the Financial Statements

We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion on the financial statements.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. 1. DESCRIPTION OF PLAN AND SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The following description of the E&E 401(k) & Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provision.

The Plan is a defined contribution and profit sharing plan originally adopted in January 2006, and most recently amended and restated effective April 1, 2022 to conform to recent tax laws. The Plan covers substantially all employees of E&E Co. Ltd. and affiliates (the "Company") who have completed at least one year of eligibility service and are age 21 or older. 1,000 hours of service constitutes a year of eligibility service. Employees begin participation in the Plan as of the first day of each month following the date that they meet eligibility requirements.

The Plan is intended to qualify under Section 401(a) of the Internal Revenue Code and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Administration - Under the terms of the Plan, Ascensus Trust Company acted as custodian and Plan Trustee. The Company is the Plan Sponsor and acts as the Plan Administrator. The Company has contracted with Ascensus, Inc. to act as the Plan's third-party administrator. The day-to-day administration of the Plan is handled by the Company's Human Resources, Payroll, and Accounting Departments. All reasonable expenses necessary to operate and administer the Plan are paid by the Plan.

Basis of accounting – The accounting records of the Plan are maintained on the accrual basis in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of estimates - The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reported period. Actual results could differ from these estimates.

Employee contributions – Participants may elect to have the Company contribute a percentage of their pre-tax compensation to the Plan, up to the amount allowable under current income tax regulations. Participants who elect to have the Company contribute a portion of their compensation to the Plan agree to accept an equivalent reduction in taxable compensation. Participants may also elect to have the Company contribute a portion of their compensation after-tax in the form of a Roth deferral.

Employer contributions - The Plan permits discretionary company matching and profit sharing contributions. For the year ended December 31, 2024, the Company made matching contributions of the first 3% of compensation contributed by the respective participants totaling \$592,058, of which \$11,039 was funded with forfeitures. No profit sharing contributions were made for the year ended December 31, 2024.

Vesting - Participants' account balances generated from employer's matching and profit sharing contributions vest at the rate of 25% per year after the second year of service and are fully vested at the earliest of five years of service, normal retirement, or termination due to disability or death.

Forfeitures – Upon termination of employment, participants forfeit their non-vested balances. Forfeited balances of terminated participants' non-vested accounts are used to reduce future employer contributions. Forfeited non-vested accounts totaled \$46,751 and \$59,893 at December 31, 2024 and 2023, respectively. For the year ended December 31, 2024, forfeitures totaling \$11,039 and \$37,276 were used to reduce employer contributions and pay expenses, respectively.

Participant accounts – A separate account is maintained for each participant. Each participant's account is credited with the participant's employee contributions, employer contributions and an allocation of Plan earnings, less withdrawals, distributions and administrative expenses, if any. The benefit to which a participant is entitled is limited to the benefit that may be provided from the participant's vested account balance.

Investments – Investments of the Plan are held by the Plan's trustee and are invested based solely upon instructions from participants. Mutual fund investments are valued at fair market value based on market prices. Investments in common collective trusts are valued at estimated fair value, as provided by the custodian.

The Plan follows the guidance of GAAP for measuring fair value of investments. Those principles establish a framework for the measurement of fair value and provide a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level one measurements) and the lowest priority to unobservable inputs (level three measurements).

The three levels of the fair value hierarchy are described below:

Level one: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level two: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or

other means. If the asset or liability has a specified (contractual) term, the level two input must be observable for substantially the full term of the asset or liability.

Level three: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used should maximize the use of observable inputs and minimize the use of unobservable inputs.

The Plan's method of valuing investments may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan's management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Investment income – Realized gains or losses on investment transactions are recorded as the difference between the proceeds received and the fair value of the investment at the beginning of the Plan year, or cost if acquired during the Plan year. In accordance with the Plan's policy of stating investments at fair value, net unrealized appreciation or depreciation is included in the statement of changes in net assets in the period in which the market change occurs.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date.

Excess contributions payable - Excess contributions payable represent excess salary deferral contributions to be refunded by the Plan to participants in order to satisfy the relevant non-discrimination provisions of ERISA.

Notes receivable from participants - The Plan provides a provision that allows a participant to borrow up to the lesser of \$50,000 or 50% of their vested account balance, with a minimum borrowing of \$1,000. Such loans shall bear interest at prime rate plus 1% per annum. The term of the loans generally cannot exceed five years, except for the purchase of a principal residence, which may be repaid over a period of up to 30 years, and a participant may not have more than one loan outstanding at any time. The loans are secured by the participant's vested balance. Principal and interest are paid ratably through payroll deductions. Notes receivable from participants are stated at their unpaid principal balances plus any accrued but unpaid interest.

Payment of benefits - Upon termination of service or disability, retirement or death, the participants or beneficiaries receive, upon request, a lump-sum payment equal to the value of the vested funds in the participant's account. Benefits (which include rollover transfers to other plans) are recorded when paid. Accounts with a vested balance below \$1,000 at the time of termination will be cashed out. Accounts with a vested balance between \$1,000 and \$5,000 will be automatically rolled into an IRA. Hardship withdrawals are not allowed.

Plan termination - The Company intends to continue the Plan indefinitely for the benefit of its employees. However, it reserves the right to terminate the Plan at any time by resolution of its Board of Directors and subject to the provisions of ERISA. In the event the Plan is terminated in the future, participants would become fully vested in their accounts.

Subsequent events - The Plan's management evaluates events or transactions occurring after the statement of net assets available for plan benefits date but before the financial statements are available to be issued for potential recognition or disclosure. The financial statements include all subsequent events considered necessary for a fair presentation. Events or transactions occurring subsequent to year end through the date the financial statements were available to be issued, September 2, 2025, have been evaluated in the preparation of the accompanying financial statements.

2. INCOME TAX STATUS

The Internal Revenue Service has ruled in its determination letter dated June 30, 2020, that the Plan qualified under Section 401(a) of the Internal Revenue Code, and, therefore, is not subject to tax under present income tax law. The Plan has been amended since receiving the determination letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

4. RELATED PARTY TRANSACTIONS

For the year ended December 31, 2024, fees paid by the Plan to the Trustee, its affiliates and the Plan's investment manager, for investment management and recordkeeping services were included in Administrative Fees and totaled \$61,118. These transactions qualified as party-in-interest transactions.

5. RISK AND UNCERTAINTIES

The Plan provides for various investment options in any combination of investment securities offered by the Plan. Investment securities are exposed to various risks, such as interest rate, market fluctuations and credit risks. Due to the risk associated with certain investment securities, it is at least reasonably possible that changes in market values, interest rates or other factors in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

Financial instruments, which potentially subject the Plan to concentrations of credit risk, consist principally of mutual funds and a common collective trust. As the portfolio is well diversified and issuers of the funds' underlying securities are dispersed throughout many industries and geographies, the concentrations of credit risk are limited.
