## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of  
RSM Maintenance LLC 401(k) Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of RSM Maintenance LLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the period July 15, 2024 through December 31, 2024, and the related notes to the financial statements.

Management has obtained a certification from a qualified institution as of December 31, 2024, and for the period July 15, 2024 through December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

### NOTES TO FINANCIAL STATEMENTS

#### Note 1 - Description of the Plan:

**General** - The RSM Maintenance LLC 401(k) Plan (the “Plan”) became effective on July 15, 2024. RSM Maintenance, LLC (the “Company,” “Plan Sponsor,” and “Employer”), has general responsibility for the administration of the Plan, including, but not limited to complying with reporting and disclosure requirements, establishing and maintaining Plan records, and adopting amendments to the Plan. The Plan is subject to the provision of the Employee Retirement Income Security Act of 1974 (“ERISA”).

The following description provides only general information about the Plan. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

**Transfers In** - Effective July 15, 2024, the Plan was spun-off from the RSM 401(k) Plan. On July 22, 2024, assets totaling \$3,754,778 from the RSM 401(k) Plan were transferred to the Plan.

**Plan Administration** - The Plan is administered by the Plan Sponsor. The Plan’s assets are held by Principal Trust Company (the “Trustee”), who is responsible for the custody and management of the Plan’s assets.

**Eligibility** - The Plan is a defined contribution 401(k) plan covering substantially all qualifying employees of the Company, excluding union employees, nonresident aliens, and Puerto Rico residents. An employee is eligible to participate in the Plan upon completing two months of service and attainment of age 21. An eligible employee can enter the Plan on the first day of each month.

**Contributions** - Participants may make pre-tax elective deferrals and Roth contributions up to 75% of their annual compensation, as defined in the Plan agreement, up to the 401(k) deferral limit for the year. Those participants who have attained age 50 before the end of the Plan year are eligible to also make catch-up contributions to the Plan.

The Company makes a safe harbor matching contribution for all eligible participants in an amount equal to 100% of the first 3% of compensation contributed with an additional 50% of the next 2%.

In addition, the Plan provides for a discretionary profit sharing contribution that can be made by the Company. For the period ended December 31, 2024, no profit sharing contribution was made to the Plan. To receive a profit sharing contribution the individual must be an eligible employee as defined by the Plan documents and be employed on the last day of the Plan year.

**Participant Accounts** - Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s contribution and, (b) Plan earnings and losses and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Payment of Benefits** - On termination of service due to death, disability, retirement or other reasons, a participant or its beneficiary with a vested balance greater than \$7,000 may elect to receive either a lump-sum, equal monthly installments over a reasonable time or partial withdrawals. A participant with a vested balance of less than \$7,000 will receive the value of the vested interest in his or her account as a lump-sum distribution.

**Vesting** - Participants are immediately vested in their voluntary contributions, safe harbor matching contributions and rollover contributions plus actual earnings thereon. A participant's vested percentage in their account balance attributable to employer discretionary profit sharing contributions is based on vesting years of service as set forth below:

Less than 2	0%
2 but less than 3	20%
3 but less than 4	40%
4 but less than 5	60%
5 but less than 6	80%
6 or more	100%

**Forfeitures** - When a participant withdraws from the Plan and has a non-vested balance in their account this amount is forfeited. Forfeited accounts can be used to pay plan expenses or to reduce employer contributions. There were no forfeitures used or utilized in 2024. As of December 31, 2024, there was no forfeited non-vested account balance.

#### **Note 2 - Summary of Significant Accounting Policies:**

**Basis of Accounting** - The accompanying financial statements are prepared on the accrual basis of accounting.

**Use of Estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets available for benefits during the reporting period. Actual results, as determined at a later date, could differ from those estimates.

**Investment Valuation and Income Recognition** - The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchase and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the period.

**Money Market Fund** - Includes a money market account with a maturity of three months or less.

**Administrative Expenses** - Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participants account and are included in administrative expenses. Administrative and investment advisory fees are also included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

**Payment of Benefits** - Benefits are recorded when paid.

**Notes Receivable from Participants** - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

**Hardship Withdrawals** - The Plan provides for hardship withdrawals from participants' vested balances, not to exceed an amount required to meet an immediate need created by the hardship, and then only to the extent that such immediate need cannot be satisfied by other sources reasonably available to the participant. Permissible circumstances for hardship withdrawals include medical expenses, purchase of a home, tuition payments, amounts necessary to prevent eviction from the participants' personal residence, payments for burial or funeral expenses, expenses for the repair of damage to principal residence and such other circumstances as the Plan Administrator may determine in accordance with Internal Revenue Service rules and regulations.

**Risks and Uncertainties** - Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investment securities will occur in the near term and that such change could materially affect the participant's account balances and the amounts reported in the financial statements.

The Plan may have investments in securities with contractual cash flows, such as assets backed securities, collateralized mortgage obligations and commercial mortgage backed securities, including securities backed by sub-prime mortgage loans. The value, liquidity and related income of these securities are sensitive to changes in economic conditions, including real estate value, delinquencies or defaults, or both, and may be adversely affected by shifts in the market's perception of the issuers and changes in interest rates.

**Concentration of Investment Risk** - The Plan's investment in two funds at December 31, 2024 comprises approximately 51% of total investments.

**Subsequent Events** - The Plan Administrator has reviewed and evaluated all events and transactions from December 31, 2024 through September 8, 2025, the date the financial statements were available to be issued. The effects of those events and transactions that provide additional pertinent information about conditions that existed at the Statement of Net Assets Available for Benefits date have been recognized in the accompanying financial statements.

Subsequent to year end, the Plan name changed and is now called LEO FM 401(k). In 2025, the Plan Sponsor became Orion Group FM Holdings, LLC. Effective January 1, 2025, 8 plans merged into the Plan.

#### **Note 3 - Certified Investment Information:**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosures under ERISA. Accordingly, the Trustee, a qualified institution, has certified that the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- a) Investments, as shown in the Statement of Net Assets Available for Benefits as of December 31, 2024.
- b) Investment income, as shown in the Statement of Changes in Net Assets Available for Benefits for the period July 15, 2024 through December 31, 2024.

At the request of the Plan Administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule of assets (held at end of period).

#### **Note 4 - Fair Value Measurements:**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified contractual term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

- *Mutual funds* - Valued at the closing price in the active market in which the fund is traded.
- *Collective investment trusts* - Valued at the net asset value (NAV) of units of a bank collective trust. The NAV, as provided by the trustees, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. All collective trusts utilize NAV as the practical expedient to valuing the investment upon sale.

- *Pooled separate accounts* - Valued at their “accumulation unit value” (AUV). The separate accounts are valued daily as the number of accumulation units held multiplied by the AUV. The AUV is first established when a new fund starts and is then determined daily based on the net asset value of the shares of the underlying funds, the fund’s dividends and contract’s separate account charges. Fair value includes reinvested dividends and interest income, received and accrued, realized gains and losses, and unrealized gains or losses of the underlying separate account investments. There are no unfunded commitments at December 31, 2024. Redemptions can be made daily and there are no other restrictions or penalties. The pooled separate accounts invest primarily in mutual funds whose objective is to seek a high total rates of return primarily from current income and long-term capital appreciation.
- *Money market fund* - Valued at the closing price of similar assets in the active market in which the similar assets are traded.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### Transfers Between Levels

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period. For the period ended December 31, 2024, there were no significant transfers into or out of Levels 1, 2 or 3.

#### Note 5 - Collective Investment Trusts:

The Plan invests in investment contracts through its collective investment trusts (CITs). The CITs' fair value is a relevant measure attribute. The CITs held by the Plan are stable value investments which have an objective to preserve capital and to provide a competitive level of income over time that is consistent with the preservation of capital. To achieve this objective, the funds invest primarily in insurance contracts, corporate and financial institution investment contracts, traditional guaranteed investment contracts, synthetic guaranteed investment contracts, and cash equivalents. Redemptions are allowed for participants daily, however, in the event of a complete redemption, the Plan is subject to a twelve-month redemption notice period which may be waived by the trustee. There are no unfunded commitments at December 31, 2024.

#### **Note 6 - Pooled Separate Accounts:**

The Plan entered into pooled separate accounts with the Principal Life Insurance Company. The Principal Life Insurance Company maintains the contributions in pooled accounts. The pooled accounts are credited with earnings on the underlying investments and charged for Plan withdrawals and administrative expenses charged by the Principal Life Insurance Company.

#### **Note 7 - Plan Termination:**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of the Internal Revenue Code (IRC). In the event of Plan termination, participants would remain fully vested in their own contributions and in any employer contributions. Under no circumstances may the Company take ownership of any of the Plan's assets as a result of such termination.

#### **Note 8 - Notes Receivable from Participants:**

Participants may obtain loans from the Plan at a minimum of \$1,000 and a maximum of one half of a participant's account balance, or \$50,000 whichever is less, and are permitted only two loans outstanding at any time. Loans bear a rate of interest based on the prevailing interest rate and are collateralized by a participant's account balance. Loans are generally repaid through payroll deductions within five years except for loans utilized to purchase a primary residence which can have a term of ten years.

#### **Note 9 - Tax Status:**

The Plan was written on an Internal Revenue Service (IRS) non-standardized pre-approved document, which obtained its latest opinion letter on June 30, 2020 in which the IRS stated that the Plan as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and therefore believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.

#### **Note 10 - Parties-in-Interest:**

The Trustee provides administrative and investment management services to the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for such services totaled \$14,843 for the period July 15, 2024 through December 31, 2024.
