The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

## Notes to Financial Statements

### Note 1. Description of Plan

The following description of the Clarity Partners, LLC 401(k) Plan and Trust (Plan) is provided for general informational purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan covering the employees of Clarity Partners, LLC (Company), except for members of a collective bargaining unit, leased employees, and non-resident aliens. Employees who are age twenty-one or older and have completed six months of service are eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions:** Each year, participants may make pre-tax and Roth contributions subject to certain Internal Revenue Code (IRC) limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Company makes safe harbor nonelective contributions for each eligible participant in an amount equal to 3% of eligible compensation. For the year ended December 31, 2024, safe harbor nonelective contributions totaled \$453,713.

The Company may also elect to make discretionary matching or nonelective contributions to the Plan. To be eligible to share in allocations of discretionary Company contributions, employees must work 1,000 hours and be employed on the last day of the Plan year. Nonelective contributions are allocated as outlined in the Plan's adoption agreement. For the year ended December 31, 2024, discretionary nonelective contributions totaled \$41,400. There were no discretionary matching contributions in 2024.

Participants direct the investment of all contributions, including Company contributions, into investment options offered by the Plan. The Plan currently offers various mutual funds as investment options for participants.

**Participant Accounts:** Each participant's account is credited with the participant's contributions, Company contributions, and plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting:** Participants are vested immediately in their contributions and Company safe harbor contributions plus actual earnings thereon. Vesting in Company discretionary contributions (and earnings thereon) is based on years of continuous service. Participants vest over a 6-year graded schedule: 1 year-0%; 2 years-20%; 3 years-40%; 4 years-60%; 5 years-80%; 6 years-100%.

Participants become 100% vested upon reaching normal retirement age (age 65) and in the event of death or total and permanent disability.

## Notes to Financial Statements

### Note 1. Description of Plan (cont.)

**Notes Receivable from Participants:** Effective January 1, 2024, the Plan was amended to remove the provision enabling new participant loans.

**Payment of Benefits:** On termination of service due to death, disability, separation or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. In addition, in-service withdrawals are allowed after participants reach age 59 ½ or in cases of financial hardship.

The Plan has the ability to make automatic distributions without participant consent for terminated participants who fail to affirmatively elect a distribution and have a vested account balance under \$5,000.

**Forfeited Accounts:** At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$8 and \$7, respectively. Nonvested forfeitures will be used to offset expenses or reduce Company contributions. No forfeitures were used during 2024.

**Plan Expense Account:** Excess amounts generated by revenue sharing agreements between the record keeper and the various mutual funds that the Plan invests in are deposited by the record keeper in an account that can be utilized to pay allowable plan expenses. Related deposits are included in net appreciation in fair value of investments in the statement of changes in net assets.

There was no balance in the plan expense account at either December 31, 2024 or 2023. During 2024, Plan expenses of \$35,791 were paid from the plan expense account.

### Note 2. Summary of Accounting Policies

**Basis of Accounting:** The Plan's financial statements are prepared on the accrual basis of accounting.

**Use of Estimates:** The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition:** Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Sponsor determines the Plan's valuation policies utilizing information provided by the custodian. See Note 3 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### Note 2. Summary of Accounting Policies (cont.)

**Contributions:** Contributions from Plan participants and the safe harbor and non-elective contributions from the Company are recorded in the year in which employee contributions are withheld from compensation.

**Payment of Benefits:** Benefits are recorded when paid.

**Expenses:** Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Record keeping, investment advisory, and audit fees are included in administrative expense. Other investment related expenses are included in net appreciation of fair value of investments.

**Subsequent Events:** The Plan has evaluated subsequent events through June 30, 2025, the date the financial statements were issued.

### Note 3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

**Level 1** - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

### Note 3. Fair Value Measurements (cont.)

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

### Note 4. Certified Investments

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by the Plan's custodian, Empower Trust Company, LLC.

### Note 5. Related-Party Transactions and Party in Interest Transactions

Empower Trust Company, LLC is the non-discretionary custodian of the Plan. Administrative and recordkeeping fees of \$21,815 were paid to Empower in 2024. These transactions qualify as exempt party-in-interest transactions.

### **Note 6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in any Company contributions.

### **Note 7. Tax Status**

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the IRC. The Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **Note 8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
