## 1 - DESCRIPTION OF PLAN

The following description of the IGS Industries, Inc. ("Company") 401(k) Plan ("Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

### General

The Plan is a defined contribution plan covering substantially all full-time employees of the Company who have completed six (6) months of service with at least 83-1/3 hours of service each month, are twenty-one (21) years of age or older and are not covered by a collective bargaining agreement. The Plan's trustees manage the operation and administration of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

### Contributions

Each year, participants may make pretax contributions to the Plan up to the maximum percentage allowable by the IRC. Participants may also contribute amounts representing distributions from qualified defined benefit or defined contribution plans. Participants who have attained age 50, before the end of the Plan year, are eligible to make catch-up contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently has twenty-six (26) mutual funds and one (1) common/collective trust fund as investment options for participants.

The Company may elect to make a matching and/or non-elective contribution at the discretion of the Board of Directors. During 2024 and 2023, the Company elected to make a match of 100% of the first 2% of deferral, no non-elective contribution was authorized by the Board of Directors. Any discretionary non-elective contribution would be allocated to eligible participant accounts as defined in the Plan document. Contributions are subject to certain limitations.

### Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's matching contribution, if any, and (b) the Company's profit-sharing contribution, if any, and (c) Plan earnings (losses), and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or compensation, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Vesting

Participants are immediately vested in their elective, rollover, transfer, plus earnings thereon. Vesting in the Company's matching and non-elective contribution portions of their account, plus earnings thereon, is based upon years of continuous service, as defined. Participants are 100% vested in Company non-safe harbor matching and profit-sharing contributions after six (6) years of service.

### Notes Receivable - Participants

Participants may borrow from their accounts in amounts not less than \$1,000 up to a maximum of \$50,000, or 50% of their vested balance, whichever is less. The loans are secured by the balance in the participant's account with interest rates that are commensurate with local prevailing rates as determined by the Plan Administrator at the date of issuance. Currently, principal and interest are being paid ratably through monthly payroll deductions.

**Payment of Benefits**

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount, equal to the value in the participant's vested interest in his or her account, or annual installments over a specified period, as defined. In-service distributions may be made to participants, who have not separated from service, from their fully vested account upon attaining the age of 59½.

**Forfeited Accounts**

Non-vested account balances are used to pay administrative costs of the Plan, restore previously forfeited account balances, or reduce future Company contributions, as defined. At December 31, 2024, there were no non-vested balances. At December 31, 2023, terminated non-vested account balances in the amount of \$8,643.09 were used to reduce Company contributions.

**Investment Options**

The Plan allows participants to make their investments under a self-directed program. Under this program, participants invest their account balances in any one of twenty-seven (27) investment options currently offered by the Plan. Participants may transfer funds between investments and make changes in the allocation of future contributions among funds at any time by either calling or by accessing their accounts with the custodians of the Plan assets.

**2 - SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Presentation**

The financial statements of the Plan are prepared on the accrual basis of accounting and are prepared in conformity with U. S. generally accepted accounting principles ("GAAP") as issued by the Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC").

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians and insurance company. See Note 3 for discussion of fair value measurements.

**Use of Estimates**

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that may affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Payment of Benefits**

Benefits are recorded when paid.

### 3 - INVESTMENTS

#### Fair Value Hierarchy

FASB ASC Topic 820 defines fair value, establishes a framework for measuring fair value, and establishes a fair value hierarchy which prioritizes the inputs to valuation techniques. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction to sell the asset or transfer the liability which occurs in the principal market for the asset or liability or, in the absence of a principal market, the most advantageous market. Valuation techniques that are consistent with the market, income or cost approach, as specified by FASB ASC, and used to measure fair value.

The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value into three broad levels:

- Level 1: Valuations based on unadjusted quoted prices available in active markets for identical assets or liabilities. Since valuations are based on quoted prices that are readily and regularly available in an active market, valuation of these securities does not entail a significant degree of judgment.
  
- Level 2: Valuations based on quoted prices for similar assets in active or inactive markets, inputs other than quoted prices that are observable, or inputs that are derived principally from or corroborated by observable market data by correlation or other means.
  
- Level 3: Valuations based on inputs that are unobservable and significant to the overall fair value measurement.

The availability of observable inputs can vary from security to security and is affected by a wide variety of factors, including, for example, the type of security, the liquidity of markets, and other characteristics particular to the security. To the extent that valuation is based on models or inputs that are less observable or unobservable in the market, the determination of fair value requires more judgment. Accordingly, the degree of judgment exercised in determining fair value is greatest for instruments categorized in Level 3.

The inputs used to measure fair value may fall into different levels of the fair value hierarchy. In such cases, for disclosure purposes, the level in the fair value hierarchy within which the fair value measurement falls in its entirety is determined based on the lowest level input that is significant to the fair value measurement in its entirety.

#### Processes and Structure

Management is responsible for the Plan's fair value valuation policies, processes, and procedures. These control processes are designed to assure that the values used for financial reporting are based on observable inputs wherever possible. In the event that observable inputs are not available, the control processes are designed to assure that the valuation approach utilized is appropriate and consistently applied and that the assumptions are reasonable.

**Fair Value Measurements**

Fair value is a market-based measure considered from the perspective of a market participant rather than an entity-specific measure. Therefore, even when market assumptions are not readily available, the Plan's own assumptions are set to reflect those that the Plan believes market participants would use in pricing the asset or liability at the measurement date.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common/Collective Trust Fund:* Valued at the NAV of units of a collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Investments are initially recorded at their acquisition cost (if they were purchased) and at fair value (if they were received as a contribution). Subsequent to acquisition, investments are reported at their fair value. The net change in the difference between fair value and the cost of investments is reflected in the accompanying statement of changes in net assets available for benefits under the caption "Net Appreciation/Depreciation in Fair Value of Investments".

The net realized gain on investments is the difference between the proceeds received and the carrying value of the investments sold. The cost of the investments includes earnings that are reinvested. Realized gains and losses on investments are accounted for on an individual security basis. Investment income is recorded on the accrual basis.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

**4 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts. Any unallocated assets of the Plan will be allocated to participant accounts and distributed in such manner as the Company may determine.

**5 - INFORMATION PREPARED AND CERTIFIED BY CUSTODIAN**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule—including investments and notes receivable from participants held at December 31, 2024 and 2023, net appreciation in fair value of investments, and interest and dividends (including interest income on notes receivable from participants) for the years then ended—was obtained by management and agreed to or derived from information supplied to the plan administrator and certified as complete and accurate by a qualified institution, Alerus Financial, N.A. (the custodian of the Plan).

**6 - ADMINISTRATIVE EXPENSES**

Plan administrative expenses consisted of service and asset charges of approximately \$16,000 in 2024 and \$13,500 in 2023. Investment related expenses are included in net appreciation in market value of investments. Remaining operating and administrative expenses are paid directly by the Plan sponsor and amounted to approximately \$20,600 for 2024 and \$19,600 for 2023. The Plan sponsor is not reimbursed by the Plan; therefore, these amounts are not charged to the participants' accounts.

**7 - TAX STATUS**

The Internal Revenue Service has determined and informed the Sponsor by a letter dated June 30, 2020 that the Plan is designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable sections of the IRC and therefore, believes that the Plan is qualified and tax exempt.

GAAP prescribes rules for the recognition, measurement, classification, and disclosure in the financial statements of uncertain tax positions taken or expected to be taken in the Plan's tax returns. Management has determined that the Plan does not have any uncertain tax positions and associated unrecognized tax benefits that materially impact the financial statements or related disclosures. Since tax matters are subject to some degree of uncertainty, there can be no assurance that the Plan's tax returns will not be challenged by the taxing authorities and that the Plan will not be subject to additional tax, penalties, and interest as a result of such a challenge. Generally, the Plan's Federal returns remain open for income tax examination for three years from date of filing.

**8 - RISKS AND UNCERTAINTIES**

The Plan invests in various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect the participant's account balances and the amounts reported in the statements of net assets available for benefits.

**9 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are shares of mutual funds managed by Alerus Financial N.A. Alerus is the custodian under the Plan, and therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net appreciation (depreciation) in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. The third-party administration fees are excluded from the financial statements and are paid directly by the Plan sponsor.

**10 – SECURE ACT 2.0**

On Dec. 29, 2022, the Consolidated Appropriations Act of 2023 (HR 2617) was signed into law and included the SECURE Act 2.0, which includes over 90 new retirement provisions. Since the SECURE Act 2.0 includes both mandatory and optional provisions, the plan administrator will determine which optional provisions to elect, and the plan document will be amended accordingly. Most of the significant provisions became effective in 2024 and thereafter.

**11 - SUBSEQUENT EVENTS**

The Plan administrator has evaluated subsequent events in accordance with ASC Topic 855, “Subsequent Events”, through August 22, 2025, which is the date the financial statements were available to be issued and concluded that no subsequent events have occurred that would require recognition in the financial statements.
