## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator  
Skyline Displays 401(k) Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Skyline Displays 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The following description of the Skyline Displays 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering all eligible employees of Skyline Displays, LLC and participating employers (the Company). All employees of the Company, excluding nonresident aliens, union employees, interns, and part-time or temporary employees, are eligible to participate in the Plan upon date of hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Fidelity Workplace Services LLC provides recordkeeping services to the Plan, and Fidelity Management Trust Company (FMTTC) is the primary custodian for the Plan and serves as trustee. Matrix Trust Company was the custodian of the OneAmerica Stable Value Account until August 29, 2024, when all funds were transferred to FMTTC. The Company is the plan administrator and has overall responsibility for the operation and administration of the Plan. The plan administrator determines the appropriateness of the Plan's investment offerings and monitors investment performance.

**Contributions**

Participants may contribute up to 100% of annual eligible compensation, as defined in the Plan, and designate those contributions as either pre-tax or Roth. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollover). Participants are permitted to transfer the vested portion of their accounts to an In-Plan Roth transfer account subject to the Plan's provisions.

The Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their pre-tax deferral rate set at 1% of eligible compensation. Also, the Plan includes an automatic increase provision whereby participants who were automatically enrolled are automatically increased by 1% each March 1, with a ceiling of 5%, unless the participant elects otherwise.

The Plan provides a safe harbor matching contribution which is determined as a percentage of participant elected deferrals. The Company contributes 100% of deferrals up to 3% of eligible compensation and 50% of deferrals above 3% and up to 5% of eligible compensation.

Contributions are subject to certain Internal Revenue Service (IRS) limitations. Participants elect investment accounts in which their contributions, as well as Company contributions, are invested. The investment account options comprise various degrees of risk and return.

**Participant Accounts**

Each participant's account is credited with the participant's contribution and safe harbor matching contributions as well as investment earnings based on their selected investments. Participant accounts may be charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Notes Receivable From Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to \$50,000 or 50% of the participant's vested account balance, whichever is less. The loans are secured by the balance in the participant's account. The loan interest rate is set at 1% above the prime rate that was effective at the time the loan was issued, as defined. A participant may have two loans outstanding at a time. Principal and interest is paid ratably through monthly payroll deductions.

**Vesting**

Participants are vested immediately in their contributions and safe harbor matching contributions. Vesting in the nonelective employer profit sharing contributions and nonelective employer supplemental contributions portion of their accounts is based on years of service.

For the nonelective employer profit sharing contribution, after one year of service, a participant becomes 20% vested. The vesting increases by 20% each year so that a participant is 100% vested after five years of credited services.

For the nonelective employer supplemental contribution, after two years of service, a participant becomes 20% vested. The vesting increases by 20% each year so that a participant is 100% vested after six years of credited services.

A participant also becomes 100% vested upon reaching plan retirement age of sixty-five, death, or disability.

**Payment of Benefits**

On termination of service, death, disability or retirement, participants may elect to receive an amount equal to the value of the vested interest in their accounts in either a lump sum amount or in installments, depending on the size of the participant's account balance at the time of termination. Participants with a vested account balance of less than \$7,000 must take a lump-sum distribution. The account of a participant with a vested account balance between \$1,000 and \$7,000 who does not request a distribution will be rolled to an individual retirement account in the participant's name.

**Payment of Benefits (Continued)**

The Company may authorize certain withdrawals from a participant's account in the event of proven financial hardship. Hardship withdrawals are allowed from a participant's elective deferral account and are subject to specific statutory and regulatory requirements.

In-service distributions are permitted from all vested accounts when a participant has attained age 59½.

**Forfeitures**

Forfeited nonvested accounts may be used to reduce Company contributions or pay plan expenses. For the year ended December 31, 2024, \$14,413 of forfeitures were used to pay plan expenses. Unallocated forfeitures were \$11,080 and \$13,283 at December 31, 2024 and 2023, respectively.

**NOTE 2 — SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses when they are incurred.

**Contributions**

Contributions from participants and the associated Company contributions are recorded in the year in which the employee contributions are withheld from compensation.

**Payment of Benefits**

Benefits are recorded when paid.

**Expenses**

Plan expenses primarily consist of administration fees. Fees related to the administration of notes receivable from participants and benefit payments to participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments. Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements.

The Plan receives service provider credits (revenue sharing) which are based on a percentage of investments in the Plan. The Plan uses revenue sharing amounts to offset plan related fees. Revenue sharing in the amount of \$13,015 is included as an offset to expenses on the statement of changes in net assets available for benefits.

**Subsequent Events**

Subsequent events were evaluated through September 4, 2025, which is the date the financial statements were available to be issued.

**NOTE 3 — INFORMATION CERTIFIED BY THE CUSTODIAN AND TRUSTEE**

As stated in Note 1, the OneAmerica Stable Value Account remained at Matrix Trust Company until August 29, 2024. The dividends earned in this account were \$45,047 from January 1, 2024 to August 29, 2024. The OneAmerica Stable Value Account was \$0 and \$2,220,218 at December 31, 2024 and 2023, respectively. This information was obtained by management and agreed to or derived from information certified as complete and accurate by Matrix Trust Company for the time periods noted.

All remaining investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules held at December 31, 2024 and 2023, and net appreciation in fair value of investments, dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by FMTC.

**NOTE 4 — FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets. Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price reported by the fund, which is the quoted net asset value (NAV) of shares.

*Common/collective trust:* The stable value common/collective trust invests in a fund in which the underlying assets consist primarily of fully benefit-responsive investment contracts. The fund is valued at NAV, the practical expedient to estimate fair value. Participant transactions may occur daily.

*Pooled separate account:* The stable value pooled separate account invests in a fund in which the underlying assets consist primarily of fully benefit-responsive investment contracts. The fund is valued at NAV, the practical expedient to estimate fair value. Participant transactions may occur daily.

**NOTE 5 — PLAN TERMINATION**

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in Company contributions.

**NOTE 6 — PARTY-IN-INTEREST TRANSACTIONS**

Fidelity Workplace Services LLC provide recordkeeping services to the Plan. Creative Planning is the investment advisor of the Plan. UHY LLP is the auditor for the Plan. Total fees paid from the Plan to these entities, net of revenue sharing, for the year ended December 31, 2024 were \$113,808. These transactions qualify as party-in-interest transactions.

**NOTE 7 — TAX STATUS**

As this Plan is a pre-approved defined contribution plan, the IRS issued an opinion letter dated June 30, 2020, stating that while they do not issue a determination as to whether a specific employer's plan is qualified, any employer who adopts this plan document will be considered to have a plan qualified under code Section 401(a) of the Internal Revenue Code (IRC) provided all the terms are not more favorable for officers, owners, or highly compensated employees than for other employees. Management believes that the Plan is operating in compliance with all the terms provided in the nonstandardized plan agreement. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

The Plan is subject to examination by the IRS for the statutory period.

**NOTE 8 — RISKS AND UNCERTAINTIES**

The Plan invests in various types of investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 9 — DELINQUENT CONTRIBUTIONS**

During the year ended December 31, 2023, the Company failed to remit to the Plan's custodian certain employee contributions and loan repayments totaling \$242,163 within the period prescribed by the Department of Labor's regulations. The Company corrected these prohibited transactions in 2024 by making contributions to the affected participants' accounts for lost income in the amount of \$1,441.

During the year ended December 31, 2024, the Company failed to remit to the Plan's custodian certain employee contributions and loan repayments totaling \$100,324 within the period prescribed by the Department of Labor's regulations. The Company corrected these prohibited transactions in 2024 by making contributions to the affected participants' accounts for lost income in the amount of \$310.

We have audited the financial statements of Skyline Displays 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit] for the year ended December 31, 2024, and we have issued our report thereon dated September 4, 2025. As permitted by ERISA Section 103(a)(3)(C), our audit did not extend to any statements or information related to assets held for investment of the Plan (investment information) by Matrix Trust Company, the custodian of the OneAmerica Stable Value Account, and by Fidelity Management Trust Company, the trustee, which are a bank or similar institution or insurance carrier that are regulated, supervised, and subject to periodic examination by a state or federal agency, that prepared and certified the statements or information regarding assets so held in accordance with 29 CFR 2520.103-5. Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements and ERISA-required supplemental schedules, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP. Professional standards require that we provide you with information about our responsibilities under generally accepted auditing standards, as well as certain information related to the planned scope and timing of our audit. We have communicated such information in our engagement letter dated January 16, 2025. Professional standards also require that we communicate to you the following information related to our audit.

### Significant Audit Matters

#### *Qualitative Aspects of Accounting Practices*

Management is responsible for the selection and use of appropriate accounting policies. The significant accounting policies used by Skyline Displays 401(k) Plan are described in Note 2 to the financial statements. No new accounting policies were adopted and the application of existing policies was not changed during 2024. We noted no transactions entered into by the Plan during the year for which there is a lack of authoritative guidance or consensus. All significant transactions have been recognized in the financial statements in the proper period.

The financial statement disclosures are neutral, consistent, and clear.

#### *Form 5500 Procedures*

We are required to obtain and read a substantially complete draft of Form 5500 prior to dating our auditor's report. The purpose of this procedure is to identify any material inconsistencies between the draft Form 5500 and the Plan's financial statements. We identified no material inconsistencies in performing and completing our audit.

#### *Difficulties Encountered in Performing the Audit*

We encountered no significant difficulties in dealing with management in performing and completing our audit.

#### *Corrected Misstatements*

Professional standards require us to accumulate all misstatements identified during the audit, other than those that are clearly trivial, and communicate them to the appropriate level of management. Management has corrected all such misstatements. In addition, none of the misstatements detected as a result of audit procedures and corrected by management were material, either individually or in the aggregate, to the financial statements taken as a whole. The Adjusting Journal Entry Report is attached to this letter at Schedule A.

## *Reportable Findings*

For purposes of this letter, a reportable finding is a matter that includes one or more of the following: (1) noncompliance or suspected noncompliance with laws and regulations, (2) a finding that in our professional judgment is significant and relevant to you regarding your responsibility to oversee the financial reporting process, and (3) an indication of internal control deficiencies identified during the audit that have not been previously communicated to management by other parties and that we determined are sufficiently important to merit management's attention. We identified the following reportable findings:

We identified the following reportable findings:

### **Missed auto-enrollment**

In our testing of employee eligibility, we noted that one employee failed to be automatically enrolled in the Plan upon becoming eligible. We understand that a corrective contribution has been contributed for the affected employee. We recommend that the Plan Sponsor implement control procedures to prevent this type of error in the future.

### **Incorrect distribution of employer contributions**

During our reconciliation of employer contributions, we noted that the inadvertent extra remittances of employer contributions in 2023 were sent back to the Company in 2024. The funds should have been forfeited from the affected participant accounts to the forfeiture account rather than returned to the Company as the funds should remain in the Plan.

### **Incorrect corrective contribution source code**

During our reconciliation of employee contributions, we noted that the Company made a corrective contribution for an employee in 2024 related to a 2023 enrollment error. The corrective contribution was inaccurately remitted to the affected participant's account as a pre-tax contribution. The funds should have been remitted as a qualified non-elective contribution (QNEC). We recommend that the funds and any associated earnings be reclassified from the pre-tax deferral source to the QNEC source. In addition, we recommend that controls be implemented to ensure that future QNECs are remitted to the correct source.

### **Ineligible forfeitures**

In our calculations of forfeitures, we noted that the vesting percentage used to calculate the forfeiture was incorrect for multiple participants. This resulted in certain participants not receiving the full benefit of their account in which they are entitled. We recommend that the over forfeitures be distributed to them or restored to their participant accounts, as applicable, as soon as possible. In addition, we recommend that you implement procedures to verify that vesting percentages are correct in the Fidelity system, particularly for all participants who had a 5-year break in service at OneAmerica. If their funds were already forfeited at OneAmerica, their vested percentage at Fidelity should be updated to 100% so errors like this will not occur in the future.

## *Other Recommendations for Fiduciary Consideration*

### **Form 5330**

During our audit, we noted that a Form 5330 was not filed to fully correct the 2023 and 2024 late remittances. We recommend that the Plan Sponsor consult with a tax advisor regarding this issue.

## *Disagreements with Management*

For purposes of this letter, a disagreement with management is a disagreement on a financial accounting, reporting, or auditing matter, whether or not resolved to our satisfaction, that could be significant to the financial statements or the auditor's report. We are pleased to report that no such disagreements arose during the course of our audit.

### *Management Representations*

We have requested certain representations from management that are included in the management representation letter dated September 4, 2025.

### *Management Consultations with Other Independent Accountants*

In some cases, management may decide to consult with other accountants about auditing and accounting matters, similar to obtaining a “second opinion” on certain situations. If a consultation involves application of an accounting principle to the Plan’s financial statements or a determination of the type of auditor’s opinion that may be expressed on those statements, our professional standards require the consulting accountant to check with us to determine that the consultant has all the relevant facts. To our knowledge, there were no such consultations with other accountants.

### *Other Audit Findings or Issues*

We generally discuss a variety of matters, including the application of accounting principles and auditing standards, with management each year prior to retention as the Plan’s auditors. However, these discussions occurred in the normal course of our professional relationship and our responses were not a condition to our retention.

### *Other Matters*
