Certain accounting estimates are particularly sensitive because of their significance to the financial statements and because of the possibility that future events affecting them may differ markedly from management's current judgments.

There are no financial statement estimates that are significant to the Plan. Significant accounting estimates are not commonly inherent in a defined contribution plan with investments that are readily available on public markets.

Financial Statement Disclosures

The financial statement disclosures are neutral, consistent, and clear.

Significant Unusual Transactions

Professional standards require us to communicate significant unusual transactions to those charged with governance. We did not identify any significant unusual transactions.

Identified or Suspected Fraud

No such matters came to our attention.

Significant Difficulties Encountered in Performing the Audit

We encountered no significant difficulties in dealing with management relating to the performance of the audit.

Corrected and Uncorrected Misstatements

Professional standards require us to accumulate all known and likely misstatements identified during the audit, other than those that we believe are trivial, and communicate them to the appropriate level of management. Further, professional standards require us to also communicate the effect of uncorrected misstatements related to prior periods on the relevant classes of transactions, account balances or disclosures, and the financial statements as a whole. Recommendation:	We recommend correcting the errors by following the guidelines and methodologies described in the IRS's Employee Plans Compliance Resolution System (EPCRS). We also recommend implementing controls to prevent similar errors for happening in the future.
