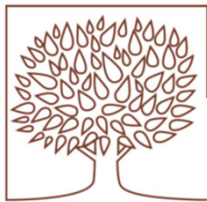

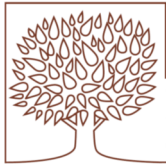

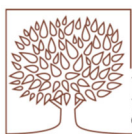

Note 1: DESCRIPTION OF PLAN

The following description of the Summit Golf Brands, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General — The Plan is a defined contribution plan covering substantially all employees of Summit Golf Brands Inc. (the "Employer" or the "Company") and any participating affiliates, who are age 21 or older. Employees are eligible to become a participant in the Plan after completing 1 month of service.

Ascensus Trust Company serves as the trustee of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan has a fiscal year ending December 31, coinciding with the Plan's sponsor, Summit Golf Brands, Inc.

Contributions — Each year, participants may contribute up to 90% of pre-tax annual compensation, not to exceed Internal Revenue Code limitations, as defined in the Plan document. Eligible employees may also elect to contribute an additional portion of their after-tax compensation, as permitted by law. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers a variety of mutual funds as investment options for participants.

The Company may, at its discretion, match participants' elective deferrals to the Plan. Beginning on October 1, 2022, the Company began making a discretionary match of 50% of elective deferrals up to 6%. Contributions are subject to certain Internal Revenue Service limitations.

Participant Accounts — Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Administrative charges related to participant loans and distributions are deducted directly from the respective participant's account. Investment expenses charged by the investments in which the Plan invests are paid directly from the underlying assets of the respective investment and are included in the net appreciation in fair market value of each type of investment in the statements of changes in net assets available for benefits. All other charges related to the administration of the Plan may be paid out of the Plan assets unless paid by the Employer.

Vesting — Participants are always fully vested in their accounts attributable to elective deferral and rollover contributions (if any). If a participant terminates employment due to death, disability, or attainment of age 65, then the individual is always 100% vested in his/her account balance. If the individual left the Company for any other reason, vesting of a participant's account attributable to matching contributions and any nonelective contributions plus earnings thereon is based on years of continued service according to the following vesting schedule:

Notes Receivable from Participants — Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear fixed interest rates at prime rate. For the year ended December 31, 2024, the interest rates ranged from 5.25% to 8.50%. Principal and interest are paid ratably through payroll deductions within 5 years unless the loan is used for the purchase of a primary residence which holds a maximum repayment of 30 years.

Payment of Benefits — Participants or their beneficiaries are entitled to receive the entire amount of their vested interest in the Plan upon retirement (normal retirement age is 65), early retirement date (the first day of the month coinciding with or following the date on which a participant or former participant attains age 55, and has completed at least 5 years of service with the Employer), death, disability, employment termination or proven financial hardship.

The benefits may be distributed to participants from the Plan in accordance with the following:

- a. A lump-sum distribution of your entire vested account balance.
- b. Installment payments or defer receiving payments until age 72. This option is only available to participants with vested account balances of \$5,000 or greater.

Withdrawals from a participant's salary deferral and rollover accounts may also be made in the event of a financial hardship, in accordance with the provisions specified in the Plan.

Forfeited Accounts — Forfeitures of employer matching contributions are used to reduce future employer matching contributions. As of December 31, 2024 and 2023 the balance in the forfeiture account was \$9,493 and \$9,020, respectively. No forfeitures were used to reduce the Company's contributions for each of the years ended December 31, 2024 and 2023.

Note 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting — The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition — The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

The Plan presents in the statements of changes in net assets available for benefits the net appreciation (depreciation) in fair value for each type of investment held by the Plan, which includes gains and losses on investments bought and sold, as well as held during the year.

Use of Estimates — The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires plan management to make certain estimates and assumptions that affect the reported amount of net assets available for benefits and contingent assets and liabilities at the date of the financial statements, and the stated amount of additions and deductions during the reporting period. Actual results could differ from those estimates.

Note 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Notes Receivable from Participants — Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Risk and Uncertainties — The Plan invests in various securities including mutual funds, corporate and municipal debt instruments, and corporate stocks. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Excess Contributions Payable — Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability and are reported as a reduction to employee contributions. There were no excess contributions to the Plan as of December 31, 2024 and 2023.

Expenses — Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Certain investment management expenses are paid directly by the Plan and are also included in administrative expenses, while other investment related expenses are included in the net appreciation in fair value of investments.

Benefit Payments — Benefit payments to participants are recorded upon distribution.

Reclassifications — Certain prior year amounts have been reclassified to confirm to current year presentation.

Subsequent Events — The Plan has evaluated subsequent events through September 5, 2025, the date the financial statements were available to be issued.

Note 3: FAIR VALUE MEASUREMENTS

The Plan values its assets and liabilities based on the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value into three broad levels as follows:

Level 1 - Quoted prices (unadjusted) in active markets that are accessible at the measurement date for identical assets or liabilities. The fair value hierarchy gives the highest priority to Level 1 inputs.

Level 2 - Observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in inactive markets or model-derived valuations in which all significant inputs are observable or can be derived principally from or corroborated with observable market data.

Level 3 - Unobservable inputs are used when little or no market data is available. The fair value hierarchy gives the lowest priority to Level 3 inputs.

In determining fair value, the Plan utilizes valuation techniques that maximize the use of quoted and observable inputs and minimize the use of unobservable inputs to the extent possible as well as considers counterparty credit risk in its assessment of fair value.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Note 3: FAIR VALUE MEASUREMENTS (continued)

Mutual Funds — Valued at the net asset value (NAV) of shares held by The Plan at year end using market prices on active markets (Level 1). Level 1 instrument valuations are obtained from real-time quotes for transactions in active exchange markets involving identical assets.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4: INFORMATION CERTIFIED BY THE TRUSTEE (UNAUDITED)

The Plan management has elected the method of compliance permitted by 29 CFS 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Ascensus Trust Company, the trustee of the Plan has certified to the completeness and accuracy of all investments and notes receivable from participants reflected on the supplemental schedule Form 5500, Schedule H, Part IV, Line 4i—Schedule of Assets (Held at End of Year) as of December 31, 2024; the related investment activity and interest income on notes receivable from participants reflected in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.

Note 5: RELATED-PARTY TRANSACTIONS

The Plan's investments managed by the trustee are considered exempt party-in-interest transactions. The Plan allows participants to take loans against their account balance which are also considered exempt party-in-interest transactions.

Note 6: PROHIBITED TRANSACTIONS

During 2022, the Plan sponsor failed to remit to the Plan's trustee \$42,992, of which \$16,196 represented employee contributions, \$10,863 represented missed employee contributions and \$15,933 represented plan sponsor employer match contributions within the period prescribed by Department of Labor regulations. Delays in remitting contributions to the trustee were due to administrative errors. Missed participant contributions and employer match contributions of \$26,796 are recorded as employer contributions receivable as of December 31, 2023. The Plan sponsor has made the appropriate contributions to the participants accounts in the Plan year ended December 31, 2024.

Note 7: PLAN TERMINATION

Although the Employer has not expressed the intent to terminate the Plan, it expressly reserves the right to amend or terminate the Plan at any time subject to provisions set forth by ERISA. In the event the Plan is terminated, participants are entitled to the entire net asset value of their account.

Note 8: FEDERAL INCOME TAX STATUS

The Company adopted a prototype standardized profit sharing plan with a deferral arrangement that received a favorable opinion letter from the IRS on June 30, 2020, which stated that the Plan and related trust are designed in accordance with applicable sections of the IRC. The Company identified certain operational omissions with respect to the Plan and has submitted an application under the Standardized Voluntary Compliance Resolution (SVCR) Program to the IRS. The Plan administrator and counsel for the Company expect that the final outcome of the SVCR process will not have any material effect on the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress.
