## Oreco Systems, Inc. Retirement Plan Notes to Financial Statements

---

### Note 1 – Description of Plan

The following description of the Oreco Systems, Inc. Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement, as amended, for a more complete description of Plan provisions.

**General** – Established December 1, 1987, the Plan is a defined contribution profit sharing plan which includes a salary deferral arrangement commonly referred to as a 401(k) plan. The Plan covers substantially all employees of Oreco Systems, Inc. (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company is the Plan's sponsor and serves as Plan Administrator.

During August 2024, the Company entered into a stock purchase agreement to sell all of the outstanding shares of the Company. Effective September 27, 2024, the Board of Directors (the Board) terminated the Plan. All participant accounts became fully vested. The Plan Sponsor has distributed all Plan assets as of March 27, 2025.

**Contributions** – Effective September 27, 2024, no employees of the Company were eligible to make contributions to the Plan, or receive contributions on their behalf, with respect to compensation paid after the termination date, and no employees were able to become new participants.

**Participant accounts** – Each participant's account is credited with the participant's contributions as well as allocations of the Company's contributions and Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances as defined. The benefit to which a participant is entitled is the benefit provided from the participant's vested account. Participants direct the investment of their account into various investment options offered by the Plan.

**Vesting** – Effective September 27, 2024, all participants were vested fully in their contributions and Company's contributions, plus actual earnings thereon.

**Payment of benefits** – On termination of service, a participant or beneficiary may elect to receive an amount equal to the value of the participants' vested interest in his or her account in a lump-sum distribution. In-service distributions may be made to a participant who has not separated from service but has attained age 62. Partial withdrawals or installments are only permitted for participants who must receive required minimum distributions. The final participant payout was completed on March 27, 2025.

### Note 2 – Summary of Significant Accounting Policies

**Basis of accounting** – The Company terminated the Plan effective September 27, 2024, and on that date, the Plan changed its basis of accounting to the liquidation basis.

Under the liquidation basis of accounting, assets are measured to reflect the estimated amount of cash expected to be collected in settling or disposing of the assets during the liquidation process and liabilities are measured using the accrual basis of accounting and would include any expected costs of the disposal of assets and other costs expected to be incurred during the liquidation process.

### Notes to Financial Statements

---

**Use of estimates** – The preparation of financial statements in conformity with GAAP requires the use of estimates and assumptions that may affect certain amounts and disclosures. Accordingly, actual results could differ from those estimates.

**Investment valuation** – The investments are reported at fair value. The Plan's custodians, Principal Life Insurance Company and Principal Trust Company, certify the fair value of all investments. If available, quoted market prices are used to value investments.

Fair value is the price that would be received to sell an asset or paid to transfer a liability (the exit price) in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

**Income recognition** – Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. The net depreciation in fair value of investments consists of both the realized gains and losses and unrealized appreciation and depreciation of those investments.

**Payments of benefits** – Benefits are recorded when paid.

**Expenses** – Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment related expenses are included in net depreciation of fair value of investments.

**Subsequent events** – Subsequent events are events or transactions that occur after the statement of net assets available for benefits in liquidation date but before the financial statements are available to be issued. The Plan recognizes in the financial statements the effects of all subsequent events that provide additional evidence about conditions that existed at the date of the statement of net assets available for benefits in liquidation, including the estimates inherent in the process of preparing the financial statements. The Plan's financial statements do not recognize subsequent events that provide evidence about conditions that did not exist at the date of the statement of net assets available for benefits in liquidation but arose after the statement of net assets available for benefits in liquidation date and before the financial statements are available to be issued.

The Plan has evaluated subsequent events through September 2, 2025, which is the date the financial statements were available to be issued.

#### **Note 3 – Fair Value Measurements**

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

**Level 1** – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

**Level 2** – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used at March 27, 2025, and November 30, 2024.

*Registered investment companies (mutual funds)* – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Pooled separate accounts* – Units held in pooled separate accounts (PSAs) are valued using the net asset value practical expedient (NAV practical expedient) of the PSA as reported by the account managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the PSA, minus its liabilities, and then divided by the number of units outstanding.

*Collective trusts* – Units held in collective trusts (CT) are valued using the net asset value practical expedient (NAV practical expedient) of the CT as reported by the CT managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the CT, minus its liabilities, and then divided by the number of units outstanding.

Investments held by the Plan contain no redemption restrictions or unfunded commitments. In addition, there are no significant restrictions on the ability to sell investments.

The Plan did not hold assets required to be included in the fair value hierarchy as of March 27, 2025. The following table discloses the fair value hierarchy of the Plan's assets by level as of November 30, 2024:

### **Note 4 – Tax Status**

The Plan Document is a volume submitter defined contribution plan that received a favorable opinion letter from the Internal Revenue Service on June 30, 2020, which stated that the Plan, as then designed, was in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

In accordance with guidance on accounting for uncertainty in income taxes, the Plan Administrator has evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **Note 5 – Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investments in the near term could materially affect a participant's account balance and the amounts reported in the statement of net assets available for benefits in liquidation.

### **Note 6 – Certified Investment Information**

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal Life Insurance Company and Principal Trust Company, the custodians of the Plan, have certified to the completeness and accuracy of:

- Investments reflected on the accompanying statements of net assets available for benefits in liquidation as of March 27, 2025, and November 30, 2024.
- Net depreciation in fair value of investments and dividends reflected on the accompanying statement of changes in net assets available for benefits in liquidation for the period ended March 27, 2025.

#### **Note 7 – Party-in-Interest Transactions**

The Plan paid expenses related to the Plan's operations and investment management to various service providers. Certain plan investments are managed by Principal Life Insurance Company and Principal Trust Company. Principal Life Insurance Company and Principal Trust Company are the custodians of the Plan. Zuna, LLC, is the investment advisor of the Plan. Transactions with Principal Life Insurance Company, Principal Trust Company, and Zuna, LLC, are considered exempt party-in-interest transactions. Fees paid by the Plan to Principal Life Insurance Company, Principal Trust Company, and Zuna, LLC, totaled \$43,671 for the period ended March 27, 2025. Fees paid by participants to Principal Life Insurance Company for distributions are included in benefits paid to participants in the Statement of Changes in Net Assets Available for Benefits in Liquidation.

#### **Note 8 – Reconciliation to Form 5500**

The Form 5500 has certain items that differ from amounts shown on the accompanying financial statements. These differences relate to classification only and have no effect upon net assets available for benefits for either period.
