Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Adobe Care and Wellness 401(K), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). 1. Description of plan:

The following description of the Adobe Care and Wellness 401(K) (Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions. The Plan was established January 1, 2018 and has been amended since that date.

General:

The Sponsor of the Plan is Adobe Care and Wellness LLC (Sponsor).

The Plan is a defined contribution retirement plan with 401(k) provisions consisting of a salary reduction arrangement. The Plan covers substantially all employees of the Sponsor who have completed three months of service and have reached the age of 21 years old. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Participant contributions:

Upon satisfying eligibility requirements, participants who do not affirmatively elect otherwise are automatically enrolled in the Plan with a pre-tax deferral rate of 3%. The Plan also provides for an annual 1% increase in deferral rates for participants who are deferring below 10% of compensation, for those participants who have not made an affirmative election. The annual 1% increase occurs on the anniversary of the participant's entry date and participants are able to opt-out of participation. Participants may elect to defer up to 90% of their annual compensation, subject to current statutory limits determined annually and prescribed by the Internal Revenue Service (IRS).

Participants may also elect to make Roth and catch-up contributions to the Plan. The Plan permits eligible participants to make additional voluntary contributions of qualified rollovers from other retirement plans.

Employer contributions:

The employer match formula uses a uniform rate equal to 100% of the participant's elective deferral up to 3% of the participant's compensation. Employer contributions are invested in the same funds and increments as directed by the participant's contributions.

The employer can also make a discretionary nonelective contribution to the Plan. For 2024, the employer did not elect to make this contribution.

Participants' accounts:

Each participant's account is credited with the participant's elective deferral, rollover and employer contributions, actual earnings thereon, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes to Financial Statements (continued)

Year Ended December 31, 2024

1. Description of plan (continued):

Vesting:

Participants are immediately vested in their elective deferral and any rollover contributions made to the Plan, plus actual earnings thereon. Vesting in the employer's contribution portion of the participant's accounts plus actual earnings thereon is based on years of credited service. Participants vest 20% per year, beginning with their first year of credited service and fully vest upon the completion of their fifth year of credited service or upon attaining their normal retirement date. The Plan defines a year of credited service to be a twelve consecutive month period commencing with the participant's hire date in which they perform an hour of service. Upon death or total disability of any participant prior to retirement, the participant's account balance shall become fully vested.

Participant loans:

The Plan allows for participants to obtain loans from the Plan. All loans require written spousal consent, cannot exceed 50% of the vested portion of the participant's account (or \$50,000 if less), and must be a minimum of \$500. All loans must be repaid within five years unless the proceeds are used for purchase of a principal residence, in which case the loan may be repaid over a term up to a 30-year period. Loans will provide for the repayment of interest at prime plus 2%. Principal and interest may be paid through payroll deduction. The participant's individual account serves as collateral for the loan. Loans will be considered in default if payments are not made for 90 days or if there is any outstanding principal remaining after the last scheduled repayment date. Upon default, death, disability or termination of employment, the entire outstanding principal and accrued interest shall be immediately due and payable. Because the participant's account collateralized the loan in its entirety, the credit quality of the participant is not assessed by the Plan Administrator. Unpaid loans will be treated as a taxable distribution from the Plan.

For financial reporting purposes, participant loans are included in the statement of net assets available for benefits as notes receivable from participants.

Investment options:

Upon enrollment in the Plan, a participant may direct contributions in any whole percentage increments into any of several different investment options. Participants may change their investment options at any time.

Hardship withdrawals:

A participant may withdraw a portion of his/her individual account balance (minimum \$500) to satisfy any of the following immediate and heavy financial needs: unreimbursed medical expenses for qualified persons, purchase of a principal residence, to prevent eviction from or foreclosure on a principal residence, to pay for post-secondary education expenses for qualified persons, funeral expenses or for expenses that qualify as a casualty deduction under the Internal Revenue Code (IRC).

1. Description of plan (continued):

Payment of benefits:

On termination of service due to death, disability, retirement or other reason, a participant whose vested account balance exceeds \$5,000 may elect to receive a lump sum payment equal to the value of their account balance, substantially equal installments or partial withdrawals of at least \$500. Participants with account balances less than \$5,000 must take a lump sum distribution as soon as practicable following termination. The Plan requires mandatory distributions under the Plan in excess of \$1,000 be automatically rolled over to an IRA established on behalf of participants who do not affirmatively consent to receive their distribution. The Plan also provides for in-service distributions (minimum \$500) for participants who have reached age 59.5.

Forfeitures:

Forfeitures of terminated employees' nonvested account balances, to the extent attributable to employer contributions, are used to pay for plan administrative expenses or reduce employer contributions.

2. Summary of significant accounting policies:

Basis of accounting:

The Plan's financial statements are prepared using the accrual method of accounting.

Estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition:

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Net appreciation in the fair value of investments includes both realized and unrealized gains and losses on investments bought and sold as well as held during the year.

2. Summary of significant accounting policies (continued):

Notes receivable from participants:

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the plan document. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payments of benefits:

Benefits paid to participants are recorded when paid.

Expenses:

Certain expenses of maintaining the Plan are paid by the Plan unless otherwise paid for by the Sponsor. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent events:

The Plan has evaluated the events that have occurred subsequent to December 31, 2024 through September 5, 2025, the date that the financial statements were available to be issued. The Plan has no responsibility to update these financial statements for events and circumstances occurring after this date.

3. Federal income tax status:

The Sponsor adopted a non-standardized pre-approved profit sharing plan published by ADP, LLC, who obtained its latest opinion letter on October 6, 2020, in which the IRS stated that the Plan and related trust, as then designed, were in compliance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator and the Sponsor believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan was qualified and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

4. Fair value measurements:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

4. Fair value measurements (continued):

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets or active markets that the Plan does not have access to;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Common/collective trust: The Plan holds an investment in the Invesco Stable Asset Fund. The fund is valued at the net asset value of units of the trust. The net asset value is used as a practical expedient to estimate fair value. The net asset value of the fund's units is determined daily and includes adjustments for investment fees. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months written notification in order to ensure that securities liquidations will be carried out in an orderly business manner; however, such withdrawals may occur before the expiration of the 12 month period. Participants may redeem units at any time at that day's net asset value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

6. Related party and party in interest transactions:

Exempt party in interest transactions:

Plan investments are managed by ADP Retirement Services (ADP). The Plan paid certain expenses to ADP and other service providers during 2024 related to plan administration and investment activity. These transactions qualify as exempt party in interest transactions under ERISA.

Related party transactions:

Expenses that are paid directly by the Sponsor are excluded from these financial statements. Employees of the Sponsor perform certain accounting and administrative functions for the Plan, however, no employee receives compensation from the Plan.

7. Plan termination:

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.
