To the Participants and Plan Administrator of SCS Direct 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of SCS Direct 401(k) Plan (the "Plan") an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. 1. Description of the Plan

The SCS Direct 401(k) Plan (the “Plan”) commenced on March 1, 2018. The following description of the Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan provisions.

General

The Plan is a defined contribution plan covering all eligible employees of SCS Direct, Inc. (the “Company” or the “Employer”) who have reached the age of eighteen and have completed six months of service. The Plan is subject to the provisions of the Employer Retirement Income Security Act of 1974 (“ERISA”). Reliance Trust Company (“Reliance”) holds all of the Plan’s investment assets and executes investment transactions. Reliance (“Trustee”) is the trustee for the Plan. ADP Retirement Services (“Recordkeeper”) performs substantially all record-keeping functions for participant accounts.

Participation

All eligible employees are automatically enrolled in the Plan with a 1% deferral percentage, unless the employee elects a different percentage, including 0% (opt out) after six months of service. Employees are eligible to participate in employer safe harbor matching contributions at the same time they are eligible for employee deferrals.

Contributions

Plan participants are allowed to make a pre-tax and/or Roth 401(k) after-tax contributions up to the maximum allowed by law of their eligible compensation (subject to Internal Revenue Code Section 401(k) elective deferral maximums). Participants can contribute from 1% to 90% of eligible compensation or a fixed dollar amount. In addition, eligible participants over the age of 50 may contribute additional “catch-up” contributions. The Company will contribute a safe harbor matching contribution up to 4% of eligible compensation. An employee must have deferrals in order to receive matching contributions. The Company may also make discretionary nonelective contributions based on eligible participant compensation as a percentage of total eligible compensation. There were no discretionary employer nonelective contributions made or declared for 2024. Participants may also contribute amounts representing distributions from other qualified plans to their account at any time during the Plan year (“rollovers”).

Participants self-direct the investment of both participant and employer contributions in their accounts into various investment options offered by the Plan (there are currently in excess of thirty investment options). If no investment election is made, contributions will be invested in a qualified default investment alternative comprised of target date funds.

Vesting

Participants are immediately vested in all amounts credited to their accounts.

Notes Receivable from Participants

Participants may borrow from their accounts varying amounts between a minimum of \$500 and a cumulative maximum equal to the lesser of \$50,000 or 50% of the participant's vested account balance. A participant may have a maximum of one loan outstanding at any given time. A loan to a participant shall be made solely from the assets of the participant's account. Loan repayments are withheld from payroll and remitted weekly, and the loan repayment period shall not exceed five years, except for loans used to acquire a principal residence for which the loan repayment period shall not exceed thirty years. The loans are secured by the balance in the participant's account and bear interest at a rate of prime rate plus 2%. Loan rates ranged from 5.25% to 10.50% at December 31, 2024.

Payment of Benefits

Upon termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum distribution or installments over a specified number of years. At the participant's option, their account balance may remain in the Plan if their vested balance exceeds \$5,000. The Plan allows for involuntary cash out distributions of terminated participants with balances of \$1,000 or less. Account balances that are greater than \$1,000 but less than \$5,000 will be subject to the applicable automatic IRA rollover requirements of Code Section 401(a)(31)(B).

Upon reaching age 59½, participants may elect distributions from their accounts without any tax penalty in accordance with the Internal Revenue Code. At age 72, there is a required distribution of a portion of the account balance, based on the life expectancy of the participant. Participants who demonstrate that a hardship (as defined under Internal Revenue Service Regulations) exists, may withdraw funds from their accounts.

Forfeited Accounts

All contributions credited to participant accounts are fully vested. As a result, there are no forfeitures applicable to the Plan.

2. Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

2. Summary of Significant Accounting Policies *(continued)*

Fair Value Measurements

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

U.S. GAAP guidance provides for the use of net asset value (“NAV”) as a “Practical Expedient” for estimating fair value of alternative investments. Pursuant to U.S. GAAP guidance, alternative investments where fair value is measured using NAV are not categorized within the fair value hierarchy.

Investment Valuation and Income Recognition

The Plan’s investments, consisting of shares of registered investment companies (“mutual funds”), are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Shares of mutual funds are valued at quoted market prices, which represent the NAV of shares owned at year-end and are deemed to be actively traded.

The common/collective trust is valued at the NAV of units held by the Plan. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

Payment of Benefits

Payments of benefits to participants are recorded when paid.

Administrative Expenses

The Plan permits the payment of administrative expenses to be made from the Plan's assets and for them to be allocated proportionately based on the value of the account balances of participants in the Plan. However, substantially all administrative expenses of the Plan are paid by the Company and are excluded from these financial statements. Expenses relating to specific participant transactions (i.e. loan setup, distribution request, annual account fee, etc.) are charged directly against the appropriate participant's account.

Subsequent Events Evaluation by Management

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is September 3, 2025.

3. Information Certified (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company, a qualified institution.

5. Common/Collective Trust

The Invesco Stable Asset Fund (the “Fund”) is a common/collective trust operated by Invesco Trust Company (“the Fund Trustee”). The Fund consists of four classes of units that wholly invests in Class C units of Invesco Stable Value Trust.

All investment contracts held by the Fund are entered into directly between the Fund and the issuer of the contract and are nontransferable. Fund units may be redeemed on a daily basis to meet benefit payments and other participant-initiated withdrawals permitted by retirement plans invested in the Fund. A participating trust invested in the Fund is required to provide 12 months’ irrevocable written notice of intent to redeem all or a portion of its participation in the Trust to the Fund Trustee prior to redemption of Fund units. There were no unfunded commitments as of December 31, 2024.

6. Tax Status

The Plan sponsor adopted a prototype plan document, which received an Internal Revenue Service (“IRS”) opinion letter dated October 6, 2020. The IRS has previously ruled that the Plan meets the requirements of Section 401(a) of the Internal Revenue Code and that the Plan is exempt from Federal income taxes. The Plan administrator and the Plan’s tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code. Accordingly, no provision for federal income taxes is included in the Plan’s financial statements.

6. Tax Status (*continued*)

U.S. GAAP requires the Plan administrator to evaluate tax positions taken by the Plan and recognize tax liability (or derecognize an asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has evaluated the Plan's tax positions and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or derecognition of an asset) or disclosure in the financial statements. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

7. Party-in-Interest Transactions

The Plan had notes receivable from participants of \$77,573 and \$24,711 outstanding at December 31, 2024 and 2023. These investments and the interest earned thereon qualify as parties-in-interest transactions, which are exempt from prohibited transaction rules under ERISA.

8. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan, subject to the provisions of ERISA.
