## Independent Auditor's Report

To the Plan Administrator and Board of Directors of  
The New England Center for Children, Inc. Supplemental Benefit Plan:

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of The New England Center for Children, Inc. Supplemental Benefit Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

**1. DESCRIPTION OF PLAN**

The following description of The New England Center for Children, Inc. Supplemental Benefit Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

**a. General**

The Plan is a defined contribution plan covering substantially all full-time employees of The New England Center for Children, Inc. (NECC) (the Plan Sponsor). The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Directors is responsible for oversight of the Plan. The Plan Administrator determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan Sponsor's Board of Directors.

**b. Eligibility**

Employees are eligible to participate in the Plan once they have reached the age of twenty-one, have one year of service, have completed 1,000 hours of service in the plan year, and are employed as of September 30<sup>th</sup> of the plan year, and employed on the last day of the plan year, or through their contract if a contracted employee. Modified weekend overnight floaters, residents of Puerto Rico, and leased employees are excluded from participating in the Plan.

**c. Contributions**

Participants are not permitted to make pre-tax or post-tax (Roth) contributions to the Plan, however, they are allowed to contribute amounts representing distributions from other qualified retirement plans (rollover contributions). NECC is permitted to make discretionary non-elective contributions in an amount as determined and approved by NECC's Board of Directors on an annual basis. Approved contributions are remitted into the Plan annually and remain unallocated in a holding account until the participant allocation is performed by the Plan's third-party administrator and approved by NECC. Contributions are allocated in an amount that depends on each participant's age and compensation during the plan year. Once approved, the funds, including related income, are transferred from the holding account into the participant's designation of investments within the Plan. Participants direct their own accounts once the annual contribution has been allocated to participants. NECC did not elect to fund a discretionary non-elective contribution for the year ended December 31, 2024.

**d. Participant Accounts**

Each participant's account is credited with rollover contributions, if any, and the allocations of NECC's contribution and plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on a participant's earnings or account balances, as defined by the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct their own accounts once the annual contribution has been allocated to participants.

**e. Vesting**

A participant is fully vested in their QNEC and rollover balances plus actual earnings thereon. A participant is credited with a year of vesting service for each calendar year in which the participant has worked 1,000 hours of compensated service. Participants become fully vested in NECC's contributions plus actual earnings thereon, subject to a three-year cliff vesting schedule. If participants are terminated before rendering three years of service, they forfeit the right to receive their accumulated benefits. A participant is fully vested after three years of continuous service, upon reaching the normal retirement age as defined in the plan document, or upon death or becoming disabled.

**f. Payment of Benefits**

The Plan provides for a normal retirement benefit to be paid to participants who have reached the retirement age of 65, with no option for early retirement. There are also retirement benefits available upon disability and death. Upon termination of service, a participant receives distributions in the form of either a lump-sum distribution of the participant's account balance, or through installments over a period of time. The Plan requires balances up to \$1,000 be paid out to participants upon termination and requires balances from \$1,000 to \$5,000 be rolled over to an individual retirement account (IRA). Effective January 1, 2024, the limit of involuntary force-out distributions increased to \$7,000 under the provisions of SECURE Act 2.0.

**g. Notes Receivable from Participants**

Notes receivable from participants are not permitted.

**h. Forfeited Accounts**

Forfeitures represent the non-vested portion of NECC contributions forfeited by participants who terminate their employment or withdraw from the Plan prior to becoming fully vested. Forfeited non-vested accounts may be used to reduce future Plan Sponsor contributions or plan expenses, as defined by the plan document. There were \$27,412 and \$25,205 in unallocated forfeitures as of December 31, 2024 and 2023, respectively. Forfeitures of \$1,599 were used to pay plan expenses for the year ended December 31, 2024.

**Basis of Presentation**

The Plan prepares its financial statements in accordance with generally accepted accounting principles (U.S. GAAP) established by the Financial Accounting Standards Board (FASB). References to U.S. GAAP in these notes are to the FASB Accounting Standards Codification (ASC).

**Use of Estimates**

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)**

**Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value, except for the fully benefit-responsive investment contract which is reported at contract value (see Note 5). Units held by the Plan in pooled separate accounts are based on each fund's daily net asset value (NAV) as a practical expedient, which is considered by the Plan's management to be the best approximation of fair value. None of the Plan's investments are traded on public exchanges and are redeemable only by the issuer. The Plan Sponsor determines the Plan's valuation policies utilizing information provided by the qualified institution. See Note 4 for discussion of fair value measurement.

Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

**Contributions**

NECC contributions are recorded when such contributions are authorized by the Plan Sponsor's Board of Directors.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by NECC and are excluded from these financial statements. Recordkeeping and asset management fees are charged directly to the participant's account and are included in administrative expenses in the accompanying statement of changes in net assets available for benefits. Investment-related expenses are included in net appreciation of investments.

**Subsequent Events**

Subsequent events have been evaluated through September 2, 2025, which is the date the financial statements were available to be issued. There were no events that met the criteria for recognition or disclosure in the financial statements.

**3. INFORMATION PREPARED AND CERTIFIED BY THE PLAN'S QUALIFIED INSTITUTION**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Voya Retirement Insurance and Annuity Company (Voya), a qualified institution, has certified to the completeness and accuracy of all investments reported in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, and the supplemental schedule, Form 5500, Schedule H, Part IV, Line 4i - Schedule of Assets Held at End of Year as of December 31, 2024, and the related investment transactions and investment income reported in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.

At the request of the Plan Administrator, the Plan's independent auditors did not perform auditing procedures with respect to certified investment information, except for comparing such certified investment information included in the accompanying financial statements and supplemental schedule.

**4. FAIR VALUE MEASUREMENT**

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants as of the measurement date. *Fair Value Measurement* establishes a hierarchy of the valuation techniques based upon whether the inputs to those valuation techniques reflect assumptions other market participants would use based upon market data obtained from independent sources (also referred to as observable inputs). The fair value hierarchy is as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value:

*Pooled separate accounts:* The fair value of accumulation units held by the Plan in pooled separate accounts is based on each account's daily NAV as a practical expedient, which is considered by the Plan's management to be the best approximation of fair value. The NAV is used as a practical expedient to estimate the fair value, unless it is probable that all or a portion of the pooled separate accounts will be sold for an amount different from NAV. As of December 31, 2024 and 2023, the Plan has no plans to sell the pooled separate accounts at amounts different from NAV. Pooled separate accounts are not exchange traded. Data for NAV is available daily to the Plan Administrator and client investors via the Voya website and provides sufficient corroborative evidence to ascertain the relationship between each fund's NAV and the values of individual underlying holdings. Underlying holdings are primarily valued using market quotations or prices obtained from independent pricing sources. Redemption frequency and notice period are available on a daily basis. There are no unfunded commitments from participants in the Plan who invest in these accounts.

There has been no change in the valuation methodology used as of December 31, 2024 and 2023.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Certain investments that are measured at fair values using the NAV per share (or its equivalent) as a practical expedient have not been classified in the fair value hierarchy. Accordingly, the pooled separate accounts have not been classified in the fair value hierarchy as of December 31, 2024 and 2023.

- (b) The funds' portfolios invest in a combination of underlying funds, which are actively managed funds or passively managed funds that invest in U.S. stocks, international stocks, U.S. bonds, and other debt instruments and it uses an asset allocation strategy designed for investors expected to retire in a specific year.
- (c) These funds invest primarily in common stocks of established U.S. companies that have above-average potential for capital growth. The investment funds also may invest in other securities, including convertibles, warrants, preferred stocks, corporate and government debt, bank loans, and options.
- (d) These funds invest in an income generating stock while preserving capital that invests in fixed income securities, such as corporate, government and mortgage bonds, which at the time of purchase are rated investment grade.
- (e) These funds seek capital appreciation and invest in small capitalization companies defined as companies that are included in the S&P Small Cap 600 Index or Russell 2000 Index at the time of purchase.
- (f) This fund seeks the maximum current income that is consistent with maintaining liquidity and preserving capital. The fund intends to maintain a stable \$1 share price.

**5. GUARANTEED INVESTMENT CONTRACT**

The Plan has a guaranteed investment contract with Voya. Voya maintains the contributions in a general account. The account is credited with participant contributions and investment income and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measure attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported by Voya, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal of all or a portion of their investment at contract value. The contract limits the percentage of the investment for periodic elective transfers to variable investments within the Plan during any twelve-month period.

The contract is guaranteed against loss of principal, minus all withdrawals, including charges and adjustments. The guarantee is based on the ability of the qualified institution to meet the financial obligations from the general assets of Voya. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 1%. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events may limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan); (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan; or (4) the failure of the trust to qualify for exemption from Federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

The guaranteed investment contract does not permit Voya to terminate the agreement prior to the scheduled maturity date.

**6. TAX STATUS**

The Plan Sponsor has obtained an opinion letter dated June 30, 2020, in which the Internal Revenue Service (IRS) stated that the restated prototype plan document was in compliance with applicable requirements of the Internal Revenue Code (IRC). The Plan Administrator timely adopted the restated prototype plan. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is currently being operated in accordance with the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognizes a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

**7. PLAN TERMINATION**

Although it has not expressed any interest to do so, NECC has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants become fully vested in the Plan and all accrued benefits shall be paid to participants in accordance with the provisions of the Plan.

**8. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

ERISA defines a party-in-interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan or an employer whose employees are covered by the Plan. Accordingly, transactions with investment funds managed and held by the qualified institution are considered party-in-interest transactions. During 2024, the Plan paid asset management, investment transaction and administrative fees of \$49,263 to the qualified institution and advisor.

**9. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.



