Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of The Solomon R. Basis for Opinion

1. Description of Plan

The following description of The Solomon R. Guggenheim Foundation 403(b) Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Summary Plan Description and any amendments for a more complete description of the Plan’s provisions.

General

Effective January 1, 1990, The Solomon R. Guggenheim Foundation (the “Foundation”), adopted the Plan. The Plan is a defined contribution plan covering all employees, except for excluded employees as noted below. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Eligibility

The Foundation offers the Plan to eligible employees. Eligible employees may make deferred voluntary contributions as soon as they join the Foundation. Eligible employees must complete two years of service (1,000 hours) to qualify for employer contributions.

An employee may not join the Plan (excluded) if they are eligible to participate in another 403(b) annuity contract or custodial account of the employer, eligible to participate in a 401(k) plan of the employer, a non-resident alien or an employee who is a student performing services described in Internal Revenue Code (“IRC”) section 3121(b)(10).

Employees who normally work fewer than twenty hours per week are not eligible for employer contributions. In addition, employees in the Plan who are collectively bargained are not eligible for employer contributions unless otherwise noted in the union contract to which the employer is a party.

Contributions

Each year, eligible participants may contribute a portion of their annual compensation on a pre-tax or after-tax (Roth) basis subject to a maximum amount that is determined by the Internal Revenue Service (“IRS”). The Plan was amended effective January 1, 2023 for an auto enrollment provision of 3% for newly eligible participants. The Plan was also amended effective January 1, 2020 to make employer contributions (non-elective employer contributions and matching employer contributions) for eligible employees discretionary for the employer. For 2024, the Plan provided for a non-elective employer contribution of 3% (less than 10 years of service) or 5% (more than 10 years of service) of eligible compensation and a matching contribution that is the minimum of a) 50% of employee elective deferrals or 50% of the first 5% of eligible compensation for eligible employees. The annual employer discretionary contributions, if any, are paid after year end only to eligible participants. Effective July 1, 2023, the Plan was amended for participants whose employment ended on or after July 1, 2023, to receive a pro-rata allocation of the annual employer discretionary contribution and employer matching contribution.

Participant Accounts

Each participant’s account is credited with the participant’s contribution and allocations of (a) the Foundation’s contributions and (b) Plan earnings (losses), and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. All investments are participant directed, and if no investment election is provided it is directed to a target date fund.

Vesting

A participant is 100% vested in his or her accounts including allocated earnings thereon at all times.

Plan Termination

Although it has not expressed any intention to do so, the Foundation has the right under the Plan to terminate the Plan subject to the provisions of ERISA.

Withdrawals

Upon reaching the age of 59 ½, participants may withdraw all or a portion of their account balance attributable to salary deferral contributions, employer non-elective contributions, and matching contributions. A participant may withdraw all or a portion of rollover contributions at any time. Hardship withdrawals are permitted under certain circumstances.

Notes Receivable from Participants

The Plan offers a loan feature whereby a participant (“borrower”) enrolled in the Plan may borrow a minimum amount of \$1,000 up to a maximum of 50% of the vested account balance or \$50,000 (whichever is less). Participants may take a loan once in any 12 consecutive-month period, subject to the IRC limits on the total amount that can be borrowed. Participants may only have three outstanding loans at a time. The interest rate is based on the prime rate plus 1%. Loans must be repaid within five years, unless the loan is used to purchase a participant’s principal residence or the participant is on authorized leave for military service for a period which extends the maturity date of the loan beyond five years.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accounts of the Plan are maintained, and the accompanying financial statements have been prepared, on the modified cash basis, which is a basis of accounting other than accounting principles generally accepted in the United States of America (“U.S. GAAP”). Under this basis, investment income is recognized when received and disbursements are recognized when made, except for investments which are reflected at fair value. Accordingly, the financial statements are not intended to present the net assets available for benefits and changes in net assets available for benefits of the Plan in conformity with U.S. GAAP.

2. Summary of Significant Accounting Policies (continued)

Use of Estimates

The preparation of financial statements requires management to make certain estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Fair Value Measurements

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist. At December 31, 2024 and 2023, all of the Plan's investments, that were valued at fair value, were valued using level 1 inputs.

Investment Valuation and Income Recognition

All of the Plan's investments are stated at fair value except for the guaranteed investment contracts, which are valued at contract value since they are fully benefit-responsive. The guaranteed investment contracts are valued by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the credit worthiness of the issuer. Mutual funds held by the Plan are valued at fair value based on the daily closing price as reported by the funds. All of the mutual funds are registered with the Securities and Exchange Commission. These mutual funds are required to publish their daily net asset value and to transact at that price and are deemed to be actively traded. Personal choice retirement accounts are considered to be self-directed accounts and are valued based on the account's underlying investments held as of the end of the plan year. The personal choice retirement accounts consist of: mutual funds and money market funds.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant ceases to make loan repayments and the plan administrator deems the loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Expenses

The costs of administering the Plan may be shared between employees and the Foundation. In addition, some costs of administering the Plan may be paid from Plan assets. Any Plan administrative fees that are actually deducted from participant's accounts will be disclosed on quarterly Plan statements. Any Plan administrative fees are in addition to any expenses of the underlying investment options available under the Plan. In addition, a Plan service credit may be added to a participant's account. If applicable, the Plan service credit will lower the effective annual expense ratios of the investment fund(s) for which a Plan service credit applies. Any Plan service credit will be disclosed on a participant's quarterly Plan benefit statement.

Investment related expenses are included in net appreciation in fair value of investments.

ERISA Spending Account

The Plan and Transamerica Retirement Solutions, LLC ("TRS") have entered into an arrangement whereby a portion of the revenue earned by TRS from certain funds is passed through to the Plan for payment of permitted plan expenses or allocation to participants. In order for the Plan to receive credits as a result of this revenue sharing arrangement, and to use this credit to pay plan expenses, the Foundation created the ERISA Spending Account. The ERISA Spending Account is an account within the Plan, similar in design to forfeiture accounts, and is used to record keep the redistribution of plan-generated fund revenue that exceeds the costs associated with plan administration. The ERISA Spending Account balance was \$49,828 and \$41,579 at December 31, 2024 and 2023. During 2024, \$52,029 of Plan expenses were reduced by the ERISA Spending Account.

Subsequent Events Evaluation by Management

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is August 25, 2025.

3. Information Certified (Unaudited)

Certain information related to investments and notes receivables from participants disclosed in the accompanying financial statements and ERISA-required Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) including investments and notes receivables from participants held at December 31, 2024 and 2023, and net appreciation in value of investments, interest on notes receivable from participants and interest and dividend income for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by the State Street Bank and Trust Company and Transamerica Financial Life Insurance Company Inc. ("TFLIC"), qualified institutions.

5. Investments at Contract Value

Guaranteed Investment Contracts

The Plan invests in the Transamerica Guaranteed Investment Option ("GIO"), which is provided under a group annuity contract issued by TFLIC. The GIO is part of the general assets of TFLIC. Participant-elected withdrawals are generally paid at contract value. The GIO is fully benefit-responsive and, therefore, is stated at contract value on the statements of net assets available for benefits. A participant may elect to withdraw all or a portion of their balance in the GIO at contract value without a market value adjustment or surrender charge for any of the following reasons: disability, death, retirement or severance from employment, hardship, compliance with a qualified domestic relations order, attainment of at least age 59 ½, in-service withdrawals from the Plan, loans, transfer to a non-competing fund subject to a 90 day equity wash, and the purchase of an annuity from TFLIC.

The guaranteed investment option contract ("GIC") between TFLIC and the Foundation is provided under a group annuity contract issued by TFLIC. The GIC is part of the general assets of TFLIC. Participant elected withdrawals are generally paid at contract value.

The GIO and GIC are fully benefit-responsive and, therefore, are stated at contract value on the statements of net assets available for benefits.

6. Tax Status

On March 31, 2017, the Internal Revenue Service ("IRS") issued an opinion letter to the prototype document preparer indicating that the Plan, as then designed, qualifies under Section 403(b) of the IRC. The Plan has been amended since receiving the opinion letter and the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

7. Party-In-Interest Transactions

Certain investments are managed by TFLIC. TFLIC is a custodian as defined by the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statement of net assets available for benefits.

8. Prohibited Transactions

During the 2023 Plan year, the Foundation failed to transmit to the Plan certain participants' contributions totaling \$274,200 within the period described by Department of Labor regulations. Delays in remitting these amounts to the Plan were due to an administrative oversight. Plan management calculated and remitted lost earnings for the delinquent contributions in October 2024.

9. Risks and Uncertainties

Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
