INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of the Kistler O'Brien Fire Protection Employees 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Kistler O'Brien Fire Protection Employees 401(k) Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) Audit). Notes to Financial Statements December 31, 2024 and 2023

1. Description of Plan

The following description of the Kistler O'Brien Fire Protection Employees 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Geo. W. Kistler, Inc. d/b/a Kistler O'Brien Fire Protection (Company) who have completed two consecutive months of service. Eligibility for Company discretionary profit sharing contributions requires the completion of one year of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The plan administrator is responsible for the oversight of the Plan and determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Company's Board of Directors.

The Company was acquired by Encore Holdings, LLC (Encore) on October 2, 2023. On December 31, 2024, Encore approved the merger of the Plan into the Encore Holdings, LLC 401(k) Plan (Encore Plan) (Note 10).

Effective December 31, 2024 the Plan was frozen; no contributions were permitted and all active participants became 100% vested in the portion of their individual account derived from employer matching and profit sharing contributions. Participants could continue to withdraw funds from the Plan.

Contributions

Each year, participants in the Plan may elect to contribute a portion of eligible compensation, as defined in the Plan. There are two types of salary deferrals, pretax 401(k) deferrals and Roth 401(k) deferrals. Participants who have attained age 50 before the end of the Plan year are also eligible to make catch-up contributions. Participants and eligible employees may also contribute amounts representing distributions from retirement plans and certain individual retirement accounts. The Plan also provides for additional deferral contributions for payroll periods designated by the Company. In addition, the Plan has an automatic enrollment feature with an initial pre-tax deferral rate of 4%; these contributions are invested in the most appropriate target date allocation investment based on the participant's date of birth. Participants who are automatically enrolled may have their contributions increased by 1% each year on January 1 until a deferral rate of 10% is reached.

The Plan provides for discretionary Company matching and profit sharing contributions. For 2024, the Company matching contribution was 50% of the first 6% of eligible compensation that a participant contributed to the Plan and there was no profit sharing contribution.

Participants direct the investment of all contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and a common collective trust as investment options for participants. Contributions are subject to certain IRS limitations.

Participant Accounts

Each participant's account is credited with the participant's contribution and Company matching contributions as well as allocations of the Company's discretionary nonelective contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant compensation, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their account, including earnings thereon, is based on years of credited service and a graduated vesting schedule, with 100% vesting after completion of six years of credited service.

Notes Receivable from Participants

Participants may borrow from their investment accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear a fixed rate of interest based on the prime rate at the time the loan was established. Principal and interest is paid ratably directly through payroll deductions.

Payment of Benefits

A participant may receive a distribution of the vested portion of their account on separation from service with the Company. Voluntary distribution options include a lump sum payment, partial payments, and installment payments. A participant whose vested balance is \$5,000 or less cannot defer receipt of their distribution.

The Plan also provides for in-service withdrawals for participants who have attained age 59½ and for hardship distributions. Amounts from a participant's rollover account can be withdrawn at any time.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited accounts totaled \$7,743 and \$5,805, respectively. These accounts will be used to reduce future employer contributions. Also, in 2024, employer contributions were reduced by \$40,752 from forfeited nonvested accounts.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan administrator determines the Plan's valuation policies utilizing information provided by investment advisers and Ascensus Trust Company (Trustee). See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. Related fees are recorded as administrative expenses and are expensed when incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and fees related to benefit payments are charged directly to the participant's account and are included in administrative expenses and were \$8,310 in 2024.

3. Information Certified by Trustee

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Ascensus, LLC, as agent for the Trustee, has certified that the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024
- Investment information included in the accompanying Schedule H, Line 4i, schedule of assets (held at end of year) as of December 31, 2024

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing prices as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common Collective Trust: The units of the common collective trust fund are valued using the NAV as a practical expedient as determined by the issuer based on the fair value of the underlying assets within the fund and the present value of future cash flows using the current discount rate (Note 5).

5. Investment Contract

The Plan has an investment in the MetLife GAC-25053 Class 0 Fund (Fund), which is a common collective trust fund. The Fund generally invests in bonds with short-to-intermediate term maturities, and insurance contracts which aim to provide price protection. In addition, the Fund maintains a wrapper contract issued by insurance companies and other financial institutions designed to allow the portfolio to maintain a constant NAV and to protect the portfolio in extreme circumstances. Participants may generally redeem units on a daily basis at NAV which represents contributions made to the collective trust fund plus earnings less participant withdrawals and administrative expenses.

Certain events may limit the ability of the Plan to transact at NAV with the Fund. Such events include Plan sponsor events that cause a significant withdrawal from the Plan, such as a Plan level liquidation, and the availability of uncommitted cash and liquid investments available on the requested redemption date. The plan administrator believes that no events are probable of occurring that would limit the Plan's ability to transact at NAV with participants.

6. Administration of Plan Assets and Expenses

The Plan's assets are administered under a contract with the Trustee. The Trustee invests funds received from contributions, investment sales, interest and dividend income and makes payments to participants for distributions and loans. The Plan also has a recordkeeping services agreement with The Vanguard Group, Inc. (Vanguard). Vanguard, through Vanguard Retirement Plan Access Services provides recordkeeping, administration and compliance services (collectively Recordkeeping Services) as outlined in the agreement.

Recordkeeping Services are allocated to participants on pro-rata basis based on their account balance and were \$50,683 in 2024 and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Certain administrative functions are performed by officers and employees of the Company. No such officer or employee receives compensation from the Plan.

7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

8. Tax Status

The Plan adopted a non-standardized pre-approved profit sharing plan with cash or deferred arrangement, which received a favorable opinion letter from the IRS dated June 30, 2020 indicating that the Plan was acceptable under section 401 of the Internal Revenue Code (IRC) for use by employers for the benefit of their employees (Opinion Letter). Although the Plan has been amended since receiving the Opinion Letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC the related trust is tax exempt.

9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

The Plan had investments of \$4,828,946 at December 31, 2024 and \$4,141,960 at December 31, 2023, concentrated in two investments.

10. Subsequent Events

The Plan has evaluated, for consideration of recognition or disclosure, subsequent events that have occurred through the date of issuance, August 25, 2025, and has determined that, except for the matters noted below, no significant events occurred after December 31, 2024, but prior to the issuance of these financial statements, that would have a material impact on these financial statements.

Effective January 1, 2025 the Company was merged into Encore and ceased to exist as a separate legal entity and Encore became the sponsor of the Plan. The Company's employees became employees of Encore and were permitted to participate in the Encore Plan.

Effective May 30, 2025, all of the investments were liquidated and transferred to, and received by, the Encore Plan on June 2, 2025. After the merger and transfer of assets, the Plan will cease to exist.
