### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed the audits of the financial statements of The Claflin Company Savings & Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

## *Notes to Financial Statements*

### **Note 1 - Description of Plan**

The following description of The Claflin Company Savings & Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions. In the event that there is a conflict between information provided in this document and the Plan agreement, the terms in the Plan agreement will prevail.

#### **General**

The Plan is a defined contribution profit sharing plan with a cash deferral 401(k) arrangement and includes all employees of The Claflin Company, Almon Company, Hospital Associates and Claflin Service Company (through April 1, 2024) (collectively the “Employer”). Employees who have completed 30 days of service and have attained age twenty-one are eligible to participate in the Plan (“Participants”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). All investments, other than any balances in forfeiture accounts, are participant directed.

#### **Plan Transfer**

The Employer sold its interest in the Claflin Service Company division, and on April 1, 2024, \$26,766,978 was transferred out of the Plan into the CME Corp 401(k) Plan related to the Claflin Service Company employee balances.

#### **Participant Contributions**

Participants may contribute up to 100% of eligible pre-tax annual compensation to the Plan, subject to dollar limits set by Federal law. Participants who have reached the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (“Participant Rollovers”).

#### **Employer Contributions**

##### **Matching Contributions**

The Employer’s matching contributions are made at the discretion of the Employer, subject to certain limitations. For the year ended December 31, 2024, the Employer elected not to make matching contributions. During the year ended December 31, 2024, the Employer made matching contributions in the amount of \$10,938 related to 2023 employee contributions that were withheld in 2024.

##### **Profit Sharing Contributions**

At its discretion, the Employer may contribute a profit sharing contribution each plan year. In order to participate in an Employer profit sharing contribution, a participant must be employed on the last day of the plan year and must have completed 30 days of service during the plan year. Allocations are based on the ratio of a participant’s compensation to total compensation of all eligible Participants. There was no profit sharing contribution for the year ended December 31, 2024.

### **Note 1 - Description of Plan (Continued)**

#### ***Participant Accounts***

Each participant's account is credited with the participant's contributions and allocations of the Employer's contributions and plan investment earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### ***Vesting***

Participants are always fully vested in their deferral and rollover contributions plus actual earnings thereon. Participants start vesting in the Employer contributions portion of their accounts plus actual earnings thereon at the rate of 20% per year starting at the end of the first year of service, as defined, and become fully vested after five years of credited service. Upon death, disability, or attainment of normal retirement age, a participant is fully vested in all of their accounts.

#### ***Forfeitures***

A participant who leaves the employ of the Employer forfeits any non-vested balance upon the earlier of five consecutive one-year breaks in service or the distribution of the entire vested portion of their account. Forfeited amounts shall be first used to pay administrative expenses with amounts in excess of administrative expenses used to reduce future Employer contributions. As of December 31, 2024 and 2023, unallocated forfeited accounts amounted to \$22,408 and \$17,243, respectively. During the year ended December 31, 2024, \$17,300 were used to reduce administrative expenses.

#### ***Payment of Benefits***

Upon termination of service due to death, disability, or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Also upon termination, if a participant's vested account is less than \$1,000, and the participant does not elect to receive the distribution, the Plan administrator may distribute the participant's vested account balance directly to the participant without consent. If the participant's balance is greater than \$1,000 but less than \$7,000, the Plan administrator is allowed to rollover the remaining balance to an IRA. In-service withdrawals are allowed from a participant's account upon attainment of age 59½. Hardship withdrawals may be taken from a participant's elective deferral account.

#### ***Notes Receivable from Participants***

Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years (or longer for the purchase of a primary residence). A participant may have two loans outstanding at a time. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are paid ratably through payroll deductions.

### **Note 1 - Description of Plan (Continued)**

#### ***Plan Administration***

The Employer is the Plan administrator and has the authority to appoint person(s) or entities to carry out the operation of the Plan. Fidelity Management Trust Company (“Fidelity”) is the Plan’s trustee and custodian.

### **Note 2 - Summary of Significant Accounting Policies**

#### ***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

#### ***Investments, Investment Valuation and Income Recognition***

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold, as well as held during the year. See Note 4 for discussions of fair value measurements.

#### ***Contributions***

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

#### ***Notes Receivable from Participants***

Notes receivable from Participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

#### ***Benefits Paid***

Benefits are recorded when paid.

#### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

#### ***Administrative Expenses***

Individual participant accounts are charged directly for loan recordkeeping and benefit disbursement processing fees, if applicable. All other operating expenses incurred in the administration of the Plan are paid by the Employer.

#### ***Subsequent Events***

The Plan has evaluated subsequent events through September 9, 2025, the date the financial statements were available to be issued. No significant matters were identified for disclosure during the evaluation.

### **Note 3 - Information Certified by Trustee/Custodian**

Plan investments are held by Fidelity. Fidelity has certified to the fair value of investments as of December 31, 2024 and 2023 and investment transactions for the year ended December 31, 2024. Investment transactions include interest and dividend income and net appreciation in fair value of investments. Information included in the supplemental Schedule H, Line 4i - Schedule of Assets (Held at End of Year) and notes receivable from participants have also been derived from information certified by Fidelity. The Plan offers investment choices to allow Participants to create a diversified portfolio of assets based on a participant's risk tolerance. Participants in the Plan may direct contributions to a variety of investment options.

### **Note 4 - Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). Valuation techniques maximize the use of observable inputs to minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described below:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs that are unobservable inputs for the asset or liability.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

#### **Mutual Funds**

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

#### **Units in Collective Investment Trust Funds**

Valued at the NAV of units of collective trusts. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the funds less their liabilities. This practical expedient is not used when it is determined to be probable that the funds will sell the investment for an amount different than the reported NAV. The investment’s objective is the stability of principal and high current income. To achieve its investment objective, the collective investment trusts invest in high-quality guaranteed investment contracts and synthetic investment contracts which underlying assets consist of security-backed investment contracts, synthetic separate account guaranteed investment contracts (includes fixed income investments) and short-term investments. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trusts, the investment adviser reserves the right to temporarily delay withdrawal from the trusts in order to ensure that securities liquidations will be carried out in an orderly business manner.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

### Note 6 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events such as an international conflict, which could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect Participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

### Note 7 - Related-Party and Party-In-Interest Transactions

Plan investments are held by Fidelity. Fidelity is the trustee and custodian as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. During the year ended December 31, 2024, the Plan received \$49,161 of revenue sharing credit income which was used to pay plan expenses. Fees paid to Fidelity and other service providers which were not covered by revenue sharing credits amounted to \$64,305 for the year ended December 31, 2024. Notes receivable from Participants also qualify as party-in-interest transactions.

### ***Note 8 - Plan Termination***

Although it has not expressed any intent to do so, the Employer has the right, under the Plan, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, Participants would become fully vested in all of their accounts. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Employer may determine.

### ***Note 9 - Excess Contributions Refundable***

At December 31, 2024 and 2023, the Plan had liabilities of \$13,749 and \$22,783, respectively, which represented the return of excess contributions required to satisfy the relevant nondiscrimination provisions of the Plan. The excess contributions were returned to participants by the following March of each year.

### ***Note 10 - Tax Status***

The Plan document is a Fidelity prototype using a standardized adoption agreement that received a favorable opinion letter on June 30, 2020. The plan administrator has adopted the prototype plan and believes that the Plan is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
