Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of The Carroll School Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from qualified institutions as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

Responsibilities of Management for the Financial Statements

1 – DESCRIPTION OF THE PLAN

General

The Carroll School Retirement Plan (the "Plan") is a defined contribution plan that was established on May 1, 1984 for the benefit of employees of The Carroll School (the "School") and was restated January 1, 2018. The Plan is funded by contributions from its participants and the School and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The following description of the Plan provides general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

Administration of the Plan

The Plan is administered by The Carroll School.

Eligibility for Participation

Employees, except students and those who normally work less than 20 hours per week, are eligible to make voluntary deferral contributions upon date of hire and are eligible to receive employer matching and nonelective contributions after one year of service in which they worked at least 700 hours.

Employee Elective Deferred Contributions

Employees participating in the Plan may elect to defer a percentage of their annual earnings as contributions, subject to the limitations outlined in the Internal Revenue Code. Employee contributions in the form of rollovers and transfers from other qualified retirement plans are allowed as defined in the Plan document.

Employer Matching and Nonelective Contributions

The School may make discretionary matching and nonelective contributions to the Plan. During the year ended December 31, 2024, the School made matching contributions equal to 100% of each participant's elective deferral up to 6% of compensation with a minimum of 2% of compensation for employees who contribute at least \$10 per pay period. During the year ended December 31, 2023, the School made matching contributions equal to 100% of each participant's elective deferral up to 5% of compensation through June 30, 2023 and up to 6% of compensation effective July 1, 2023 with a minimum of 2% of compensation for employees who contribute at least \$10 per pay period. There were no nonelective contributions for the years ended December 31, 2024 and 2023.

Vesting

Participants are immediately vested in their elective deferral contributions as well as all employer contributions, plus actual earnings thereon.

Participant Accounts

Accounts are maintained for each participant. Accounts are increased for contributions, transfers and for an allocation of investment income based on the relationship of each participant's account within each investment fund to the total fund. Accounts are decreased for withdrawals made by participants, administrative expenses, and for an allocation of investment losses based upon the relationship of each participant's account within each investment fund to the total fund.

Investment Options

Contributions to the Plan are invested in accordance with investment elections specified by each participant. Upon enrollment in the Plan, a participant may direct employee and employer contributions in whole number percentages into a variety of mutual funds offered by Reliance Trust Company (“Reliance”). Participants are no longer allowed to contribute to Teachers Insurance and Annuity Association of America (“TIAA”), College Retirement Equities Fund (“CREF”), Fidelity Management Trust Company (“Fidelity”) and DWS Trust Company (“DWS”). Reliance, TIAA, CREF, Fidelity and DWS are the custodians of the Plan.

Notes Receivable from Participants

A participant may borrow from their account a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. A participant may not have more than one loan outstanding at any given time, unless one is a primary residence loan with a term of more than five years. Participant loans are secured by the balance in the participant's account and bear interest at a commercially reasonable rate established by the Plan Administrator or under the terms of the applicable funding vehicle. Payments of principal and interest on notes receivable are either paid by the participant directly to the custodian or through payroll deductions.

In-service Withdrawals

In-service withdrawals may only be made under the following circumstances:

- Hardship as defined in the Internal Revenue Code and the Plan document
- Attainment of age 59 ½

Retirement Benefits

The normal retirement age under the Plan is age 65. Certain participants may be eligible for early retirement subject to the provisions in the Plan document. A participant who becomes disabled as defined in the Plan document is eligible for disability retirement.

Payment of Benefits

On termination of service from the School, a participant may elect to receive the vested portion of their account in the form of a single lump sum or any other form of settlement available from the manager of the investment fund(s) in which the participant's account or portion thereof is invested. Upon termination of service from the School, a participant with an accumulated balance of \$1,000 or less will receive a distribution of the vested balance at the direction of the School. This distribution will occur approximately 60 days following severance of employment.

Timing of Distributions

Distributions described above shall be made as soon as reasonably practicable following the date the participant's application for distribution is received by the custodian.

As of December 31, 2024 and 2023, there were no distributions payable to participants.

Administrative Expenses

The majority of administrative expenses incurred by the Plan are paid by the School. However, certain administrative expenses may be paid by the Plan.

1 – DESCRIPTION OF THE PLAN (continued)

Participant-Directed Contributions, Withdrawals and Transfers

The manner of electing to allocate contributions between funds and any decision to change such allocation is made by the participant as permitted by the custodians. Withdrawals and transfers are recorded at the time such transactions take place.

2 – SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared utilizing the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires the Plan Administrator to make significant estimates and assumptions that affect the reported amounts in the financial statements and, when applicable, disclosures of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Cash

For the purposes of the financial statements, cash is defined as cash accounts that have not been allocated to investment accounts.

Investments

Net investment income (loss) consists of interest and dividend income, realized gains and losses, and unrealized appreciation (depreciation) on investments.

Other than as described in Note 5, investments are reported at fair value as described in Note 4. Security transactions are accounted for as of the date the securities are purchased or sold (trade date). Interest income is recorded as earned and, for money market instruments, includes amortization of discount and premium. Dividend income is recorded on the ex-dividend date or, for certain foreign securities, as soon as the investment funds are informed of the ex-dividend date. Realized and unrealized gains and losses on security transactions are accounted for on the average cost basis and include the Plan's gains (losses) on investments bought and sold as well as held during the year.

Each participant's assets are jointly invested and the return on assets is allocated monthly among the participants and recorded as income or loss. The basis of allocation is the unit of participation method. Under this method, contributions and income increase units of participation while benefits paid and losses decrease units of participation.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable will be deemed distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of Benefits

Benefits are recorded when processed and approved for payment.

2 – SUMMARY OF ACCOUNTING POLICIES (continued)

Risks and Uncertainties

The Plan provides for various investment options in any combination of stocks, bonds, fixed income securities, mutual funds, real estate and other investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the accompanying Statements of Net Assets Available for Benefits.

Subsequent Events

The Plan Administrator evaluated events that occurred after December 31, 2024, the date of the Statement of Net Assets Available for Benefits, but before the date the financial statements were available to be issued, September 4, 2025, for potential recognition or disclosure in the financial statements. The Plan Administrator did not identify any subsequent events that had a material effect on the accompanying financial statements.

3 – INFORMATION CERTIFIED BY CUSTODIANS

Unaudited information included in the Plan's financial statements and supplemental Schedule of Assets (Held at End of Year) was prepared by the Plan's custodians and furnished to the Plan Administrator and includes all Plan assets (except for the effects of participant and employer contributions receivable, if any) and all investment transactions. The Plan Administrator has obtained certifications from the custodians that such information is complete and accurate.

4 – FAIR VALUE MEASUREMENTS

The Plan applies the provisions of GAAP, which establish a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements), a lower priority to significant other observable inputs (Level 2 measurements), and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under these provisions are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Mutual Funds:

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

4 – FAIR VALUE MEASUREMENTS (continued)

CREF Variable Annuity Accounts:

These accounts invest principally in equity securities, fixed-income instruments, and short-term instruments in accordance with each portfolio's investment objectives. Account investments are primarily valued using market quotations or prices obtained from independent pricing sources that may employ various pricing methods to value the investments including matrix pricing. CREF Money Market Account holdings are generally valued at amortized cost. Each account determines its unit value on a daily basis, which are published by National Association of Securities Dealers Automated Quotations ("NASDAQ").

TIAA Pooled Separate Account:

The TIAA Pooled Separate Account invests in the TIAA Real Estate Account ("REA"), which consists of real estate properties and real estate-related investments. The REA's value is principally derived from the market value of the underlying real estate holdings or other real estate-related investments. Real estate holdings are valued principally using external appraisals, which are estimates of property values based on a professional's opinion. The REA sometimes holds securities as well. These are generally priced using values obtained from independent pricing sources. Unit values are calculated on a daily basis and are published by NASDAQ.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

TIAA Insurance Investment Account:

The TIAA Insurance Investment Account consists of the non benefit responsive TIAA Traditional Annuity Account and is reported at contract value. The contract value equals the accumulated cash contributions and interest credited to the Plan's contracts, less any withdrawals and transfers, if any. The TIAA Traditional Annuity is not available for sale or transfer on any securities exchange. Accordingly, transactions in similar investment instruments are not observable; however contract value provides a reasonable approximation of fair value.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5 – FULLY BENEFIT RESPONSIVE INVESTMENT CONTRACT

The Plan invests in a stable asset fund, which is considered to be fully benefit responsive. The stable asset fund is valued at contract value, which is based on its beginning balance plus any deposits and credited interest, less any withdrawals, charges or expenses, and which approximates fair value.

Contract value represents the amount participants would receive if they were to initiate a transaction under the terms of the ongoing plan. Interest is credited daily at an interest rate not less than the guaranteed minimum interest rate shown on the contract specifications. The interest crediting rate is declared on a quarterly basis. The contract is guaranteed against loss of principal, minus all withdrawals, including charges and adjustments. The guarantee is based on Standard Insurance Company's ability to meet its financial obligations from general assets.

The following events are not probable of occurring but could limit the ability of the Plan to transact at contract value with the stable asset fund and would also limit the ability of the Plan to transact at contract value with the participants.

- Premature terminations of the contract by the Plan
- Spin-offs
- Divestitures
- Layoffs
- Corporate relocation
- Plan terminations
- Early retirement incentives
- Liberalization of plan withdrawal or transfer rules

The fully benefit responsive investment contract described above is reported at contract value in the Statements of Net Assets Available for Benefits.

6 – INVESTMENT CONTRACT WITH INSURANCE COMPANY

The TIAA Traditional Annuity Account is a fixed annuity contract that is fully and unconditionally guaranteed by TIAA. During the accumulation phase, the TIAA Traditional Annuity Account provides a guarantee of principal, a guaranteed minimum rate of interest between 1% and 3%, and the potential for additional interest if declared by TIAA.

Additional interest, when declared remains in effect for the "declaration year", which begins each March 1. Additional interest is not guaranteed for future years. When the accumulation in TIAA Traditional Annuity Account is converted to an annuity based on life expectancy, the present value of the stream of payments is equal to the accumulation. The crediting rate is supported by the investment performance of a large, diversified portfolio, is correlated with the highest quality debt security yields, and is adjusted for contract liquidity.

8 – PLAN TERMINATION

Although it has not expressed intent to do so, the School has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a termination of the Plan, all affected participants will remain fully vested in their accounts.

9 – INCOME TAX STATUS

The School has adopted the Angell Pension Group, Inc. (“Angell”) Basic Plan Document #007 for its Plan document. Angell received an advisory letter from the Internal Revenue Service indicating its Basic Plan Document #007 is acceptable under Internal Revenue Code section 403(b). The Plan has been amended since receiving the advisory letter. However, the Plan administrator and the Plan’s tax counsel believe that the Plan is designed and currently being operated in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believe that the Plan is qualified.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

10 – PARTY-IN-INTEREST TRANSACTIONS

Plan investments consist of shares of various accounts managed by Reliance, TIAA, CREF, Fidelity and DWS who are the custodians of the Plan’s assets and, therefore, these transactions qualify as party-in-interest.
