INDEPENDENT AUDITORS' REPORT

To the Plan Administrator and Participants
Alliance Precision Plastics Corp. 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Alliance Precision Plastics Corp. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for plan benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for plan benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Alliance Precision Plastics Corp. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from qualified institutions as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management has determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

The following brief description of the Alliance Precision Plastics Corp. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a salary reduction plan pursuant to Section 401(k) of the Internal Revenue Code, established on April 1, 1992. It covers substantially all employees of Alliance Precision Plastics Corp. (the Company) who meet certain age and length of service requirements. The Plan is also subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Participation

Eligible employees may become participants commencing on the first day of the next calendar quarter following the attainment of both the age of 21 and completion of three months of service with the Company.

Contributions

The Company shall make deferral contributions (elective deferrals) on behalf of each participant who has an executed salary reduction agreement in effect with the Company. The maximum contribution each participant may make each year is subject to federal limits.

The Plan has an automatic enrollment policy. Under this policy, employees who meet eligibility requirements are automatically enrolled to defer 4% into the Plan unless they have an executed opt-out agreement with the Company. Eligible participants may also elect to defer a portion of their total annual compensation into the Plan as elective after-tax Roth contributions. During 2024 and 2023, the qualified pre-tax contributions totaled \$624,484 and \$643,831, respectively. During 2024 and 2023, the elective after-tax Roth contributions totaled \$84,044 and \$68,596, respectively.

Each year, the Company may make discretionary matching contributions on behalf of each participant equal to a discretionary percentage of participant deferrals to be determined by the Company each year. In both 2024 and 2023, discretionary matching contributions were equal to 25% of the first 4% of employee deferrals, calculated on a weekly basis. Matching contributions, net of forfeitures used towards employer match, amounted to \$100,119 and \$107,043 for the years ended December 31, 2024 and 2023, respectively.

The Company may also contribute an amount which it designates as a qualified contribution (qualified non-elective contribution). This contribution may be included in the actual deferral percentage test or the actual contribution percentage test. Qualified discretionary contributions shall be allocated only to non-highly compensated employees in proportion to his or her compensation as a percentage of compensation of all eligible for the plan year. Qualified non-elective contributions may also be made by the Company to participant accounts to correct any missed contributions. During 2024 and 2023, the Company did not make qualified discretionary contributions.

Contributions (Continued)

The Company may also decide each plan year to make a discretionary profit-sharing contribution on behalf of the eligible participants. Such contributions shall be allocated to eligible participants in the ratio that each participant's compensation bears to the total compensation paid to all eligible participants for the plan year. In order for a participant to qualify to receive a discretionary profit-sharing contribution, the participant must be credited with more than 1,000 hours of service during the plan year and be employed on the last day of the plan year. In both 2024 and 2023, the Company did not make a discretionary profit sharing contribution.

Participants may also transfer (or rollover) funds from other qualified plans, with the consent of the Plan administrator.

Participant accounts

Each participant shall have an account which will be credited with the participant's contributions, Company contributions, Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant compensation or account balances.

Vesting

Participants are immediately 100% vested in their elective deferrals and rollover contributions plus actual earnings thereon. Vesting in matching contributions and employer discretionary contributions is based on years of continuous service. A year of service is defined as a minimum of 1,000 hours worked during a plan year.

A vested percentage for discretionary matching contributions is determined in accordance with the following vesting schedule:

Additionally, accounts become fully vested upon attainment of age 62 while employed, death or total and permanent disability.

Payment of benefits

Upon retirement, death or disability, the entire account balance, if less than \$5,000, will be distributed in the form of a lump-sum payment. In addition, lump-sum distributions may be made, with participant consent, under the following conditions: the account balance is greater than \$5,000, separation from service or upon the hardship of a participant as provided for in the Plan and in government regulations.

Notes receivable from participants

The Plan allows participants to borrow funds from their accounts. Loans may not exceed the lesser of 50% of the employee's vested account balance or \$50,000. No loan in an amount less than \$1,000 will be permitted. Repayments of principal and interest are made through payroll withholding. At any time, no more than two loans may be outstanding from the Plan to the participant. Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest.

Basis of accounting

The accompanying financial statements have been prepared on the accrual basis and present the net assets available for plan benefits and changes in those net assets.

Revenue recognition

Purchases and sales of securities are recorded on the trade date basis. Interest and dividends are recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Notes receivable from participants

Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest.

Administrative expenses

Administrative expenses are recorded in the year incurred.

Payment of benefits

Benefits are recorded when paid.

Fair value measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Fair value measurements (Continued)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts: Valued at quoted market prices which represent the net asset value of units held by the Plan at the end of the year.

Investment contracts: Valued at contract value, which approximates fair value, as reported to the Plan by The Voya Retirement Insurance and Annuity Company. Contract value represents contributions made under the contract, plus earnings, less plan withdrawals and administrative expenses.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. The fair value of these investments is subject to market volatility and may be susceptible to fluctuations.

Income taxes

The Plan evaluates income tax positions for uncertainty to determine any tax positions that may not be fully sustained upon examination by taxing authorities, despite the belief that the underlying tax positions are fully supportable. Tax positions are reviewed on an ongoing basis and are analyzed in light of changing facts and circumstances, including progress of tax audits, developments in case law, and closing of statute of limitations. The Plan administrator has determined that the Plan has no uncertain tax positions. The Plan is no longer subject to examinations by the applicable taxing jurisdictions for periods prior to December 31, 2021.

Plan management's review of subsequent events

The Plan administrator evaluated events occurring between the end of the most recent plan year and September 4, 2025, the date the financial statements were available to be issued.

3. Financial Information Certified by the Custodian

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the ERISA. Accordingly, Voya Retirement Insurance and Annuity Company, the custodian of the Plan, has certified to the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for plan benefits, the schedule of assets held for investment purposes and the related investment activity reflected in the statements of changes in net assets available for plan benefits.

5. Related Party Transactions

The Plan invests in pooled separate accounts and investment contracts managed by affiliates of The Voya Retirement Insurance and Annuity Company. The Voya Retirement Insurance and annuity Company acts as a custodian for only those investments defined by the Plan. Transactions in such investments qualify as party-in-interest transactions which are exempt from prohibited transaction rules. Administrative fees paid to The Voya Retirement Insurance and Annuity Company amounted to \$49,172 and \$47,616 for the years ended December 31, 2024 and 2023, respectively.

6. Tax Status

The Plan obtained its latest determination letter in June, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe that the Plan is qualified and is tax-exempt as of the financial statement date.

7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.
