In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Supplemental Schedule Required by ERISA

The supplemental schedule of Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion—

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

(1) Description of Plan

The following description of the Champlain College Defined Contribution Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions.

(a) General

The Plan is a tax-exempt, defined contribution retirement plan sponsored by Champlain College (the “College”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The purpose of the Plan is to provide eligible employees a measure of financial security upon their retirement.

(b) Eligibility

Full-time and part-time employees are eligible to make salary deferral contributions immediately. Full-time employees are eligible to receive the College match on the first day of the month following their hire date. Part-time staff are only eligible to receive the College match if they are scheduled 20 hours per week in a plan year and adjunct faculty are excluded for the College match. Full-time student employees are excluded from contributing to the Plan. The College provides supplemental employer contribution to employees who had five or more years of service and were at least 35 years of age as of July 30, 2006. Employees can decline to participate in the Plan at any time.

(c) Contributions

Contributions to the Plan are made by the participants in the form of salary reduction up to the maximum dollar limit which is set by law on an annual basis, plus any “catch-up contributions.” In addition to the limits set each year, if the employee is projected to attain age 50 before the end of the calendar year or they qualify for the 15-years of service catch-up, they may elect to defer additional amounts, called “catch-up contributions”. Employees may contribute on a pre-tax or after-tax basis.

The College matched employee contributions two to one up to 5% per pay period, through June 29, 2024. Effective June 30, 2024, implemented a one-to-one retirement match up to 3% per pay period. This contribution is made at the discretion of the College. Additionally, the College provides a supplemental contribution to eligible participants. This contribution is discretionary and intends to replace benefits which would have been accrued had the defined benefit plan not been terminated in 2006. The College made total contributions to the Plan of \$1,947,460 and \$2,868,862 for the years ended December 31, 2024 and 2023, respectively.

(d) Participant Accounts

Each participant’s account is credited with the participant’s contributions, the College’s matching contribution, supplemental contributions, if applicable, and allocations of investment earnings. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested

account. Participants direct the investment of their account balances into various investment funds or annuities offered by the Plan.

(e) Vesting

Participants are immediately vested in all contributions and earnings thereon.

(f) Loans

Participant Loans

Participants may borrow from only their pre-tax and Roth salary deferral accounts and rollover accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The maximum loan amount available will be determined by taking into account the participant's entire vested interest in the Plan including employer contributions. Only two outstanding loans are allowed at a time and no loan will be issued if the participant has previously defaulted on a loan. Loans are treated as a transfer from the investment fund to participant loans. Loans must be repaid over a period not to exceed five years unless the loan proceeds are used for the purchase of a primary residence, in which case a longer repayment period is allowed. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with prevailing rates as determined by the vendor. Principal and interest are paid through payroll deductions or ACH directly to TIAA after termination. Participant loans are valued at amortized cost.

Plan Loans

Plan loans are issued as separate contracts by TIAA-CREF as contemplated under IRC Section 72(p)(5) and do not represent plan assets. Loans are collateralized using a participant's TIAA Traditional account balance in an amount equal to 110% of the outstanding loan balance. Participants could borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 45% of their TIAA Traditional account balance subject to annuity contract and plan provisions. Loan terms range from one to five years in one year increments (up to 30 years for the purchase of the participant's primary residence). Principal and interest is paid ratably by the participant to TIAA and each payment will reduce amounts collateralized by the borrowing participant's TIAA Traditional account balance. Plan loan balances outstanding from participants to TIAA were \$149 and \$141 as of December 31, 2024 and 2023, respectively. Beginning October 1, 2014, the Plan only allows for participant loans which are discussed above.

(g) Distributions

On termination of service due to death, disability, retirement, or separation of service, a participant may elect to receive an amount equal to the value of the participant's vested interest in their account in either a single lump-sum amount, monthly, quarterly, or in annual installments over a period of not more than the participant's assumed life expectancy or an annuity option. For termination of service due to other reasons, a participant will receive the value of the vested interest in their account as a lump-sum distribution.

In-service distributions are allowed after age 59 ½.

If a participant terminates employment for any reason and at any age, and the value of their vested benefit does not exceed \$5,000, including any rollover contributions, then a distribution will be automatically paid to the participant even if they do not consent. Any distribution under this paragraph of \$1,000 or less will be paid to the participant in a taxable-lump sum distribution within a year after they terminate employment, unless they elect a direct rollover. If the distribution is greater than \$1,000 but does not exceed \$5,000, the distribution will automatically be rolled over to an IRA on their behalf, unless they elect otherwise.

(h) Plan Termination

Although it has not expressed any intent to do so, the College has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

(i) TIAA Traditional Annuity

TIAA Traditional Annuity (TIAA Traditional) is an unallocated fixed annuity contract that is fully and unconditionally guaranteed by TIAA. TIAA Traditional provides a guarantee of principal, a guaranteed minimum rate of interest, generally 3%, and the potential for additional interest if declared by TIAA. Additional interest, when declared, remains in effect for the “declaration year,” which begins each March 1. Additional interest is not guaranteed for future years. Contributions to a participant’s account purchases a guaranteed amount of lifetime annuity income. When a participant’s account in the TIAA Traditional is annuitized based on available options, the present value of the stream of payments is equal to the account balance. The subsequent stream of annuity payments occurs outside of the plan and does not represent an obligation of the plan.

TIAA Traditional Annuity holdings within liquid contracts (SRA, GSRA, and RCP) are considered fully benefit-responsive and contract value approximates fair value at December 31, 2022 and 2021, respectively. TIAA Traditional Annuity holdings within illiquid contracts (RA, GRA, and RC) are non-benefit responsive. See Notes 4 and 5 for further discussion of the TIAA Traditional Annuity.

(2) Summary of Significant Accounting Policies

(a) Basis of Accounting

The accompanying financial statements are prepared using the accrual basis of accounting.

Investment contracts held by a defined contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan.

(b) Use of Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the Plan Administrator to make estimates and assumptions that affect the reported

amounts of net assets available for benefits and changes therein during the reporting period. Actual results could differ from those estimates.

(c) *Investment Valuation and Income Recognition*

The Plan's investments are reported at fair value, except for fully-benefit responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

(d) *Payment of Benefits*

Benefits are recorded when paid.

(e) *Administrative Expenses*

Expenses of administering the Plan including investment advisory fees, consultant fees, recordkeeping fees, audit and legal fees are covered by the plan. Participants may incur specific fees, such as investment fees, dependent upon their investment elections selected and fees for personalized services such as loans and withdrawals.

(3) Information Certified by the Plan's Custodians/Trustees

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosures under ERISA. Accordingly, American General Life Insurance Company (Sun America), Nationwide Life Insurance Company, TIAA-CREF, and TIAA, FSB, the custodians/trustees of the Plan have certified as being complete and accurate the investments on the statements of net assets available for benefits as of and for the years ended December 31, 2024 and 2023, the investment activity reflected in the statements of changes in net assets available for benefits, and the investment information included in the supplemental schedule of assets held as of December 31, 2024. Accordingly, as permitted under such election, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information certified as complete and accurate by the Plan's custodians/trustees for their respective periods.

(4) Fair Value Measurements

Accounting principles generally accepted in the United States of America establishes a framework for measuring fair value and a hierarchy that prioritizes inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or

liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Investment options available to participants include the TIAA Traditional Annuity, TIAA Real Estate, CREF funds, Sun America annuities, Nationwide annuities, select mutual funds, and money markets.

The following is a description of the valuation methodologies used for assets measured at fair value.

Insurance Contracts (Non-fully Benefit Responsive Portion)

TIAA Traditional Annuity is a guaranteed fixed-rate annuity backed by TIAA's claims paying ability whereby the annuity guarantees principal and a minimum interest rate. TIAA Traditional Annuity holdings within illiquid contracts (RA, GRA, and RC) are non-benefit responsive. The non-fully benefit responsive portion of the TIAA Traditional Annuity provides an opportunity for additional amounts in excess of the guaranteed rate and is reported at fair value, classified within level 3 of the valuation hierarchy. See discussion at Note 1 for further details.

Sun America and Nationwide annuities are valued in a similar manner as the CREF funds described below.

Mutual Funds

TIAA offers several CREF funds. Unlike TIAA Traditional, these accounts do not provide guaranteed returns. Participant returns depend entirely on the investment performance of each account. The accounts invest principally in equity securities, fixed income instruments and short-term investments in accordance

with each portfolio's investment objectives. Account investments are primarily valued using market quotations or prices obtained from independent pricing sources, except those held by the TIAA-CREF Money Market Fund, whose holdings are valued at amortized cost. Transfers out of CREF funds or mutual funds into another investment option may be executed on a daily basis.

Pooled Separate Accounts

In addition, TIAA offers the Real Estate Account which is an insurance company separate account of TIAA investing in real estate and real estate-related investments. The account's value is principally derived from the market value of the underlying real estate holdings or other real estate-related investments (Level 1). Real estate holdings are valued principally utilizing external appraisals, which are estimates of property values based on a professional's opinion. The TIAA Real Estate Account sometimes holds securities as well. These are generally priced using values obtained from independent pricing sources. Unit values are calculated daily. Transfers out of the TIAA Real Estate Account to a TIAA or CREF account or into another investment option can be executed at any time but are limited to once per calendar quarter.

(5) Investment Contract with Insurance Company

As described in Note 1, because a portion of the guaranteed investment contracts with TIAA is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to this guaranteed investment contract. The fully benefit-responsive portion of the investment contracts is included in the financial statements at contract value, as reported to the Plan by TIAA. Contract value represents contributions made under the contracts, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate, generally 3%, that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the issuer, but may not be less than 3%. The TIAA Board of Trustees may declare additional amounts on a year-by-year basis. These additional amounts, when declared, remain in effect for the 12-month declaration year that begins each March 1; they are not guaranteed for future years. The interest rate credited to participants for the fully benefit-responsive portion of the investment contracts for the Plan was 3% for the year ending December 31, 2024.

Certain events limit the Plan's ability to transact at contract value with TIAA. Examples of such events include the following: (a) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the College or other College events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants are probable of occurring.

The guaranteed investment contract does not permit the TIAA to terminate the agreement prior to the scheduled maturity date.

(6) Related-Party Transactions and Party-In-Interest Transactions

The Plan's records are maintained by three recordkeepers including Sun America, Nationwide, and TIAA-CREF. The recordkeepers are considered related parties to the Plan.

TIAA, FSB, is the custodian of non-annuity assets, including mutual funds, traded and held in retirement plans recordkept by TIAA. These transactions qualify as party-in-interest transactions.

Deloitte, completes the non-discrimination testing and prepares the Form 5500 for the Plan. These transactions qualify as party-in-interest transactions.

(7) Income Tax Status

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code (Code). The terms of the Plan have been prepared to conform with the sample language provided by the Internal Revenue Service (IRS) in Revenue Procedures 2007-71. The Plan is required to operate in conformity with the Code to maintain the tax-exempt status for plan participants under Section 403(b).

Accounting principles generally accepted in the United States of America requires management to evaluate tax positions taken by the Plan and recognize a tax liability (or de-recognize an asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or de-recognition of an asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

(8) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

(9) Subsequent Events

For purposes of determining the effects of subsequent events on these financial statements, management has evaluated events subsequent to December 31, 2024 and through August 7, 2025 the date on which the financial statements were available to be issued.
