We have performed audits of the financial statements of the WellHaven Pet Health 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). Note 1 – Description of Plan

The following description of WellHaven Pet Health 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan established by WellHaven Pet Health, LLC (the “Plan Sponsor” or the “Company”) under the provisions of Section 401(a) of the United States Internal Revenue Code (the “IRC”), which includes a qualified cash or deferred arrangement as described in Section 401(k) of the IRC, for the benefit of eligible employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as well as certain provisions of the federal income tax laws.

All employees of the Company are subject to the following eligibility requirements:

- Age: 21
- Service: One month
- Status exclusions:
 - a. Leased employees
 - b. Non-resident aliens with no U.S. earned income
 - c. Independent contractors
 - d. Members of collective bargaining agreement

Upon satisfying the eligibility requirements, employees may participate in the Plan on the first day of the next month.

The Plan’s retirement committee is responsible for the oversight of the Plan, determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

Plan amendments

The Securing a Strong Retirement Act (“SECURE 2.0”) was signed into law on December 29, 2022, and includes mandatory and optional provisions with varying effective dates in 2023 and later. Written amendments to the Plan related to SECURE 2.0, as applicable, will be drafted in accordance with applicable law and regulatory guidance. The following descriptions reflect the mandatory and optional provisions that have been adopted by the Plan through December 31, 2024.

Contributions

The Plan is funded through employee elective deferrals and Company contributions. Each year, participants may elect to contribute a portion of their compensation, subject to certain maximum limitations imposed by Section 402(g) of the IRC. Participants may also contribute amounts representing distributions from other qualified plans, as defined in the Plan agreement. Participants who have reached age 50 before the end of the Plan year are eligible to make catch-up contributions.

Notes to Financial Statements

The following contribution types are allowed by the Plan:

- Employer profit-sharing
- Employer matching
- Roth deferrals
- Elective deferrals
- Rollover contributions

The Company may make discretionary matching or profit-sharing contributions that will be allocated in accordance with the Plan document provisions. For the year ended December 31, 2024, the Company made discretionary matching contributions equal to 25% of the first 6% of participant deferrals.

Participant accounts

Each participant's account is credited with the participant's contributions and the Company's contributions, as well as allocations of Plan earnings or losses, and charged with an allocation of administrative expenses that are paid by the Plan. Allocations may be charged based on participant earnings, account balances, or specific participant transactions, as defined in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately 100% vested in their elective deferrals, including catch-up contributions, rollover contributions from other plans, and actual earnings thereon. The method for crediting vesting service for employer-matching and profit-sharing contributions is based on years of continuous service. A participant is 100% vested after two years of credited service. Participants are credited with a period of service for 1,000 hours earned. Participants are always 100% vested in their Company matching and profit-sharing contributions if they are employed on or after their normal retirement age or if they terminate employment on account of their death or disability.

Forfeited accounts

Forfeitures represent unvested portions of terminated participants' accounts. The Plan allows forfeitures of non-vested Company contributions to be used in the following ways:

- Pay administrative expenses
- Reduce Company contributions

As of December 31, 2024 and 2023, forfeited non-vested accounts totaled approximately \$4,000 and \$0, respectively. During the year ended December 31, 2024, forfeited non-vested accounts of approximately \$7,000 were used.

Investment options

Upon enrollment in the Plan, a participant may direct the contributions made to the Plan, for or on behalf of the participant, to any one or more of the investment funds determined at the discretion of the Plan Administrator and the Plan Sponsor and in such multiples as the participant prescribes. A participant may change his or her investment direction with respect to future contributions or redirect the investment of his or her account balances.

Notes to Financial Statements

Notes receivable from participants

Participants who are active employees may borrow against their vested account balances a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000. The loans, in the form of promissory notes, are secured by the vested balance in the participant's account and bear interest at reasonable rates, which are commensurate with local prevailing rates. Principal and interest are paid ratably through payroll deductions and generally repaid within five years.

Benefits paid to participants

Upon the termination of service, disability, or retirement, a participant is entitled to receive a distribution equal to the value of the participant's vested interest in his or her account as a lump-sum distribution. Distribution of a deceased participant's account will be made to the designated beneficiary.

As required under Section 401(a)(9) of the IRC, a participant must begin receiving required minimum distributions from the Plan by April 1 of the calendar year following the later of (i) the year in which the participant reaches age 73 or (ii) the year in which the participant retires.

The following types of distributions are also allowed by the Plan:

- In-service
- Hardship
- Termination partial withdrawal
- Involuntary cash-outs
- Rollover source withdrawal at any time

Plan expenses

The Plan's expenses are paid by either the Plan or the Company, as provided by the Plan document. Expenses paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment-related expenses are included in net appreciation in fair value of investments.

Termination of the Plan

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of termination, no further contributions will be made to the Plan and all amounts credited to each participant's account will become 100% vested. The Company will direct the distribution of the participant's account in a manner permitted by the Plan as soon as practicable.

Note 2 – Summary of significant accounting policies

Basis of accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make scheduled repayments and the Plan Administrator deems the participant note receivable to be in default, the participant note receivable balance is reduced and a benefit payment is recorded.

Payment of benefits

Benefits are recorded when paid.

Subsequent events

The Plan has evaluated subsequent events through September 5, 2025, which is the date the financial statements were available to be issued. Events, if any, are disclosed within the notes to these financial statements.

Note 4 – Fair value measurements

Fair value measurement guidance establishes an authoritative definition of fair value, sets out a framework for measuring fair value in a hierarchy and requires certain disclosures about fair value measurements. All Plan investments measured at fair value are valued at the net asset value (“NAV”) per share (or its equivalent) as a practical expedient and, therefore, have not been classified in the fair value hierarchy.

The Plan holds group annuity contracts issued by Voya. The contracts allow the Plan to invest in pooled separate accounts, each containing several sub-accounts. Each sub-account is primarily invested in mutual funds but may hold short-term money market instruments, cash or cash equivalents from time to time. The mutual funds have various strategies depending on the fund category that include capital preservation and long-term capital appreciation. The NAV of the sub-accounts is primarily based on the quoted market prices of the underlying mutual funds less daily administration charges. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily, and there are no participant redemption restrictions for these investments; the redemption notice period is applicable only to the Plan. Were the Plan to initiate a full redemption of the account, the investment advisor reserves the right to temporarily delay withdrawal to ensure that the securities liquidation will be carried out in an orderly business manner.

Under the terms of the contract with Voya, the administration charge varies up to a maximum of 2.0% per year depending on the investment option. Sub-accounts may also be charged with direct charges arising from the purchase, maintenance or sale of investments held by the sub-account; any taxes that may be payable by Voya that are attributable to the assets in the sub-account; and any expenses that Voya determines are reasonably necessary or required to preserve or enhance the value of assets of the sub-account.

The valuation methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes that its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 – Fully benefit-responsive investment contracts

The Plan invests in the Voya Fixed Account, which is a fully benefit-responsive guaranteed investment contract (“GIC”). This contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals and administrative expenses.

The traditional investment contract held by the Plan is a GIC. The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established in a contract between the Plan and the contract issuer, which will not fall below 0%. The crediting rate is reviewed quarterly for resetting. The contract cannot be terminated before the scheduled maturity date.

The Plan’s ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer’s ability to meet its financial obligations. The issuer’s ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

1. The Plan’s failure to qualify under Section 401(a) of the IRC or the failure of the trust to be tax-exempt under Section 501(a) of the IRC.
2. Premature termination of the contracts.
3. Plan termination or merger.
4. Changes to the Plan’s prohibition on competing investment options.
5. Bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan’s normal operations.

The Plan Sponsor believes that no events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and also with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

1. An uncured violation of the Plan’s investment guidelines.
2. A breach of material obligation under the contract.
3. A material misrepresentation.
4. A material amendment to the agreements without the consent of the issuer.

The Plan Sponsor is not aware of any such events and, therefore, believes that they are unlikely to occur.

Note 6 – Excess contributions payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (“IRS”) are recorded as a liability, with a corresponding reduction to contributions. The Plan distributed the excess contributions to the applicable participants prior to March 15 of the following year.

Note 7 – Related-party transactions and transactions with parties in interest

A related party is any party who can control or significantly influence Plan management or operating policies. Parties in interest are defined under Department of Labor regulations as any employees of the Plan, fiduciaries of the Plan, service providers to the Plan, the employer whose employees are covered by the Plan, and certain significant owners of the employer and their relatives. Service providers may include, but are not limited to, the custodian, trustee, third-party administrator, investment managers, investment advisors, legal counsel, and Plan auditor.

During the year ended December 31, 2024, the Plan made direct payments of \$4,675 to certain parties in interest for administration and investment advisory fees, as allowed by ERISA. The Plan Sponsor pays directly any other fees related to the operation of the Plan.

Fees incurred by the Plan for the investment management services are included in the net appreciation in fair value of the related investment, as they are paid using investment earnings rather than a direct payment.

Note 8 – Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events that could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

Note 9 – Tax status

The Plan Sponsor adopted a plan that received a favorable determination letter, issued for the individually designed Plan from the IRS dated June 30, 2020, which states that the Plan, as then designed, was designed in accordance with the applicable sections of the IRC. The Plan has been amended and restated since receiving the determination letter, issued for the individually designed Plan. However, the Plan Sponsor believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Plan management evaluates tax positions taken by the Plan and recognizes a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and concluded that there are no uncertain positions taken, or expected to be taken, as of December 31, 2024. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Generally, the statute of limitations for the IRS to assess taxes on a plan expires three years from the due date of the return or the date on which it was filed, whichever is later.
