Notes to Financial Statements

Note 1: Description of Plan

The following description of the HB Performance Systems, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

General

The Plan is a defined-contribution plan sponsored by HB Performance Systems, Inc. (the "Sponsor"). Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company ("Principal") is the Plan trustee and holds the Plan's investment assets and executes investment transactions.

The Plan is intended to satisfy the requirements under Section 404(c) of ERISA, and therefore, provides that participants direct their contributions and/or their account balances among the Plan's investment alternatives. All investments are participant directed.

Eligibility and Participation

Substantially all domestic employees of the Sponsor, except for employees subject to the collective bargaining agreement (unless the collective bargaining agreement specifically indicates they are eligible) are eligible to participate in the Plan. These employees of the Sponsor, age 21 or over, are eligible to participate in the Plan upon the completion of 60 days of service. Participants may enter the Plan on the first day of the month immediately following the attainment of this requirement.

Employees who become eligible are automatically enrolled in the Plan deferring 6% of eligible compensation, unless they affirmatively elect not to participate or elect a different deferral rate. The contribution rate increases annually by 1% up to a maximum of 10%.

Contributions

Each year participants may contribute a portion of their compensation, as defined in the Plan, not to exceed the limits of the Internal Revenue Service ("IRS"). Participants may also contribute distributions from other qualified plans ("rollovers").

The Sponsor may make discretionary matching contributions. The sponsor made discretionary matching contributions equal to 50% of the first 6% of eligible participant compensation during 2024.

Funding

The Sponsor remits participant elective contributions and, when applicable, matching Sponsor contributions to the Plan as soon as practical after amounts are withheld from participants' wages.

Notes to Financial Statements

Note 1: Description of Plan (Continued)

Participant Accounts

Each participant's account is credited with the participant's contributions, Sponsor matching contributions, allocations of Plan net earnings (losses) thereon, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings (losses) or account balances, as defined in the Plan. The balance to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately 100% vested in their contributions, Sponsor matching contributions, plus actual earnings (losses).

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Notes to participants are treated as a separate investment of the participant and all principal and interest payments on note balances are credited to the participant's account from which the note was made. Notes are secured by the balance in the participant's account and bear interest between 5.25% and 10.50% at December 31, 2024. Principal and interest are paid through payroll deductions.

Payment of Benefits

Benefits are paid to the participant or beneficiary upon death, disability, retirement, or termination. Benefit payments are made in the form of a lump-sum, or any other method agreed to by the participant and Plan Administrator, and which is allowable under the Internal Revenue Code ("IRC"). Under certain circumstances, participants may qualify for hardship withdrawals. The Plan also allows for in-service distributions upon attaining age 59 1/2.

SECURE 2.0 Act of 2022

The SECURE Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. Management has evaluated those provisions and determined there is no material impact on the plan. Plan management will determine the optional provision to elect in the future.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The financial statements are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates in Preparation of Financial Statements

The preparation of financial statements in conformity with GAAP requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from these estimates and are subject to change in the near term.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant to be in default, the participant loan balance is reduced and the benefit payment is recorded.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Sponsor and are excluded from these financial statements. Fees related to the administration of distributions and notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events

Subsequent events have been evaluated through September 4, 2025, which is the date the financial statements were available to be issued.

Note 3: Fair Value Measurements

GAAP specifies a three-tier fair value hierarchy, which prioritizes the inputs used in estimating fair value. These tiers include Level 1, defined as observable inputs such as quoted market prices in active markets; Level 2, defined as inputs other than quoted market prices in active markets that are either directly or indirectly observable; and Level 3, defined as unobservable inputs in which little or no market data exists, therefore, requiring an entity to develop its own assumptions.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trust: Fair value is estimated using the NAV per unit by the issuer of the stable value fund. Fair value is based on the fair value of the underlying investments held by the stable value fund. The objective of the stable value fund is to provide preservation of capital, achieve relatively stable returns consistent with its comparatively low risk profile, and provide liquidity for benefit-responsive payments. The fund invests in high quality stable value investment contracts, cash and cash equivalents.

Withdrawals from the stable value fund for benefit payments and participant transfers to noncompeting options to be paid to plan participants shall be made within 30 days after written notification has been received. Withdrawals, other than for benefit payments and participant transfers to noncompeting options, require a one year advance written notice.

Pooled separate accounts: The NAV of each of the pooled separate accounts is calculated in a manner consistent with GAAP for investment companies and is determinative of their fair value and represents the price at which the Plan would be able to initiate a transaction. Several of the pooled separate accounts invest in publicly quoted mutual funds or actively managed stocks. Some of the pooled separate accounts also invest in fixed income securities or real estate. The fair value of the underlying mutual funds or stock and the underlying securities, which is based on quoted prices of similar assets, is used to determine the NAV of the pooled separate account, which is not publicly quoted.

Note 3: Fair Value Measurements (Continued)

Investments in the pooled separate accounts can be purchased and sold continuously. A notice of redemption is not required. The Plan has no obligation to buy additional units.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5: Income Tax Status

The Plan uses the Principal prototype plan document. Principal received an opinion letter from the IRS which states that the prototype document satisfies the applicable provisions of the IRC. The Plan Administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. The Plan Administrator is not aware of any significant uncertain tax positions taken by the Plan.

Note 6: Party-In-Interest Transactions

Certain Plan investments are managed by Principal. These transactions and notes receivable from participants qualify as party-in-interest transactions. These transactions are not considered prohibited transactions under ERISA regulations.

Note 7: Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right to terminate the Plan subject to the provisions of ERISA.

Note 8: Risks and Uncertainties

The Plan's investments are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.
