Opinion

NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. THE PLAN

The following description of the CSEA Child Care Providers Trust Fund (Plan) provides only general information. Participants should refer to the trust fund agreement for a more complete description of the plan's provisions.

General

The Plan is affiliated with the Civil Service Employees Association, Inc., Local 1000, AFSCME (Union), a labor organization that represents individuals in collective bargaining. The Union is the sponsor of the Plan for purposes of the Employee Retirement Income Security Act of 1974, as amended, and the Union has the authority to appoint and remove the members of the Board of Trustees of the Plan.

The Plan is also connected to the State of New York (State) to the extent that the State is responsible to reimburse the Plan for the cost of providing benefits thereunder pursuant to the Memorandum of Agreement between the Union and the State.

Benefits

The Plan is a welfare plan providing various dental, vision, and telemedicine benefits to participants and their eligible dependents who meet the qualifications for benefits eligibility under the Plan and the relevant policies.

To be eligible to participate in the plan, an individual must not be enrolled in Medicaid (exclusively for dental and vision benefits) and must:

- Be actively at work performing the duties of either: a) an operator of a licensed group family day care home as defined in New York Social Services Law section 390(1)(d), b) an operator of a registered family day care home as defined in New York Social Services Law section 390(1)(e), or c) a provider of child care in a residence to one or more children who are receiving child care assistance under Title 5-C of New York Social Services law under circumstances where he or she is not required to be licensed or registered under New York Social Services Law section 390, provided that you are outside New York City; and
- Be a member of the bargaining unit covered under the Agreement between CSEA, Inc. and the State, as it may be amended from time to time.

It is intended that the plan be a "single-employer plan".

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities, changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Cash

Cash includes bank demand deposit accounts. The Plan's cash balances may at times exceed federally insured limits. The Plan has not experienced any losses in these accounts and believes it is not exposed to any significant risk with respect to cash.

Grant Receivable

Grant receivable consists of grant funding due from CSEA, Inc. for costs incurred by the Plan for providing various benefits. The grant receivable has been collected, in full, from CSEA, Inc. as of the date these financial statements were available to be issued.

Revenue Recognition

Grant contributions comprise funds received from New York State through CSEA, Inc. The grant assists with the funding of the Plan's benefits. Grant contributions are recognized over the course of the relevant grant period when amounts have been awarded and all conditions for revenue recognition have been met.

Administrative Expenses

The administrative expenses are paid by the Plan and by CSEA, Inc. Expenses paid by CSEA, Inc. on behalf of the Plan are included in both the contributions and deductions sections of the Statement of Changes in Net Assets Available for Benefits.

3. TAX STATUS

The trust established under the Plan to hold the Plan's assets is qualified pursuant to Section 501(c)(5) of the Internal Revenue Code (IRC). The Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Under certain conditions, the Plan may be terminated. Upon termination, the assets then remaining shall be subject to the applicable provisions of the Plan then in effect and shall be used until exhausted to pay benefits to employees as outlined in the agreement and declaration of trust.

4. FUND TERMINATION

Although it has not expressed any intention to do so, the Sponsor has the right under the Plan to modify the benefits provided and to terminate the Plan subject to the provisions set forth in ERISA and applicable collective bargaining agreements.

5. SUBSEQUENT EVENTS

The Plan has evaluated subsequent events and transactions through August 29, 2025, the date that the financial statements were available to be issued.

As part of obtaining reasonable assurance about whether CSEA Child Care Providers Trust Fund's financial statements are free from material misstatement, we performed tests of its compliance with certain provisions of laws, regulations, contracts, and grant agreements, noncompliance with which could have a direct and material effect on the financial statements. However, providing an opinion on compliance with those provisions was not an objective of our audit, and accordingly, we do not express such an opinion. The results of our tests disclosed no instances of noncompliance or other matters that are required to be reported under *Government Auditing Standards*.

Purpose of This Report

The purpose of this report is solely to describe the scope of our testing of internal control and compliance and the results of that testing, and not to provide an opinion on the effectiveness of the entity's internal control or on compliance. This report is an integral part of an audit performed in accordance with *Government Auditing Standards* in considering the entity's internal control and compliance.
