To Those it May Concern:

During 2022 Organomation Associates (EIN 04-2490343) transferred the plan to a new company called Organomation Manufacturing (88-1721619). That year, a 5500-SF was filed for the plan, under the Manufacturing company (Confirmation # 20230518143522NAL00044845120).

The old company's information was listed on the 5500-SF form and indicated that all assets had been transferred. We thought that listing the old company on the new plan fulfilled the requirements set by the IRS and DOL.

When we received notice that the Associates company still needed to file, we worked quickly to get this resolved. The 2022 form will be submitted through EFAST during the first week of September, it will be marked as the last report for Organomation Associates with 0 assets as of December 31st, 2022.

Filing the 2022 report as a final submission should negate the need for a 2023 return.

Please consider removing the IRS and DOL fees on the 5500-SF for Organomation Associates.
